## Directions for filling out the special assessment refund application

2020-2021 property tax needs to be paid prior to submission of refund application. If refund application is approved, a refund check will be issued.

1. To qualify for the refund, you must be the owner and occupant of the property. Please fill in your last, first and middle name, along with the parcel number and address. The potential amount of the refund will depend on the type of property shown in the table below. Refund applications must be received within one (1) year of the date

of payment.

Information for No-Income Affidavit.

If a household member is age 18 and over and has no income, a No-Income Affidavit must be included. If a household member is age 26 or younger and is listed as a dependent on the individual tax return, a No-Income Affidavit does not need to be included.
