Answer: (Page 22; B. AJCC Career Services Provider, 2. Population to be Served; 1st Paragraph) Other than the Comprehensive Center all sites will be AJCC Career Services Providers.

Question 5: If an organization is pursuing grants in two separate geographical areas, are two proposals required?

Answer: (Page 7) Bidders must identify in their proposal the geographical area(s) of Oakland they intend to serve.

Question 6: Are there preference points for SLBE? What are those? Are there preference points for Oakland resident staff?

Answer: (Page 58) There are no preference points for L/SLBE.

Question 7: Since 1-3 contracts may be awarded for the AJCC Career services providers, would the City of Oakland be interested in funding providers with expertise to reach specific population groups (e.g. immigrants) and for specific workforce sectors (e.g. healthcare)? In other words, is the goal/outcome of the RFP to create a system of providers rather than a single provider if such qualified providers apply.

Answer: We cannot comment on the design of potential responses to the RFP. We encourage applicants to look thoroughly at the guiding documents that are referenced (Pages 11-16).

Question 8: Do the service sites have to be only within the zip codes listed? **Answer:**

Question 9: The language on page 27, facilities and operations is unclear. Can an organization based in 94610 but having a career center in 94607 apply for the AJCC/comprehensive from the 94610 facility?

Answer: (Page 27; 10. Facility and Operations; 1st Paragraph). Each AJCC will maintain at least one physical site in the City of Oakland... For additional clarity, please see the answer to Question 8 above.

Question 10: How much are the preference points for leveraged funds of 50%, 100%, and 200%?

Answer: (Page 58) The Possible Bonus Points are as follows: Documented cash match equivalent to 50% (2 points), 100% (4 points), or 200% (8 points) of the amount requested from OWDB. (Please also reference the answer to Question 6).
