D. Stephanie Montgomery, City of Oakland Human Services Department (HSD), Trauma Informed Systems Training 101

Trauma Informed Systems Training 101 focused on how trauma and stress affects our bodies and minds, communities, organizations and systems. Collective Trauma was addressed within the context of the COVID-19 Pandemic. Throughout the training, S. Montgomery, members of the Board and staff shared their COVID-19 experiences and were given additional opportunities to participate beyond the board training. Board Members and staff were provided a shared vocabulary and awareness of what it means to be a trauma-informed team and how applying common practices can help heal our community.

Equity Summit, Virtual, April 19 – 21, 2021 - National Community Action Partnership (NCAP) is presenting an Equity Summit with the theme of “Centering in Truth, Activating Community Healing & Resiliency.” The roster of equity leaders include: Dr. Georges Benjamin, Dr. Gail Christopher, Mr. Gary Cunningham, Dr. Raquel Hatter, and Dr. Michael McAfee.

NCAP Annual Convention, Boston, MA, August 30 – September 3, 2021 The NCAP Annual Convention is the largest gathering of regional, state, and local Community Action Agencies in the United States, drawing more than 1,500 attendees each year. Travel at this time is tentative since the Convention may become a virtual event, contingent upon the COVID-19 pandemic.

2. 2021 Programming

A. AC-OCAP Update (CSBG 2020, 2021 and 2020-2022 CARES)

The CSBG Annual Report for 2020 was submitted to the Department of Community Services & Development. The 2020 CSBG funding for grantees will be wrapped up by the end of March. An additional \$3000 was allocated to the Grantees for 2020. Staff Program Analysts D. Williams and V. Floyd-Rodriguez are working diligently on grants for 2021 and the 2020-2022 CARES Grant.

B. 2022-2023 Community Needs Assessment/Public Hearings, due June 30, 2021

The 2022-2023 Community Action Plan (CAP) is a two-year roadmap outlining how qualifying agencies of the Community Service Block Grant (CSBG) plan to deliver CSBG programs. The CAP recognizes and assesses poverty-related needs and resources in Alameda County by gathering data from a broadly circulated community survey. The community survey is currently being translated into Spanish and Mandarin and will be available in the next two weeks. The Public Hearings will take place via Zoom Teleconference on June 10, 2021, due to COVID-19.

C. 2020 Organizational Standards

The 2020 Organizational Standards Assessment review was completed on February 04, 2021. AC-OCAP received a 98% Met Rate, with only Standard 5.5 Not Met. Standard 5.5 states, “The department’s tripartite board/advisory body meets in accordance with the frequency and quorum requirements and fills board vacancies as set out in its governing documents”. AC-OCAP submitter notes include, “AC-OCAP has two open Community Sector seats, Oakland District 1 and Alameda County. Please note, while there are vacancies on the Administering Board, meetings have quorum.” Since the Assessment review, AC-OCAP has filled the Alameda County vacancy and currently has an applicant for District 1.

D. 2020-2021 Earned Income Tax Credit (EITC) Campaign

E. Clemons reviewed the getyourrefund.org/oakland hub statistics: 52 clients, 9 E-Files, four Quality Reviews, five Tax Preps, 18 Intake, and 16 Non-Fileers. The EITC program has a partnership with University of Berkeley Volunteer Income Tax Assistant (VITA) students, who are preparing taxes on the getyourrefund.org/oakland hub. Drop-off appointments on Wednesday and Thursday at the Downtown Oakland Senior Center can be scheduled by calling the EITC Hotline at (510) 238-4911.

E. Clemons discussed the new [Golden State Stimulus](#), which provides \$600 -\$1200 cash payments to qualifying EITC individuals and families, and the new expanded Child Tax Credit offered by the American Rescue Plan is expected to bring millions of children above the poverty line.






Gender of CSBG Clients: January - December 2020
(of those reporting on Gender)




Age Group of CSBG Clients: January - December 2020

(of those reporting on Ethnicity)




Ethnicity of CSBG Clients: January - December 2020
(of those reporting on race)




**Education Level of CSBG Clients Age 14-24:

(of those reporting on Education)




**Education Level of CSBG Clients Age 25+: January -

Helping People...Changing Lives

Alex was born and raised in deep East Oakland, where he lives with his mother and older sisters. He first heard about **New Door Ventures** job training and employment placement when he was a student at Dewey Academy, and was later referred to the program by his probation officer. Alex exemplifies so many of the strengths and qualities that staff strives to cultivate and support in the youth served. Alex is a natural leader who has been persistent and resilient, despite the myriad of challenges and obstacles that life has presented. Alex is a positive presence voice in the program and in the other communities he is a part of. His New Door paid internship as a mentor at Edna Brewer was invaluable. His site supervisor had nothing but glowing things to say about him, highlighting his consistency, his communication skills, and the positive, respectful, and inspiring relationships he built with the middle school students he was mentoring. Alex's engagement in the program is a testament to his desire to be an effect positive change in his community and to reach his educational, personal, and career goals – we cannot wait to see what lies ahead for Alex.

After being incarcerated, **Darren** said he struggled with his transition back into society. He states his previous choices in 2005 landed him a prison term that was the result of a drug related robbery with one count of murder and another for attempted murder - a choice he says that had major repercussions and grand pitfalls. He was sentenced in 2008 with 32 years to life in prison with the possibility of parole in the year of 2037. He says being isolating in a jail cell was severe psychological punishment. However, his fate changed and in October of 2020, Darren was resentenced and granted early release on parole. One week into his parole term, he was discharged from parole and released with no means of support. Within the same month, Darren was referred to **Lao Family Community Development** services and gained enrollment into the Find a job in 1 to 30 days' program where he received employment assistance. On 24th day, Darren successfully secured employment! Currently, Darren is still participating and receiving support form Lao Familys supervision program where he is on track to reach sefl-sufficient and independence once again.

Beth, a single mother of five children, lost her job and her apartment after her landlord sold his property and failed to notify his tenants. With her finances depleted and no other housing options, she began calling shelters to see who could help and that's when she found **Alliance for Community Wellnes - FESCO's** Les Marquis House. After being accepted into Les Marquis Shelter, Beth went back to her previous employer to let them know she was now stably housed. She went in for an interview and was rehired full-time. With the support of staff, she was also able to identify child care for her two youngest kids, and her three oldest enrolled in school. Her oldest daughter had been struggling academically and had attendance issues in school, but after settling in at Les Marquis, she did not missed one day of school and improved her grades. Beth was able to start saving money and was very excited about the possibility of having their own place again so that she could provide a safe and healthy home for herself and her five children. After filling out an application, she was quickly approved. Within three weeks, she moved out of Les Marquis, found a two-bedroom apartment that her and her family now call home. Because Beth is employed and makes slightly above minimum wage, she is not eligible for many public benefits to assist her and her children. Like hers, this exact situation keeps hundreds of families in the Bay Area in a constant state of scrambling to make up the difference to stay above water. After entering the Linkages Program, she realized that she needed to have more income to support her family. She started a side business by purchasing storage lockers and selling the contents online and at local flea markets, finding a new sense of pride and economic empowerment. With her new income, Beth was able to afford her housing and build a \$10,000 savings for herself and her children.

Hannah is a 66-year-old African-American homeowner in Castro Valley who is disabled and extremely low-income. She approached **HERA** to address extensive damage to her credit from collections on student loans. It was not clear initially, whether the loans were for her, or loans she had taken out for her adult daughter's education years before. HERA researched the debts and found that she was current on her own student loans (still outstanding at age 66). HERA advised her on the fact that she qualified for public service loan forgiveness which she had known nothing about. She had been using a significant amount of her tiny income from part-time employment for her own loans. HERA researched her loan history and found a complicated maze of debt that she was not clear on. She had not received any billing but showed as being in default on at least one loan. She also had co-signed for private student loans for her daughter, not just federally insured loans. It took months to obtain documents so HERA could review them, verify amounts owed, payment status on all, and walk through strategies with Hannah on how to handle each. HERA helped her pursue resolution and clean-up each debt. Her credit score was in the 500s when she came to HERA. Her score has gone up over 50 points since HERA started the clean-up process on the various student loans and it will continue to improve as Hannah resolves her debt and rebuilds her credit.
