INFORMATION

As a continued best practice and in accordance with the City's Investment Policy, the Finance Department will publish a quarterly informational cash management report for the City Council. For the quarter ended December 31, 2021, the City's Operating Pool Portfolio had a balance of \$1.66 billion and yielded 0.23 percent, while the Successor Agency's Investment Portfolio had a balance of \$9.50 million and yielded 0.03 percent.

As of December 31, 2021, the portfolios are in full compliance with the Investment Policy of the City for Fiscal Year (FY) 2021-22. The portfolios' credit quality remains high and well within Investment Policy parameters. Liquidity remains sufficient to meet projected cash flow needs for the next six months.

Provided in ***Attachment A*** are each portfolio's current market value and yield as of December 31, 2021, as well as comparisons to other market benchmarks. This report confirms that no leverage (use of debt to supplement investments) was utilized nor were derivatives (such as interest rate swaps, futures, or options) held during the reporting period.

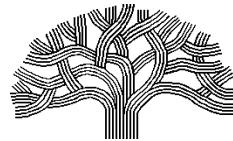

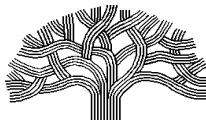

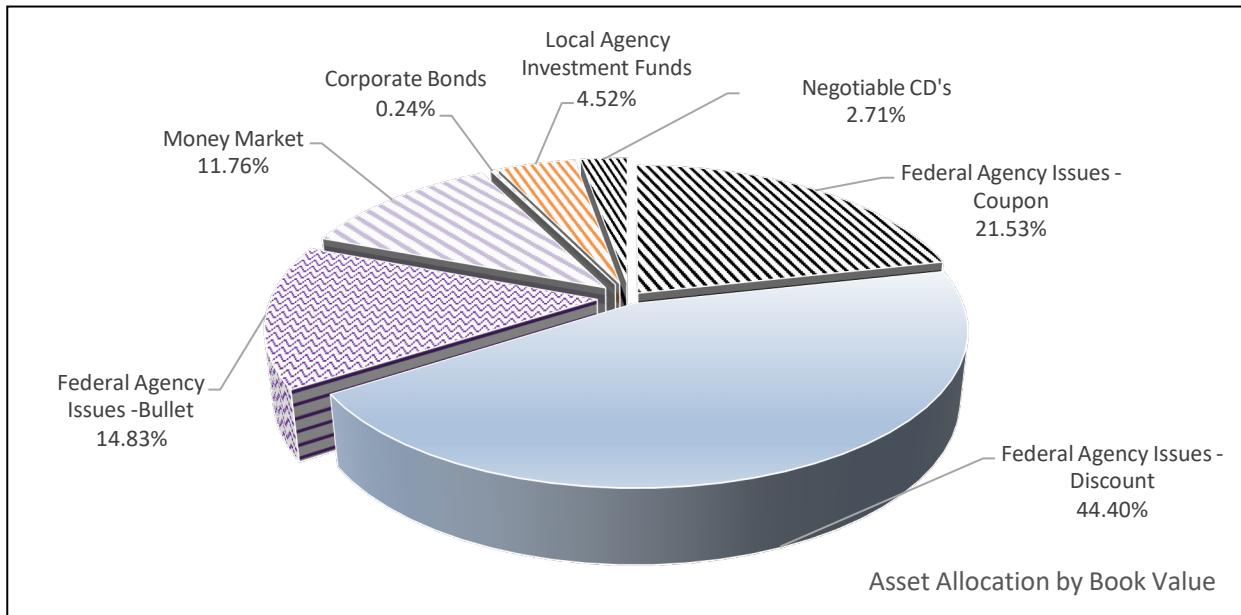

I. ECONOMIC REVIEW

MARKET OVERVIEW

COVID-19 virus pandemic has disrupted economic activity in many countries, including the United States. There has been a recent surge in COVID cases in December 2021 with reported U.S daily cases above 1 million, particularly Delta variant and newer highly contagious Omicron variant, which is posed to slow the current economic recovery, and cast a doubt as to when the pandemic will end. The strain has caused milder symptoms and fewer hospitalizations. The economic concerns and market volatility are expected to continue in 2022, along with supply and labor market constraints, surge in energy prices, and persistent high inflation.

The Federal Open Market Committee (“FOMC”) believes inflation is persistent, and U.S economy is strong enough to sustain increased interest rates in 2022, the first interest rate hike is expected in the first quarter of 2022, the first rate increase in three years, as full employment goal expectations are met. The policy is also likely in response in the highest inflation levels in 40 years for consumer prices.

The U.S economy is expected to bounce back in fourth quarter of 2021, despite the rising delta variant and supply chain bottlenecks. According to the U.S. Department of Commerce, Real Gross Domestic Product – the output of goods and services produced by labor – is expected to increase at an annual rate of 6.0 percent in the fourth quarter of 2021. The Real GDP had increased 2.3 percent in the third quarter of 2021.

The U.S economy created less than expected jobs in December 2021, as labor shortages hit business amid surging omicron variant cases. According to the Bureau of Labor Statistics, Nonfarm payroll increased by only 199,000 jobs in December 2021, after increasing by 249,000 jobs in November 2021. However, the unemployment rate decreased to 3.9%, from 4.2% in November 2021. Economists were expecting addition of 499,000 jobs. The biggest jobs gains were in the hospitality and leisure industry where 53,000 jobs were created, followed by professional and business services creating 43,000 jobs, and manufacturing sector added 26,000 jobs. Job growth has averaged 537,000 per month in 2021. Prior to the coronavirus impact, the unemployment rate was at 3.5%, the lowest in 50 years. Average hourly wages increased 0.6% in December 2021, up 4.7% year over year.

U.S. consumer spending increased in November 2021. The Bureau of Economic Analysis reported that consumer spending, which accounts for almost 70 percent of the economy, increased 0.6% in the November 2021. The personal consumption expenditure (PCE) price index excluding food and energy increased by 0.5% in November 2021. In 12 months through November 2021, core PCE index has increased 4.7%, the largest inflation pressures in more than a decade. The core PCE is the Federal Reserve's preferred inflation measure and has a 2 percent target.

U.S. consumer prices increased at its fastest 12-month pace in the last 40 years in December 2021. The Labor Department reported that its Consumer Price Index increased 0.5% in December 2021. The CPI had increased 0.4 percent in November 2021. Core inflation, which excludes volatile food and energy costs increased 0.6% in December 2021, and 5.5% since last December. Shelter costs and used vehicle prices have been major component of inflation, as shelter cost had increased 4.1%

and used vehicle increased 37.3% for the year. The Consumer Price Index has increased 7.0 percent over the past year, which is now above to the FOMC inflation threshold of 2 percent, the highest since 1982.

U.S. consumer confidence improved in December 2021 even amid rising inflation and rising variant cases. The Conference Board, a non-profit business and research group organization reported that its index of consumer confidence increased to 115.8 in December 2021 after 110.8 reading in November 2021. Consumers were confident in spending on holiday spending and travel.

However, U.S. retail sales unexpectedly decreased in December 2021, as surging inflation and prices curb consumer spending. The U.S. Commerce Department reported that retail sales decreased by 1.9 percent in December 2021, after increasing 0.2 percent in November 2021. Economists surveyed by Bloomberg, were expecting retail sales to decrease only by 0.1%. Retail sales remains strong for the year 2021, up 16.9% since last December. Online spending plunged by 8.7%, furniture and home furnishing declined by 5.5%, restaurant and bars declined by 0.8%. Surging omicron cases and rising inflation has consumer worried about spending and future economy uncertainty.

U.S. manufacturing activity slightly decreased in December 2021, amid supply chain constraints and short labor. The Institute of Supply Management (ISM) said its manufacturing index increased to a reading decreased to 58.7 in December 2021, from 61.1 in November 2021. Any number above 50% signals expansion in the manufacturing economy, which accounts for 11.9% of the U.S economy, as the manufacturing since April 2020, 19 months in a row.

U.S. producer prices increased less than expected in December 2021, as supply chain pressure and material shortage ease, however inflation remains high and present in all levels of the U.S economy. The Labor Department reported that its producer price index for final demand increased by 0.2% in December 2021 after increasing 1.0 percent in November 2021. In the 12 months through December 2021, the PPI increased 9.7 percent, the highest yearly increase since 2010.

U.S. import prices unexpectedly decreased in December 2021, as prices dropped for cost of petroleum products. According to U.S. Bureau of Labor Statistics, import prices fell by 0.2 percent in December 2021, after import prices had increased 0.7 % in November 2021. Economists surveyed by Bloomberg had forecasted import prices to increase 0.3 percent. In the 12 months through December 2021, import prices increased by 10.4%, suggested imported inflation could be a concern.

U.S. homebuilding increased to a nine-month high in December 2021, amid a surge in multi-family housing projects. The Commerce Department reported that Housing Starts increased 1.94 percent to a seasonally adjusted annual rate of 1.702 million units in December 2021. Housing Starts are up 15.6% from last December. The Commerce Department also reported that single family homebuilding, which accounts for the largest share of the housing market, decreased 2.3 percent in December 2021. The volatile multi-family housing segment increased 13.7% in December, suggesting strong demand for rental housing.

Sales of new U.S. single family homes increased in November 2021, as demand for housing remains strong amid low interest rates. The Commerce Department reported that new home sales increased by 12.4 percent to a seasonally adjusted annual rate of 744,000 units in November 2021. Sales have increased for the third straight month in November.

The U.S. existing home sales slowed in December 2021, as first-time home buyers struggle with higher home prices nationwide. The National Association of Realtors reported that its index of existing home sales decreased 4.6 percent to a seasonally adjusted annual rate of 6.18 million homes. Existing home sales makes up about 90 percent of U.S. home sales, up 8.5% since last year.

INTEREST RATES

During the fourth quarter, the “FOMC”, met on Nov 3rd and on December 15th, and on both meetings FOMC kept the funds rate at 0.00-0.25%. FOMC stated that in light of higher inflation and further improvement in labor market, FOMC will start tightening its accommodative policies. The central bank will increase the speed in the reduction of its monthly bond purchases by \$60 billion of bonds each month starting in January 2022, also known as bond tapering.

FOMC is poised to keep federal funds rate at zero in the near term. The FOMC has indicated the path of the economy will significantly depend on the path of the virus. The Federal Reserve is prepared to use its full range of tools to ensure that there is liquidity in the market, that is to support the flow of credit to households and businesses. FOMC is willing to accommodate policy, so inflation can moderately exceed 2 percent.

The FOMC has reflected that some financial conditions have improved in part of policy measures implicated by Federal Government and Federal Reserve, however U.S economic uncertainty remains, and will require additional fiscal stimulus for continued economy growth. The FOMC committee expects to maintain this target range until it is confident that the economy has weathered recent events and is on track for its maximum employment and price stability goals.

II. CITY OF OAKLAND

PORTFOLIO REVIEW

The City's Operating Pool Portfolio balances increased from \$1.51 billion as of September 30, 2021 to \$1.66 billion as of December 31, 2021. This net balance increase was mainly due to the following: receipt of \$234.48 million in property taxes, offset by debt service payments of approximately \$57.95 million. The remaining balance decrease of approximately \$25.92 million, is due to receipt of other revenues, such as Sales Tax offset by operational expenses such as payroll and vendor payments.

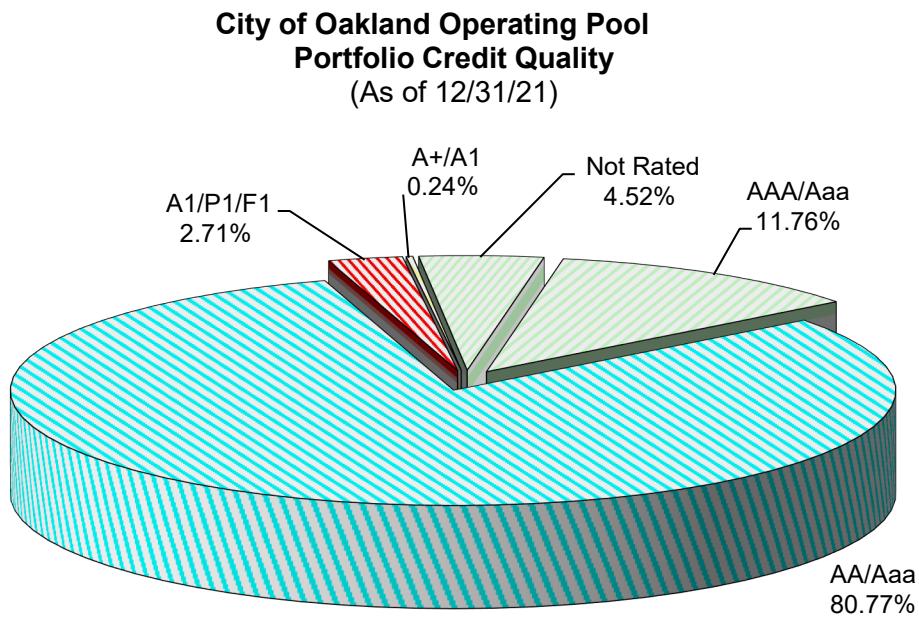
PORTFOLIO COMPOSITION

The Portfolio continues to comply with all provisions of the City's adopted Investment Policy for Fiscal Year 2021-22, including compliance with applicable local ordinances and resolutions such as Nuclear Free Zone, Linked Banking, Tobacco Divestiture, Fossil Fuels, and Guns/Ammunition.

The following discussion addresses the City's operating pool portfolio characteristics in terms of the Investment Policy's four objectives: safety, liquidity, diversity and return. Portfolio detail for each month of the current quarter is attached to this report.

Preservation of Capital/Safety. In the chart below, the City's holdings are depicted by credit rating category as of December 31, 2021. Approximately 80.77% of Operating Pool investment were rated in the AA/Aaa category while 11.76% in AAA/Aaa, 4.52% primary unrated holdings represent the Fund's investments in the Local Agency Investment Fund (“LAIF”), 2.71% in the A1/P1 category and 0.24% in A1/A category. On August 6, 2011, the government agencies were downgraded by Standard and Poor's Rating Agency to AA+ from AAA. Moody's Investors' Service and Fitch Ratings continue to maintain AAA rating for government agencies.

The City's Investment Policy for FY 2021-2022 does not have a rating criteria level for government agencies.



Liquidity. Liquidity continues to be a primary objective when making investment decisions for the Operating Pool portfolio. With ongoing capital projects at the Port and within the City, and to ensure that sufficient liquidity is available to meet day-to-day expenditures, the City maintains a sufficient "cushion" in money market funds to meet unanticipated project expenditures.

Debt service payable from the City's Operating Pool for the Port and the City for the six months following December 31, 2021 is approximately \$227.36 million. Consequently, staff will continue to invest in short-term instruments and money markets as investment tools to maintain adequate short-term liquidity.

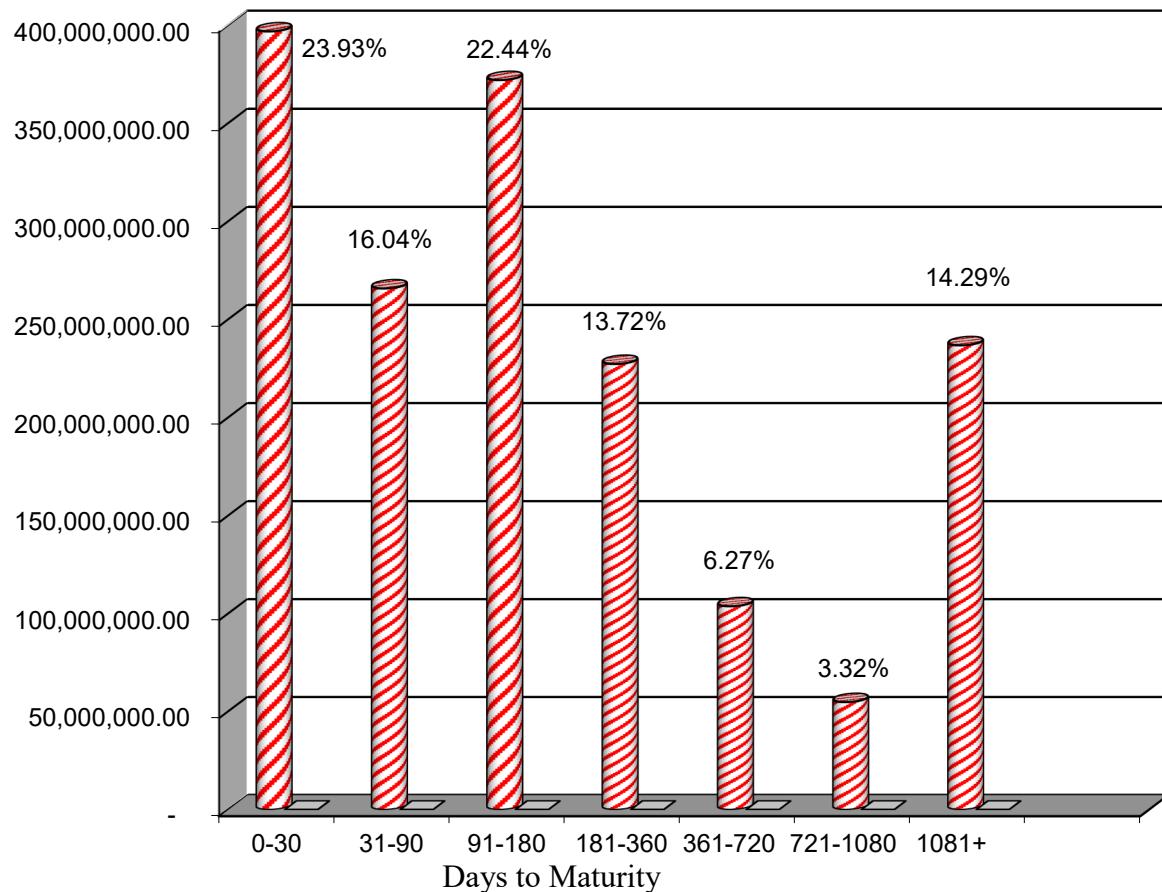
Investments maturing within 180 days include \$75.00 million in LAIF and \$195.00 million in money market funds, both of which are considered to have a one-day maturity due to the ability to withdraw funds daily.

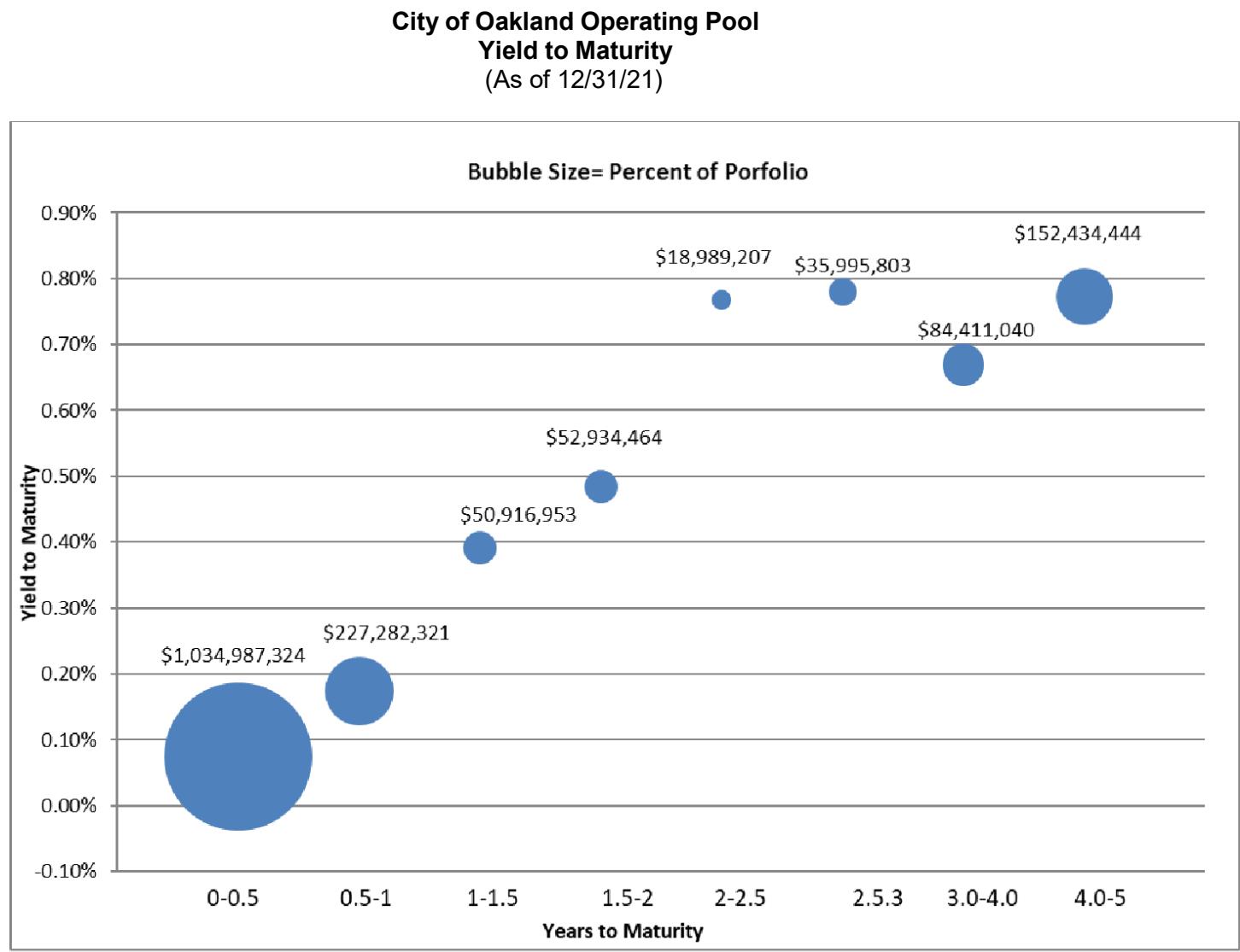

The following graph depicts the Operating Pool Portfolio by dollars invested and the percentage in each maturity range as of December 31, 2021.

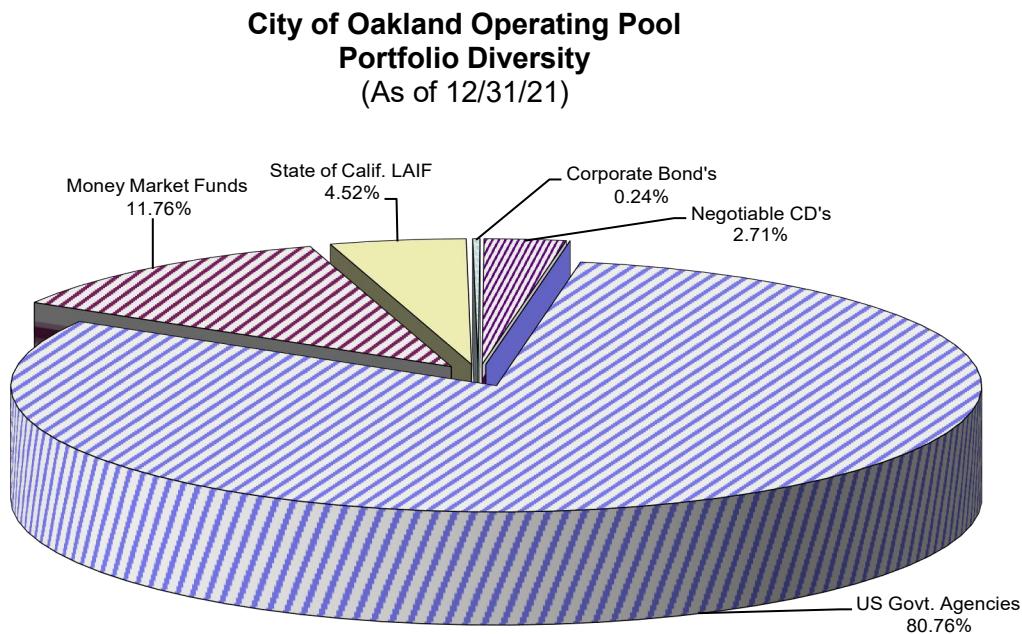
**City of Oakland Operating Pool

The following graph depicts the Operating Pool Portfolio by yield to maturity vs time to maturity, this indicates that higher percentage of portfolio is invested in front end of the yield curve to meet daily liquidity needs.



Diversity. To reduce the risks of investing, the portfolio is diversified among a variety of financial instruments, as depicted by the following chart. In addition to limiting the types of investments permissible in any one category as outlined in the Investment Policy, no more than 5% of the total cash portfolio may be invested in any one issue. This single-issue provision does not apply to money market funds or to LAIF, as they each are backed by a large portfolio of highly diversified assets.



Derivatives. The Operating Pool Portfolio contained no derivative instruments (interest rate swaps, futures, or options) during this reporting period.

Yield. Total interest earned for the quarter ended December 31, 2021 was approximately \$813,106. The effective rate of return on total assets in the Operating Pool Portfolio for month-end December 31, 2021, was 0.23% as compared to 0.19% for September 30, 2021. It continues to be the City's practice to hold investments to maturity rather than to sell. The primary investment objective of the City for the portfolio is to maximize safety, liquidity, and return in that respective order.

Benchmark Comparison:

The effective rate of return on total assets in the Operating Pool Portfolio for the month ending December 31, 2021 was 0.23 percent. The City's Operating Pool Portfolio had slightly underperformed the 1-year government agency which yielded a rate of 0.25 percent. The City's Operating Pool Portfolio slightly outperformed the Local Agency Investment Fund ("LAIF"), which ended the month at 0.21 percent.

The Alameda County Pool had a preliminary accrual basis rate of return for December 2021 of 0.49 percent. The Alameda County Pool had a Portfolio of \$7.84 billion with 607 days to maturity, meanwhile the City's Operating Pool had an accrual rate of return of 0.23 percent for December 2021. The City Operating Pool had a Portfolio of \$1.66 billion with 356 days to maturity.

As of December 31, 2021, the City Operating Pool's average days-to-maturity (ADM) was 356 days versus LAIF's average days-to-maturity (ADM) was 340 days.

The performance comparison to LAIF must be considered in light of LAIF's historical tendency to lag market changes in both rising and falling interest rate environments. The City does not actively sell securities in the portfolio to take advantage of cyclical swings in the market, which could result in the loss of principal. The primary investment objective of the City for the portfolio is to maximize safety, liquidity, and yield in that respective order.

The summary below provides total portfolio income recognized for the last quarter as compared to the prior quarter and the same quarter one year ago.

Valuation and Leverage. Based on information received from Interactive Data Corporation, the market value of the City Operating Pool portfolio was \$1.65 billion, which was below book value by \$4,110,664. There was no leverage in the portfolio during the reported period, and liquidity was maintained at sufficient levels.

The following table illustrates the net unrealized gains or losses on the portfolio when comparing the portfolio's market value to both its original cost and amortized cost.

III. CITY OF OAKLAND SUCCESSOR AGENCY PORTFOLIO

PORTFOLIO REVIEW

The Successor Agency's portfolio stayed the same from a balance of \$9.50 million as of September 30, 2021 to a balance of \$9.50 million as of December 31, 2021. The portfolio netted zero as any revenues were offset by other vendor payments.

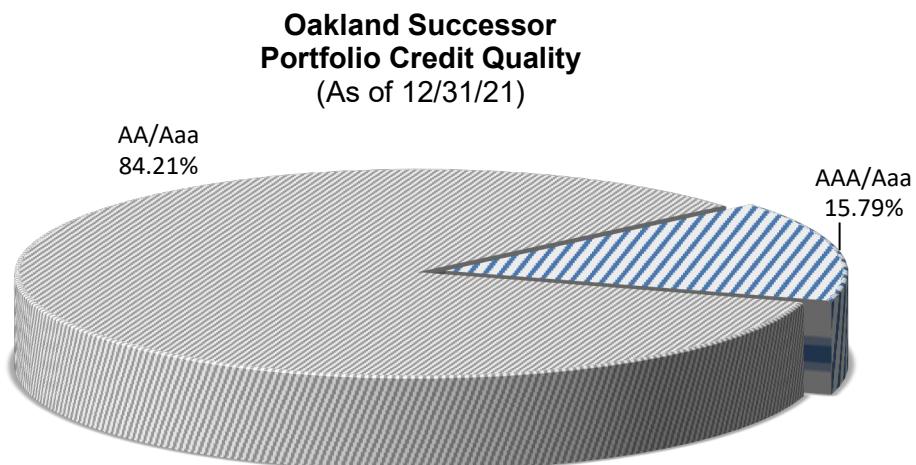
PORTFOLIO COMPOSITION

The Portfolio continues to comply with all provisions of the City's Investment Policy for Fiscal Year 2021-2022, including compliance with applicable local ordinances and resolutions such as Nuclear Free Zone, Linked Banking, and Tobacco Divestiture. In addition, the City will consider investing, when possible, in companies that promote the use and production of renewable energy resources and any other type of socially responsible investments.

The following discussion addresses the Successor Agency's investment portfolio characteristics in terms of the Investment Policy's four objectives of safety, liquidity, diversity and return. Portfolio detail for each of the months in the current quarter is attached to this report.

Preservation of Capital/Safety. The Successor's holdings by credit rating category are depicted in the chart below. Approximately 15.79% of Operating Fund investments were rated in the AAA/Aaa, while 84.21% were rated AA/Aaa . On August 6, 2011, the government agencies were downgraded by Standard and Poor's Rating Agency to AA+ from AAA. Moody's Investors' Service and Fitch Ratings continue to maintain AAA for government agencies.

The City's Investment Policy for FY 2021-2022 does not have a rating criteria level for government agencies.



Liquidity. Liquidity within the Successor's Portfolio remains sufficient to meet only debt service needs of the Successor for the next six months and beyond. The debt service payment for the next six months for the Successor is approximately \$5.66 million. The estimated 6-month cash flow for Successor Portfolio is summarized below:

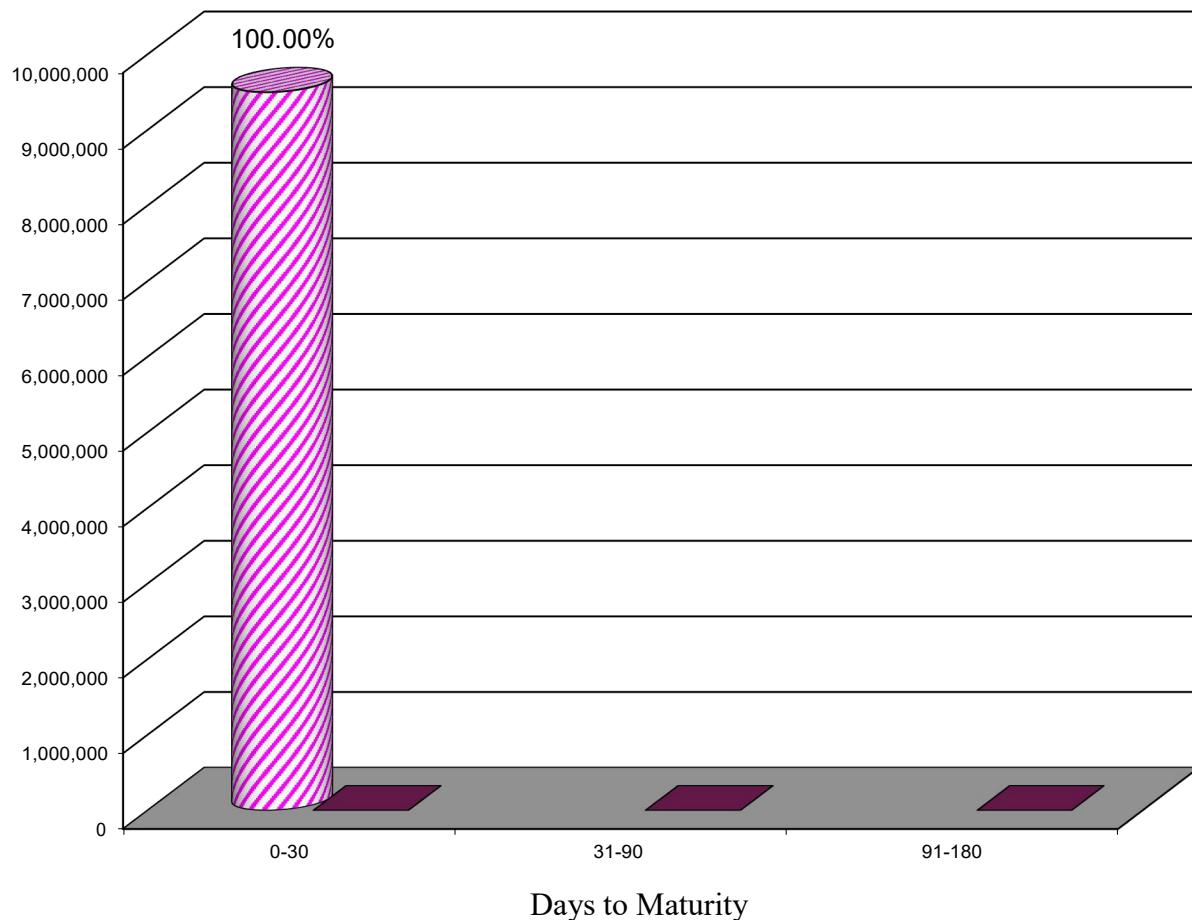

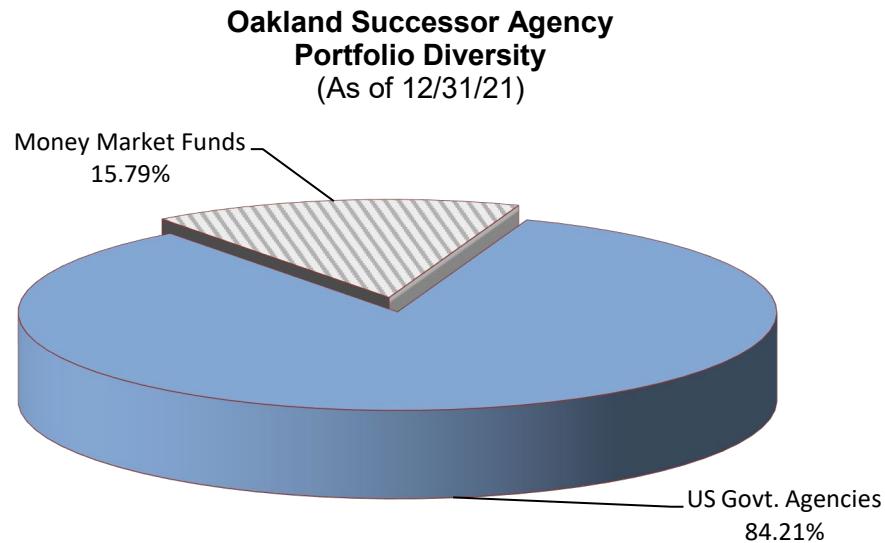

Diversity. To reduce the risks of investing, the portfolio is diversified among a variety of instruments, as depicted by the following chart. In addition to limiting the types of investment in any one category, as outlined in the Investment Policy, no more than 5 percent of the total cash portfolio may be invested in any one issue.



Derivatives. The Successor Portfolio contained no derivative instruments during this reporting period.

Yield. Total interest earned for the quarter ended December 31, 2021, was approximately \$520. The effective rate of return on total assets in the Successor's Portfolio was 0.03 percent for month ending December 31, 2021. The Successor's Portfolio underperformed the 1-year government agency which yielded a rate of 0.25 percent as of December 31, 2021. The Successor's Portfolio underperformed the Local Agency Investment Fund ("LAIF"), which ended the month at 0.21 percent. The performance comparison to LAIF must be considered in light of LAIF's historical tendency to lag market changes in both rising and falling interest rate environments. The Successor Portfolio has extremely shorter duration due to liquidity concerns/needs, thus was able to only generate short term returns in comparison to LAIF and 1-year government agency.

As of December 31, 2021, Successor's Portfolio Fund's average days-to-maturity (ADM) was 19 days versus LAIF's average days-to-maturity (ADM) was 340 days.

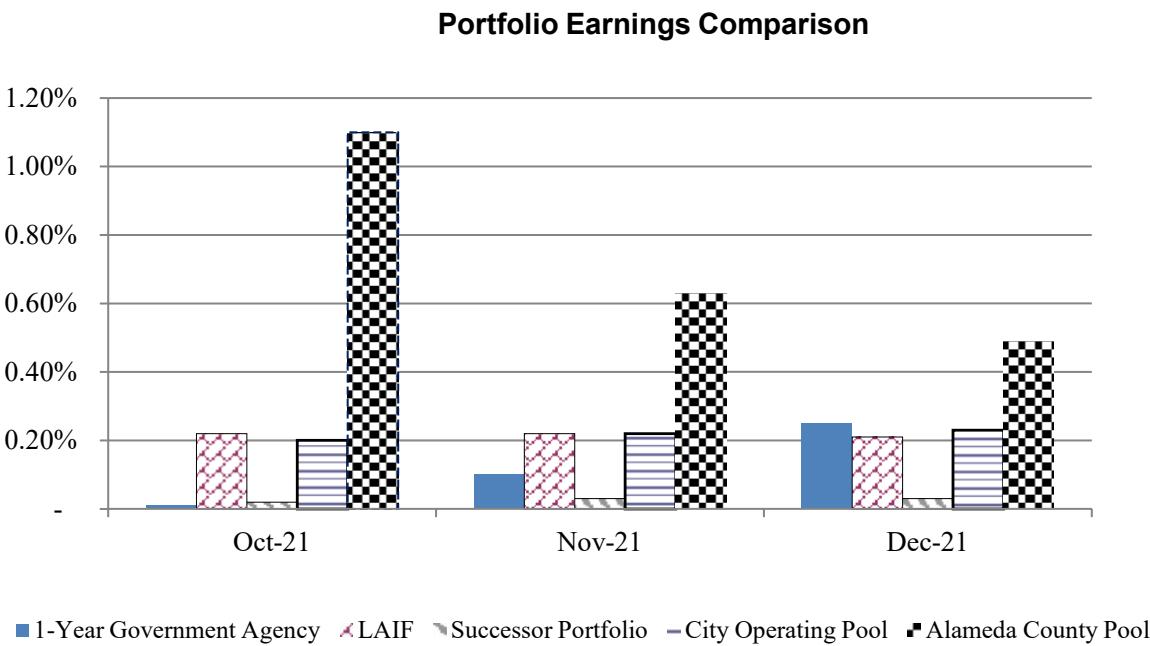

Valuation and Leverage. Based on information received from Interactive Data Corporation, the market value of the Successor portfolio for the quarter ended December 31, 2021 was \$9.50 million, which was above book value by \$246. There was no leverage in the portfolio during the reporting period and liquidity was maintained at sufficient levels.
