INFORMATION

As a continued best practice and in accordance with the City's Investment Policy, the Finance Department will publish a quarterly informational cash management report for the City Council. For the quarter ended March 31, 2021, the City's Investment Portfolio had a balance of \$1.43 billion and yielded 0.21 percent, while the Successor Agency's Investment Portfolio had a balance of \$54.49 million and yielded 0.06 percent.

As of March 31, 2021, the portfolios are in full compliance with the Investment Policy of the City for Fiscal Year (FY) 2020-21. The portfolios' credit quality remains high and well within Investment Policy parameters. Liquidity remains sufficient to meet projected cash flow needs for the next six months.

Provided in *Attachment A* are each portfolio's current market value and yield as of March 31, 2021, as well as comparisons to other market benchmarks. This report confirms that no leverage (use of debt to supplement investments) was utilized nor were derivatives (such as interest rate swaps, futures, or options) held during the reporting period.



I. ECONOMIC REVIEW

MARKET OVERVIEW

COVID-19 virus pandemic had disrupted economic activity in many countries, including the United States. The longest expansion in the U.S history had come to an end in the first quarter of 2020 after almost 11 years. Most economists, including the Federal Reserve indicated that the economic recovery will be slow and gradual. However, the U.S economic is showing signs of quicker recovery, as the vaccine rollouts continues faster than anticipated, and the passing of "American Rescue Plan Act of 2021", a \$1.9 trillion stimulus bill. The bill signed into law by President Joe Biden on March 11th, 2021, in hopes to further support U.S economy from economic and health effects of the COVID-19 pandemic.

The U.S economy is expected to gain momentum in the second quarter of 2021, as the COVID-19 cases decline in most states and most business are reopening, and surging U.S manufacturing activity. According to the U.S. Department of Commerce, Real Gross Domestic Product – the output of goods and services produced by labor – is expected to increase at an annual rate of 8.3 percent in the first quarter of 2021. The Real GDP had increased 4.3 percent in the second quarter of 2021.

The U.S economy created more than expected jobs in March 2021, as jobs growth surged at a faster pace since last year, as more business reopen. According to the Bureau of Labor Statistics, Nonfarm payroll increased by 916,000 jobs in March 2021, after increasing by 468,000 jobs in February 2021. The unemployment rate fell to 6.0%. Economists were only expecting addition of 675,000 jobs. The biggest jobs gains were in the hospitality and leisure industry, as restrictions are easing and business are opening such as hotels, restaurants, and travel. Prior to the coronavirus impact, the unemployment rate was at 3.5%, the lowest in 50 years. The pandemic induced economic shutdown saw about 22 million layoffs since March 2020. There are still about 8.4 million fewer jobs than in February 2020.

U.S. consumer spending is expected to increase slightly in March 2021, after decreasing in February 2021 due to harsh weather in most parts of the country. The Bureau of Economic Analysis reported that consumer spending, which accounts for almost 70 percent of the economy, decreased 1.0 % percent in February 2021 after increasing 3.4 percent in January 2021. The personal consumption expenditure (PCE) price index excluding food and energy increased to 0.1% in February 2021. In 12 months through February, core PCE index has increased 1.4%. The core PCE is the Federal Reserve's preferred inflation measure and has a 2 percent target.

U.S. consumer prices surged in March 2021, as cost of gasoline increases as demand increases, also prices boosted by federal stimulus. Gasoline prices have surged 9.1% in March, up 22.5% since last March. As inflation appears to be slowing increasing as the economy gradually recovers from COVID-19 recession. The Labor Department reported that its Consumer Price Index increased 0.6% in March 2021. The CPI had increased 0.4 percent in February 2021. Core inflation, which excludes volatile food and energy costs increased 0.3% in March 2021. The Consumer Price Index has increased 1.6 percent over the past year, which is now close to the Federal Open Market Committee (FOMC) inflation threshold of 2 percent.

U.S. consumer confidence increased as consumers were more optimistic about the future expectations, as faster vaccine rollout amid coronavirus pandemic. The Conference Board reported that its index of consumer confidence increased to 109.7 in March 2021 after 90.4 reading in February 2021.

- U.S. retail sales surged more than expected in March 2021, as business reopen and consumers are spending amid stimulus check boost, mainly in bars and restaurants. The Commerce Department reported that retail sales increased by 9.8 percent in March 2021, after decreasing 2.7 percent in February 2021. Economists were expecting retail sales to increase by only 6.1%. Sporting goods, clothing and food and beverage led the gains in spending and contributed to the best month for retail since May 2020.
- U.S. manufacturing activity surged to the highest level in 37 years in March 2021, driven by strong growth in new orders, as manufacturing sector rebounds from lockout and signaling manufacturing entering expected expansion cycle, and as factories reconfigured to bring back workers safely. The Institute of Supply Management (ISM) said its manufacturing index increased to a reading of 64.7 in March 2021, from 60.8 in February 2021. Any number above 50% signals expansion in the manufacturing economy, which accounts for 11.9% of the U.S economy.
- U.S. producer prices increased more than expected in March 2021 as the demand of cost of goods such as gasoline and services increased as pandemic lockdown eased. The Labor Department reported that its producer price index for final demand increased by 1.0% in March 2021 after increasing 0.5 percent in February 2021. This was largest annual gain in 9 ½ years, with the pandemic easing. In the 12 months through March 2021, the PPI increased 4.2 percent.
- U.S. import prices increased in March 2021 for the fourth straight month, with products such as lumber, petroleum, computer chips, and cars posting gains. According to U.S. Bureau of Labor Statistics, import prices increased 1.2 percent in March 2021, after import prices had increased 1.3 % in February 2021. Economists had forecasted import prices to increase 0.9 percent. In the 12 months through March 2021, import prices increased by 6.9 %, suggested imported inflation could be a concern soon.
- U.S. homebuilding urged to a 15-year high in March 2021, as housing sector continues to show positive signs in economic recovery, amid low interest rates and migration to suburbs and low density areas, however shortage of homes is threatening to slow the housing market momentum. The Commerce Department reported that Housing Starts increased 19.4 percent to a seasonally adjusted annual rate of 1.739 million units in March 2021. Housing Starts are up 37% from March 2020. The Commerce Department also reported that single family homebuilding, which accounts for the largest share of the housing market, increased 15.3 percent in March 2021.

Sales of new U.S. single family homes rebounded more than expected in March 2021, as housing is still strong and is leading economic recovery, the fastest pace since 2006. The Commerce Department reported that new home sales increased by 20.7 percent to a seasonally adjusted annual rate of 1.021 million units in March 2021, after decreasing 16.2% in February 2021. The housing market is showing positive signs of recovery, and is leading recovery efforts fueled by low interest rates.

The U.S. existing home sales decreased for the second straight month in March 2021, as low home inventories are pushing prices higher. The National Association of Realtors reported that its index of existing home sales decreased 3.7 percent to a seasonally adjusted annual rate of 6.01 million homes. Existing home sales makes up about 90 percent of U.S. home sales, up 12.3 % since last year.

INTEREST RATES

During the first quarter, the Federal Open Market Committee ("FOMC"), met on January 27th and March 17th, and on both meetings FOMC kept the funds rate at 0.00-0.25%. The FOMC has stated that the effects of the COVID19 virus will weigh in on the economic activity in the near term and pose risks to the economic outlook, despite moderation increase in the pace of the economy, as noting that

there has been some increase in economy activity and unemployment during the quarter, however sectors most adversely affected by the pandemic remains weak.

FOMC is posed to keep federal funds rate at zero in the near term. The FOMC has indicated the path of the economy will significantly depend of the path of the virus. The Federal Reserve is prepared to use its full range to tools to ensure that there is liquidity in the market, that is to support the flow of credit to households and businesses. FOMC is willing to accommodate policy, so inflation can moderately exceed 2 percent.

The FOMC has reflected that some financial conditions have improved in part of policy measures implicated by Federal Government and Federal Reserve, however U.S economic uncertainty remains, and will require additional fiscal stimulus for continued economy growth. The FOMC committee expects to maintain this target range until it is confident that the economy has weathered recent events and is on track for its maximum employment and price stability goals.

II. CITY OF OAKLAND

PORTFOLIO REVIEW

The City's Portfolio balances increased from \$1.38 billion as of December 31, 2020 to \$1.43 billion as of March 31, 2021. This net balance increase was mainly due to the following: receipt of \$78.55 million in property taxes, approximately \$77.93 million in business tax revenues, offset by debt service payments of approximately \$115.81 million. The remaining balance increase of approximately \$6.53 million, is due to receipt of other revenues, such as Sales Tax offset by operational expenses such as payroll.

PORTFOLIO COMPOSITION


The Portfolio continues to comply with all provisions of the City's adopted Investment Policy for Fiscal Year 2020-21, including compliance with applicable local ordinances and resolutions such as Nuclear Free Zone, Linked Banking, Tobacco Divestiture, Fossil Fuels, and Guns/Ammunition.

The following discussion addresses the City's investment portfolio characteristics in terms of the Investment Policy's four objectives: safety, liquidity, diversity and return. Portfolio detail for each month of the current quarter is attached to this report.

<u>Preservation of Capital/Safety.</u> In the chart below, the City's holdings are depicted by credit rating category as of March 31, 2021. Approximately 76.60% of Operating Fund investments were rated in the AA/Aaa category while 13.97% in AAA/Aaa, 5.42% primary unrated holdings represent the Fund's investments in the Local Agency Investment Fund ("LAIF"), 4.19% in the A1/P1 category. On August 6, 2011, the government agencies were downgraded by Standard and Poor's Rating Agency to AA+ from AAA. Moody's Investors' Service and Fitch Ratings continue to maintain AAA rating for government agencies.

The City's Investment Policy for FY 2020-2021 does not have a rating criteria level for government agencies.

<u>Liquidity.</u> Liquidity continues to be a primary objective when making investment decisions for the Operating Pool portfolio. With ongoing capital projects at the Port and within the City, and to ensure that sufficient liquidity is available to meet day-to-day expenditures, the City maintains a sufficient "cushion" in money market funds to meet unanticipated project expenditures.

Debt service payable from the City's Operating Pool for the Port and the City for the six months following March 31, 2021 is approximately \$171.56 million. Consequently, staff will continue to invest in short-term instruments and money markets as investment tools to maintain adequate short-term liquidity.


Investments maturing within 180 days include \$75.00 million in LAIF and \$200.00 million in money market funds, both of which are considered to have a one-day maturity due to the ability to withdraw funds daily.

The following graph depicts the Operating Fund Portfolio by dollars invested and the percentage in each maturity range as of March 31, 2021.


City of Oakland Operating Fund Portfolio Maturity (As of 3/31/21)


City of Oakland Operating Fund Yield to Maturity

<u>Diversity.</u> To reduce the risks of investing, the portfolio is diversified among a variety of financial instruments, as depicted by the following chart. In addition to limiting the types of investments permissible in any one category as outlined in the Investment Policy, no more than 5% of the total cash portfolio may be invested in any one issue. This single-issue provision does not apply to money market funds or to LAIF, as they each are backed by a large portfolio of highly diversified assets.

<u>Derivatives.</u> The Operating Fund Portfolio contained no derivative instruments (interest rate swaps, futures, or options) during this reporting period.

<u>Yield.</u> Total interest earned for the quarter ended March 31, 2021 was approximately \$783,571. The effective rate of return on total assets in the Operating Fund Portfolio for month-end March 31, 2021 was 0.21% as compared to 0.28% for December 31, 2021. It continues to be the City's practice to hold investments to maturity rather than to sell at a loss and adjust to the market's yield curve. The primary investment objective of the City for the portfolio is to maximize safety, liquidity, and return in that respective order.

Benchmark Comparison:

The effective rate of return on total assets in the Operating Fund Portfolio for the month ending March 31, 2021 was 0.21 percent. The City's Operating Fund Portfolio had out-performed the 1 year government agency which yielded a rate of 0.07 percent. The City's Operating Fund Portfolio slightly underperformed the Local Agency Investment Fund ("LAIF"), which ended the month at 0.36 percent.

The Alameda County Pool had a preliminary accrual basis rate of return for March 2021 of 1.32 percent. The Alameda County Pool had a Portfolio of \$7.33 billion with 578 days to maturity, meanwhile the City's Operating Fund had an accrual rate of return of 0.21 percent for March 2021. The City had a portfolio of \$1.43 billion with 286 days to maturity.

As of March 31, 2021, the City's Portfolio Fund's average days-to-maturity (ADM) was 286 days versus LAIF's average days-to-maturity (ADM) was 220 days.

The performance comparison to LAIF must be considered in light of LAIF's historical tendency to lag market changes in both rising and falling interest rate environments. The City does not actively sell securities in the portfolio to take advantage of cyclical swings in the market, which could result in the loss of principal. The primary investment objective of the City for the portfolio is to maximize safety, liquidity, and yield in that respective order.

<u>Valuation and Leverage</u>. Based on information received from Interactive Data Corporation, the market value of the Operating Fund was \$1.43 billion, which was below book value by \$478,632. There was no leverage in the portfolio during the reported period, and liquidity was maintained at sufficient levels.

The City's investment strategy, per the Investment Policy, is generally to hold securities to maturity. The net unrealized gains noted above are "paper gains" where there is an inverse relationship between the changes in market interest rates to the value of fixed income investment securities.

III. CITY OF OAKLAND SUCCESSOR PORTFOLIO

PORTFOLIO REVIEW

The Successor Agency's portfolio increased from a balance of \$18.50 million as of December 31, 2020 to a balance of \$54.49 million as of March 31, 2021. The portfolio increased due to receipt of \$41.76 million for Recognized Obligation Payment Schedule ("ROPS"), offset by debt service payments of approximately \$6.24 million, and other vendor payments.


PORTFOLIO COMPOSITION

The Portfolio continues to comply with all provisions of the City's Investment Policy for Fiscal Year 2020-2021, including compliance with applicable local ordinances and resolutions such as Nuclear Free Zone, Linked Banking, and Tobacco Divestiture. In addition, the City will consider investing, when possible, in companies that promote the use and production of renewable energy resources and any other type of socially responsible investments.

The following discussion addresses the Successor investment portfolio characteristics in terms of the Investment Policy's four objectives of safety, liquidity, diversity and return. Portfolio detail for each of the months in the current quarter is attached to this report.

<u>Preservation of Capital/Safety.</u> The Successor's holdings by credit rating category are depicted in the chart below. Approximately 17.43% of Operating Fund investments were rated in the AAA/Aaa, while 82.57% were rated AA/Aaa. On August 6, 2011, the government agencies were downgraded by Standard and Poor's Rating Agency to AA+ from AAA. Moody's Investors' Service and Fitch Ratings continue to maintain AAA for government agencies.

The City's Investment Policy for FY 2020-2021 does not have a rating criteria level for government agencies.



<u>Liquidity</u>. Liquidity within the Successor's Portfolio remains sufficient to meet only debt service needs of the Successor for the next six months and beyond. The debt service payment for the next six months for the Successor is approximately \$34.69 million. The estimated 6-month cash flow for Successor Portfolio is summarized below:





<u>Diversity.</u> To reduce the risks of investing, the portfolio is diversified among a variety of instruments, as depicted by the following chart. In addition to limiting the types of investment in any one category, as outlined in the Investment Policy, no more than 5 percent of the total cash portfolio may be invested in any one issue.



<u>Derivatives.</u> The Successor Portfolio contained no derivative instruments during this reporting period.

<u>Yield.</u> Total interest earned for the quarter ended March 31, 2021, was approximately \$7,496. The effective rate of return on total assets in the Successor's Portfolio was 0.06 percent for month ending March 31, 2021. The Successor's Portfolio underperformed the 1-year government agency which yielded a rate of 0.07 percent as of March 31, 2021. The Successor's Portfolio underperformed the Local Agency Investment Fund ("LAIF"), which ended the month at 0.36 percent. The performance comparison to LAIF must be considered in light of LAIF's historical tendency to lag market changes in both rising and falling interest rate environments. The Successor Portfolio has extremely shorter duration due to liquidity concerns/needs, thus was able to only generate short term returns in comparison to LAIF and 1-year government agency.

As of March 31, 2021, Successor's Portfolio Fund's average days-to-maturity (ADM) was 73 days versus LAIF's average days-to-maturity (ADM) was 220 days.


<u>Valuation and Leverage.</u> Based on information received from Interactive Data Corporation, the market value of the Successor portfolio for the quarter ended March 31, 2021 was \$54.50 million, which was above book value by \$7,718. There was no leverage in the portfolio during the reporting period and liquidity was maintained at sufficient levels.
