




Q2 Are you currently operating?





Q3 How long have you been operating?





Q4 Are you utilizing METRC (Marijuana Enforcement Tracking Reporting Compliance)?





Q5 What is your cannabis business' annual gross receipts last year?





Q6 What was your cannabis business' annual profit last year?





Q7 How many individuals do you currently employ? For this question, an employee is someone who works at least 35 hours a week.





Q8 Have you added or reduced staff in the last 12 months?





Q9 What barriers are you experiencing as you establish a compliant cannabis business? Please select all that apply.







Q11 What impact, if any, has the COVID-19 pandemic had on your business? Please describe in the comment box below.



















Q24 Have you applied for a City loan or grant through Elevate Impact Oakland?






