

Mari Go Round maintains their own in-house Seed and Clone to Sale products, and utilizes several Cloning and Nurseries to stock consistent and stable clones and seeds.
Again, Mari Go Round will subscribe to LeafLogix integrated with Metrc, which will be used to track cannabis product from Seed to Sale utilizing the compliant bar code registration as mandated by the State of California.
The facility will exceed the expectations of California Department of Public Health's (CDPH) and Medical Cannabis Safety (OMCS) regulations.

7. Odor Mitigation

DISPENSARY - AIR QUALITY AND ODOR CONTROL PROGRAM

The dispensary 's desire to be a good neighbor includes avoiding nuisances of odor that may be generated by its operations. Accordingly, The dispensary will be designed with the following Odor Control Plan with its HVAC Vendor to mitigate against such a nuisance:

- [1] The space will be conditioned using multiple split heat pump systems of various capacities and a ductless mini-split system. Each of the split-systems, excluding the ductless mini-split system, are equipment with unit-level pleated filters. Fresh air is brought to each of the ducted systems via a fresh air duct that is run to the exterior of the structure. Fresh air quantities are calculated using the American Society of Heating and Refrigeration Engineers (ASHRAE) Standard 62.1. This fresh air will tend to pressurize the space:
- [2] The space is designed for a negative pressure to contain internal odors. To accomplish this, an in-line, belt-driven exhaust fan is provided to remove the amount of fresh air provided for the occupants and an additional amount that will ensure a negative pressure within the space;
- [3] To prevent odors from escaping the structure, the in-line exhaust fan is equipped with a filter section loaded with 30 lbs of activated carbon, in a rack-mounted configuration. Activated carbon is an extremely effective absorptive odor control substance. An ozone generator will be placed upstream of the carbon filters, in the housing assembly. Ozone (O3) is an effective odor control mechanism. In this case, it is used to help control outgoing airstream odors and recharge the activated carbon filter media, extending the life of the media.;
- [4] Once systems are running, systems shall be air balanced to ensure design air flows for supply, fresh air, and exhaust air base values have been met. Once completed, a differential pressure gauge shall be used to ensure that a negative building static of no less than 0.05" of negative building static has been achieved. A maximum negative building static shall not exceed 0.15". An initial test with a trade-specific calibrated sensor establishes the a base-line of operation for odors in the out-going air stream.
- [5] Once odor control has been established, periodic testing shall be conducted to ensure that the odor control systems are operating to maintain the baseline. As the filters age, replacement will be required and will be conducted, as determined by the calibrated sensor on the test equipment.
- [6] Testing will be done, in the absence of other standards, in accordance with Standardized Odor Measurement Practices for Air Quality Testing. Testing shall be done using a field Olfactometer, calibrated in accordance with ASTM E544-75 and AWMA odor control standards, using the Scheduled Monitoring protocol:
- [7] Planned, scheduled monitoring on a daily walk-about visit around the exterior of the site, near the exhaust system. Data to be compiled and compared to established norms. Using a 5 point OIRS (Odor Intensity Reference Scale), compare daily readings. If values equal 3 on the 5 point scale, carbon-filtration exhaust system to be evaluated and repaired, as required. Evaluation shall include, but not be limited to, fan operation, distribution system integrity, and filter media effectiveness.

Mari Go Round Beautification Plan and Mission Statement

Social responsibility and good stewardship of our community are at the heart of the Mari Go Round's business model. Our vision for Excellence in Wellness includes partnering with our neighbors to build stronger, healthier populations. We seek to enhance the lives of our patients and members of our surrounding community by creating living-wage jobs, supporting beautification programs to improve public spaces, and supporting local nonprofit organizations through fundraising and volunteerism.

Mari Go Round's nuisance and crime prevention procedures will ensure we maintain a professional and discreet image for the dispensary, and positively impact our surrounding community through increased neighborhood security and beautification of the surrounding area.

Mari Go Round's Management will go beyond the mere mitigation and prevention of nuisance, by allocating resources to improve the neighborhood in which we are located. The exterior of the dispensary building will be regularly maintained and cleaned, and the facade will be tastefully designed to complement the aesthetics of the surrounding architectural design.

Mari Go Round will create a Public Art Program to beautify and enhance the dispensary location and adjacent social "intersections". Public Art Programs have been a tool for beautification and community development here in Oakland and throughout the country for decades.

The Beautification Program created by Mari Go Round will utilize public art as a community beautification activity, historically there has been only limited focus on this tool in the past decade in Oakland.

Looking forward, public art offers communities a possible cost-effective way to create lasting enhancement to their public spaces and can be a growing part of the Beautification program.

Additionally, we plan to give employees paid time off to volunteer in the community. Our community manager will organize monthly volunteer events and incentivize employees to participate. These events include participating in supporting and providing for the Homeless population in Oakland, Oakland's Adopt a Spot program, landscaping, and pick up litter/trash days.
