EXECUTIVE SUMMARY

Attachment A to this biannual report provides information on crime, crime trends, crime reduction and crime intervention activities in Oakland for January through May 2023.

BACKGROUND AND LEGISLATIVE HISTORY

In 2013, the Public Safety Committee requested a quarterly report from OPD on crime trends and crime reduction activities in the City of Oakland. This report was provided four times a year and updated to include the preceding three-month period. At the Rules Committee meeting on March 23, 2023, there was a motion made and approved to change the reports' frequency from quarterly to biannual.







Citywide Homicides – All Investigated Incidents 01 January to 31 May





- Homicides, shootings, robberies, and burglaries remain priorities of focus.
 - Measurable gang and group violence in West Oakland increased from Q1 into Q2. There is a continuation of preventative patrols and intelligence led patrol strategies, Ceasefire, Department of Violence Prevention, and OPD's Violent Crime Operations Center (VCOC) to address these issues.
 - Robbery in Police Beats 1 and 3 has declined in correlation with continued preventative patrols, collaborative community efforts, and focused enforcement and investigations. Although City-Wide, robberies are increasing including elsewhere in Area 1 due to numerous organized robbery crews that have formed. This is being addressed with VCOC operations targeting these groups.

Area 1- Captain Clay Burch

- Problem solving projects continued into Q2 2023 to address public safety issues and crimes committed in the violence concentrated gang areas. These projects emphasize prevention and conflict resolution through community partnerships.
- Homeless encampment numbers continue to rise and are being addressed collaboratively with the Encampment Management Team.



- Shootings and Robberies are a main focus for Police Area 2.
- As part of the 2023 crime plan, high visibility patrols and security checks will be focused on in the shopping districts (Valdez, Montclair, College, Temescal, Piedmont)
- Patrol teams are directed to focus on serious and violent crime incidents:
 - Thorough good preliminary investigations, video canvassing recovery, dissemination, partnering with VCOC, and working with DVP and Ceasefire strategies.
 - Area 2 robberies have increased due to numerous organized robbery crews that have formed. This is being addressed with VCOC operations targeting these groups.
 - In order to supplement the efforts to the CRO teams, the Area 2 Captain will be working with BID leaders and utilizing patrol overlaps to create directed patrols for high visibility and to deter crime.



Area 3- Captain Alan Yu

- Our focus is to safely reduce gun related violence, robberies, and human trafficking through collaborative efforts with the Department of Violence Prevention, Department of Transportation, Vice Crimes Unit, United States Marshals and FBI Task Force, and the Community to conduct intelligence-based policing.
 - Homicides reduced by 50 percent from 8 to 4.
- The Community Resource Officers (CRO) conducted an extensive investigation
 with community assistance targeting dozens of illegal gambling shacks in the
 area associated with multiple shootings. Search warrants were served at each
 location netting multiple arrests, the seizure of dozens of firearms and the
 closure of the businesses.
- From January to May 2023, The VICE unit completed 15 Human Trafficking and Child Exploitation operations. The majority of the operations were held along the International Corridor.
 - Partnering with DOT, temporary traffic barricades were placed at the E15th corridors effectively moving the prostitution out of the residential neighborhood in front of churches and schools.



Area 4 Homicides – All Investigated Incidents 01 January to 31 May



Part 1 crimes for Q1 from 2022 to 2023: The largest increases and decreases:

- Sexual Assault 75% increase from 2022.
- Homicides 62% decrease from 2022.
- Violent Crime Index overall 11% increase from 2022.

In response, Area 4 staff deployed the following measures in an attempt to continue to reduce this rise in violence:

- Continued Data intelligence to identify possible groups or gangs escalating violence.
- Continued partnership with DVP (Department of Violence Prevention) who assist with reaching out to involved parties to prevent further violence.

- Worked closely with the VCOC and Ceasefire which will continue to focus on individuals driving the increase in robberies and violent assaults.
- Prioritized Ceasefire strategies and referrals with requests for outreach and prevention.
- Conduct weekly meetings with all stakeholders, law enforcement partners and city leaders to include Councilmember's Jenkins and Gallo.
- Reviewed ShotSpotter activity while gathering intelligence and deploying available resources to those areas.

- When possible, run overtime details such as robbery and Violence Suppression Units to focus on identified locations with increased robberies and aggravated assaults.
- Continue to enforce thorough preliminary investigations (Patrol Officers) while working with our Criminal Investigations Division on follow-up request.
- Work closely with the Special Victims Unit to ensure sexual assault investigations are investigated to the fullest extent possible and make arrests when necessary.



The largest and only increases were the following:

- Homicide with a 38% increase.
- •Assault with a firearm With a17% increase
- Rape with a 50% increase.
- Auto Burglary with a 7% increase.
- Motor Vehicle Theft with a 19% increase.

The largest decreases were as follows:

- Robbery with an 8% decrease.
- Residential Burglary with a 47% decrease.
- Commercial Burglary with a 5% decrease.

- In response, Area 5 staff deployed the **following measures** to continue to reduce the increase in homicides:
- Continued intelligence briefings to identify possible groups or gangs escalating violence.
- Continued Patrol briefings to ensure all stakeholders have timely and relevant information of the conflicts driving the violence in Area 5.
- Reviewed ShotSpotter activity while gathering intelligence and deploying available resources to those areas.
- Continued Violence Suppression operations that are laser focused on groups, gangs, and/or areas of known violence.
- Proactive collaboration with DVP (Department of Violence Prevention) who assists with reaching out to involved parties to prevent further violence.

Police Area 5 – Capt. Kevin Kaney, cont.

- Worked closely with the VCOC and Ceasefire which will continue to focus on individuals driving the violence.
- Conduct weekly meeting with all stakeholders, law enforcement partners and city leaders to include local Councilmember's.
- Prioritized Ceasefire strategies and referrals with requests for outreach and prevention.
- Ensure quality preliminary investigations are being completed in the field and in partnership with CID (Criminal Investigations Division).
- Developed a plan to increase and fund the Cannabis Regulation unit to help decrease cannabis burglaries which led to increased burglaries in Area 5.



Part 1 crimes for YTD for 2023: The two largest increases:

- Aggravated Assaults are up by 1% but are still down by 11% compared to the three-year average.
- Homicides are up by 71% compared to 2022.
- Auto Burglaries are down by 26%.

In response, Area 6 staff deployed the **following measures** in an attempt to continue to reduce this rise in violence:

- Continued Data intelligence to identify possible groups or gangs escalating violence
- Worked closely with the VCOC and Ceasefire which will continue to focus on individuals driving the violence.
- Prioritized Ceasefire strategies and referrals with requests for outreach and prevention.
- Increased partnership with DVP (Department of Violence Prevention) who assist with reaching out to involved parties to prevent further violence.

- Conduct weekly meetings with all stakeholders, law enforcement partners and city leaders, including Councilmember's Reid office.
- Work with local merchants and stakeholders to conduct CPTED evaluations for long term burglary mitigation solutions.
- Run overtime details such as ShotSpotter and Violence Suppression Units to focus on identified locations with increased firearm-related aggravated assaults.

- Reviewed ShotSpotter activity while gathering intelligence and deploying available resources to those areas.
- Continue to enforce thorough preliminary investigations (Patrol Officers) while working with our Criminal Investigations Division on follow-up request.
- Run anti-burglary operations focused on Beat 31 where over three out of four (3/4) of all burglaries occur.

Ceasefire – Captain Trevelyon Jones

- Ceasefire has hosted two (2) call-In meetings in 2023.
- Ceasefire has engaged with 145 individuals at highest risk for violence, in direct communication and offered services:
 - 107 custom notifications
 - 38 individuals at call-ins.
- There have been 14 community engagement events. 9 with partners.
- Call-ins are planned for June, August, and November 2023.




