I. STATE GRANT FUNDING

The City of Oakland received three state grants in 2020-2021 to support its cannabis equity program: in the spring of 2020 the City received a grant of approximately \$1,650,000 from the Bureau of Cannabis Control (BCC); in the summer of 2020 the City received a \$6,576,705 grant from the Governor's Office of Business and Economic Development (Go-Biz) (Go-Biz 1 Grant); then in the summer of 2021 the City received a \$2,434,712.51 from Go-Biz (Go-Biz 2 Grant). The City has disbursed all of the BCC grants funds and all but approximately \$200,000 of the Go-Biz 1 and Go-Biz 2 grants, which consist of second installments of workforce development and shared-use manufacturing grants.

In April 2022 the City of Oakland received a three-year \$9,905,020 Local Jurisdiction Assistance Grant from the Department of Cannabis Control (DCC) to support the transition of cannabis operators from a provisional to an annual state license. In June 2022 the City received the latest one-year grant from Go-Biz to support the City's Equity Program in an amount of \$5,435,140.82 (Go-Biz 3). Finally, this spring the City Council approved adjustments to a three-year grant from the Board of State and Community Corrections (BSCC) to address the impacts of cannabis legalization. Staff is now beginning to disburse these funds as outlined in **Figures 1-3** month and will provide status updates moving forward.

Additionally, in July staff released a <u>Request for Proposals</u> (RFP) for funds for events for cannabis equity applicants, shared-use manufacturing technical assistance, security measures for provisional licensees, and the cannabis equity property purchase program. The deadline for RFP responses is Monday October 3rd.

Also, in August staff increased the grant funding available to equity applicants to match the amounts available through the loan program and introduced additional specialty grant programs. A. Updates on City's Grant Program

a. To date the City has provided \$2,896,000 in funding for 88 grants to 50 unique grantees for an average of \$57,926 per grantee. In addition, the City has received grant requests totaling a potential of \$2.2 million in additional new grant funding once underwriting and closing is complete.

a. To date, the City has lent \$4,398,239 to fund 110 loans provided to 64 unique borrowers for an average of \$68,722 per borrower. In addition, the City has received 20 requests totaling a potential of \$870,000 in additional new loan funding once underwriting and closing is complete.

- b. Below is a summary of the Specialty Grants that are now available"
 - <u>Get Your Annual State License Grant</u>: In 2022, the Department of Cannabis Control provided the City of Oakland with Local Jurisdiction Grant funding to help transition cannabis operators from a provisional to an annual state license. To help Verified Equity Applicants obtain their annual state license, the City of Oakland offers a \$15,000 "Get Your Annual State License Grant".  - <u>Rental Assistance Grant</u>: To support equity businesses impacted by the transition from incubation to commercial leases, the City of Oakland and Elevate Impact have launched a Rental Assistance Program to provide an additional source of funds to help impacted businesses to continue to grow

and thrive. Specifically, the Rental Assistance Grant Program provides up to \$15,000 in grant funds to Verified Equity Applicants that demonstrate they have matching cash funds available for rent. If an applicant has \$5,000 in matching cash funds, they may apply for \$5,000 in a rental assistance grant. For more information please visit:

• <u>Emergency Grant:</u> To support equity businesses impacted by burglaries in the years 2021 and 2022, City of Oakland and Elevate Impact have launched an Emergency Grant Program that minimizes barriers and provides an additional source of funds to help impacted businesses rebuild and re-open. Specifically, the Emergency Grant Program provides \$15,000 in grant funds to Verified Equity Applicants with a business lease that demonstrate their business was burglarized in Oakland during the calendar years 2021 and 2022. - <u>Education Grant</u>: To provide additional funding to Oakland Verified Equity Applicants, the City of Oakland offers an "Education Grant" in collaboration with Oaksterdam University and Elevate Impact Oakland. Grant funds will be provided to Oakland Verified Equity Applicants who received a certificate of completion from one of Oaksterdam's Certification Programs, either selfpaced or in the live cohort model. The Education Grant is available as follows:
 - i. \$5,000 to Oakland Verified Equity Applicants who have a City of Oakland cannabis permit and a current business lease.
 - ii. \$1,000 to Oakland Verified Equity Applicants who have a City of Oakland business license, but have not been issued a City of Oakland cannabis permit and/or do not have a lease.

V. NEW DISBURSEMENT COURSE REQUIREMENT – THE GRASS ELECTIVE

In July of 2022, the City of Oakland introduced a new educational requirement to the underwriting process. Each loan or grant disbursement will now require all Verified Equity Applicants to take an elective course or webinar offered by Oaksterdam

University called "Gaining Resources to Achieve Sustainable Success ("GRASS") Electives. The GRASS Elective course or webinar is provided free to Oakland Equity Applicants.

VI. NEW FINANCIAL PREREQUISITE COURSE

The prerequisite to any initial grant or loan is the New "City of Oakland Financial Literacy" elective.

Overview: Most cannabis ventures do not have access to the types of debt financing other businesses rely on because cannabis is classified as a Schedule I drug at the federal level. Cannabis businesses must rely primarily on private equity financing. In this course, we examine the difference between debt and equity financing and explore the process of raising equity capital to launch or expand a business. We will also identify the key factors investors tend to consider when they vet an investment opportunity and outline best practices for pitching the idea to potential backers.

- Financial Metrics for Fundraisers
- Types of Financing Debt vs. Equity
- Equity Financing
