1. The proposed project is a mixed use facility located at 2044 Franklin Street (APN 008-0651-018-01). The site is currently a 2 story office building and surface parking lot. The proposal is to demolish the existing building and construct a new mixed use facility consisting of two structures: Building 1, a 353 foot high 29 story tower with a 77 foot high 6 story podium, and Building 2, a 40 foot high 3 story low rise building. The proposed uses include 184 residential units, approximately 57,000 square feet of office and 5,000 square feet of commercial at the ground floor. 2. The proposed project is an office tower located at 325-22nd Street (APNs 008-0653-008-00, 008-0653-009-00, and 008-0653-015-01). The proposal includes two options, one at 400,000 square feet and the other at 800,000 square feet. Both options include office above-ground floor office and commercial uses, parking, and ground-floor active uses. The project site is currently occupied by surface parking. Nearby uses of note include the Ordway Building, the Cathedral of Christ the Light, and the Kaiser Rooftop Garden. The project was reviewed by the Design Review Committee on February 22, 2017 and is now revised to respond to comments received at that time.
