Brief History of Oakland Slow Streets

OakDOT launched **Oakland Slow Streets** on April 10, 2020 in response to COVID-19 Shelter-In-Place Orders, need for physical distancing while walking, biking, wheelchair rolling

- Generally positive response in social media, local and national media
- Concerns from some communities including East Oakland regarding:
 - lack of engagement before roll out
 - cookie cutter approach to different local transportation behaviors, street conditions
- OakDOT desire to capture feedback, and prioritize streets for implementation



Over 300 responses and growing – East Oakland Under-Represented



- 44% of respondents came from the three North Oakland Zip Codes (94609, 94608, 94618) where approximately 16% of the Oakland population resides.
- Only 22% of respondents reside in East Oakland where approximately 47% of the Oakland population resides.

Respondents more likely to be White and Higher Income

- 66% of respondents identified as White alone compared to 36% of Oakland's population.
- Only 9% of respondents identified as Black or African American alone compared to 36% of Oakland's population.



- 43% of respondents marked their household income as \$150,000 or higher compared to approximately 20% of Oakland's population.
- Conversely, 10% of respondents marked their household income as under \$50,000 compared to 39% of Oakland's population.






- 78% of respondents overall support Oakland Slow Streets
- 75% of East Oakland respondents support Oakland Slow Streets



Respondents Largely Understand the Intent, Design of the Program


"The Oakland Slow Streets program is supporting **safe physical activity** by creating more **space for physical distancing** for all Oaklanders by declaring some streets Closed to Through Traffic so that people can more comfortably use these low-traffic streets for physically distant walking, wheelchair rolling, jogging, and biking all across the City. **Residents of these streets, emergency vehicles, waste collection, and delivery vehicles can still access these streets.**"



• 90% of respondents understand the intent and design of the program



Respondents Reported More Speeding and More People Using the Roadway For Physical Distancing During Shelter In Place





- 53% of respondents report observing more drivers speeding under Shelter-In-Place
- 65% of respondents report observing people using the roadway to maintain physical distancing

Slowing Speeding Traffic a Key Transportation Concern, particularly in East Oakland

Oakland Slow Streets Next Steps

- **Expansion of Slow Streets** in response to positive community feedback 5/1 and 5/8 installations
- Continued engagement with community stakeholders including in East Oakland and vulnerable communities re: transportation safety concerns and needs particularly during COVID-19
- Greater outreach to residents to complete survey
- Continued analysis of survey responses regarding how the program can be responsive to local needs (e.g., smaller area installations)
- Evolution of Oakland Slow Streets program to respond to community needs during COVID-19 public health emergency
