We, the undersigned, are residents and/or business owners of the proposed Residential Permit Parking Area described in this petition. We understand that, if this area is designated as a Residential Permit Parking Area, certain restriction will be placed upon on-street parking within the designated area; that subject to the regulations and restrictions established by the City Council, visitors will be eligible to obtain permits exempting them from such parking restrictions; that the annual fee for a Residential Parking Permit shall be in accordance with the Master Fee Schedule, currently at \$82 per residential vehicle; that a Residential Parking Permit may be issued to a resident of the same address, but no more than **three** Residential Parking Permits shall be issued to any one address, except in areas where the number of permits issued would exceed the number of legal on-street parking spaces where the initial sale would be limited to two or possibly one permit per resident; that no more than one Residential Parking Permit shall be issued to each motor vehicle owned or leased for which an application is made; that fees for one-day and 14-day Visitor Parking Permits shall be in accordance with the Master Fee Schedule, currently at \$5.00 and \$25.00 per vehicle, respectively; but that no more than five 1-day or two 14-day Visitor Parking Permits per any one address shall be issued at any one time. We, the undersigned, hereby request that the City Council consider this petition for establishment of the above-described area as a Residential Permit Parking Area.

Upon return of the completed petition, OakDOT Parking & Mobility staff will evaluate the petition, hold neighborhood hearing(s), and make a recommendation to the City Council in accordance with Ordinance No. 10689 C. M. S. of the Oakland Traffic Code.
