A. Roll Call and Determination of Quorum

B. Open Forum / Public Comment

Speaker expressed interest in how cannabis tax revenues will be used by the City of Oakland.

Member Parker made motion to accept the draft minutes; Member Knox seconded the motion and it was approved by consensus.

 - 1. Oakland Police Department Report on 2016 arrests and citations for cannabis offenses.

Deputy Chief Leronne Armstrong provided a summary of the 2016 report and current OPD practices to reduce disparities in stops and arrests overall and with respect to cannabis.

Chair Hummel expressed frustration over continued disparities in cannabis arrests and asked what commission can do to address this. Other members asked follow up questions of OPD.

Member Parker made a motion for additional 2016 data regarding age of those cited/arrested for cannabis, number of cannabis citations/arrests at Oakland Airport, cannabis DUIs, arrests public intoxication for alcohol, enforcement for unpermitted vending, breakdown of public vs. private property cannabis arrests, and additional details on cultivation arrests.

Member Yi seconded the motion and it was adopted by consensus.

Staff provided an update.

3. Update on implementation of adult recreational use due to the passage of Prop 64.

Staff provided an update and offered to present a draft of proposed legislation at next CRC meeting. Member Parker made a motion for staff to present draft adult use legislation at October meeting. Member Knox seconded the motion and it was adopted by consensus.
