#### 1. Call to Order

The meeting was called to order at 6:18pm.

#### 2. Open Forum

#### 3. Adoption of Prior Meeting Minutes of April 17, 2019

Langston Buddenhagen made a motion to adopt the prior meeting minutes of April 17<sup>th.</sup> Julie Tinker Ward seconded the motion. Betty Booker made a request to revise the minutes to add her name to the list of absent POC members. All POC members moved to adopt the minutes.

#### 4. Report out and Approval of Ad-Hoc Appeals Subcommittee Report of Findings

Staff described the actions taken by the POC Ad-Hoc Appeals Subcommittee on May 15, 2019 upon receiving appeals from applicants who did not receive funding recommendations from hem for FY2019-2020 grant awards. Based on one or more of three total criteria, the Subcommittee determined the nine appellants did not have sufficient grounds for successful appeals of their respective applications and thus were denied. Julie Tinker Ward made a motion to accept the Ad-Hoc Appeals Subcommittee report of findings and decision. Langston Buddenhagen seconded the motion. All POC members moved to approve the findings report.

 Requesting the POC to Consider Forwarding to the Council Additional Grant Recommendations Based on the Finance Department's Projected Kids First True-up for FY2018-2019

Staff described the actions taken by the Life Enrichment Committee on June 11, 2019 on FY2019-2020 grant funding recommendations and the additional grant recommendations from the Finance Department's FY2018-2019 projected true-up. The LEC approved the POC funding recommendations for 137 grant awards totaling \$17,989,162 and forwarded the item for review and approval by the full Council on June 18 consent calendar to bring the total FY2019-20 grants to \$19,514,722. The LEC also requested that OFCY and the POC consider additional funding for already established programs that focus on homicide and violence prevention and that plan to work with community members to reduce the rates of these issues. Additionally, programs addressing underserved communities such as LGBTQ and refugees were requested to be considered for funding. The estimated true-up of \$1.24 million for FY2018-19 for OFCY was identified in the Finance Department's FY2018-2019 Quarter 3 Revenue and Expenditures Report. This adjustment will be adopted in the City's Mid-Cycle Budget and available to spend on July 1, 2020. City Council also requested that the Human Services Department return to LEC in September with the POC's updated funding recommendations. Staff requested that the POC consider approving additional grant recommendations.

The POC determined that it would establish a process to allocate the additional funds based on the existing work and uphold the process that was established by the POC through the OFCY 2019-2022 RFP review and selection process. Through the RFP review and selection process, the POC and POC Review subcommittee established a "parking lot" for consideration of programs that were ranked low in the funding strategy, but could be recommended based on equity considerations, past performance, and strategic alignment.

Langston Buddenhagen made a motion to request the Finance Department to provide the calculation for the 3% annual revenues of Kids First from the General Purpose Fund for FY2019-2020 and FY2020-2021. Julie Tinker Ward seconded the motion. All POC members moved to approve the motion. The POC determined to use the "parking lot" to review programs that have previously been identified, and overlay that work with the direction and priorities of City Council as presented at the June 11th 2019 LEC meeting, and also consider the public input that they have received from their public meetings to come to funding recommendations at their

#### **Executive Summary**

In June, City Council approved OFCY funding recommendations for FY2019-2020, identified additional funding available for OFCY in FY2020-2021, and directed staff to provide funding consideration for additional programs based on the increased funding.

The Planning and Oversight Committee (POC) met the following week to receive a staff update regarding the City Council direction. The POC agreed to allocate additional annual funding of approximately \$300,000 to \$400,000 to support additional grants for one (1) to three (3) programs, and determined that it would review the programs identified for funding consideration through the OFCY 2019-2022 RFP review and selection process as part of the decision-making.

Staff is providing the "parking lot" of programs that were identified during the review process as deserving consideration for grant awards if additional funding was available, as well as the review spreadsheets for the funding strategies for programs identified by City Council for consideration or included in the "parking lot".

#### **Background**

#### LEC Meeting (06/11/2019)

On June 11, 2019, the Oakland City Council Life Enrichment Committee (LEC) approved the Planning and Oversight Committee's recommendation 137 grant awards totaling \$17,989,162 in annual funding. Combined with the prior approval of summer 2019 grant awards, OFCY annual grants total \$19,514,772 for 149 awards.

In addition, the LEC requested that the City Administration confirm a pending revenue adjustments for FY2018-2019, and that the Planning and Oversight Committee consider recommendations for additional grant awards from the OFCY 2019-2022 Request for Proposals (RFP) due to the additional funding.

The committee requested that OFCY consider the programs that:

- Address homicide and violence prevention;
- Address LGBT families;
- Are already established and have momentum, and would leverage other resources;
   and

 Underserved communities that are neighborhood or ethnic specific who may not have had as much representation through the OFCY grant recommendations, specifically Asian refugee communities.

Specific programs mentioned by the LEC:

- Youth ALIVE!
- Our Family Coalition
- Center for Refugees and Immigrants
- Lotus Bloom
- Youth Beat

The Committee directed staff to return to the Life Enrichment Committee in September 2019 with a new report that identifies POC additional funding recommendations based on considerations identified by LEC.

#### POC Meeting (June 19, 2019)

Staff confirmed that the City Administration has identified approximately \$1.24 million in potential additional funding available to OFCY through the FY2018-2019 true-up, pending approval in the next Mid-Cycle Budget review with funding available next fiscal year (FY2020-2021). In order to sustain OFCY grant awards in year three of the grant cycle (FY2021-2022) in the amounts approved for FY2019-2020, staff indicated the POC would need to allocate additional annual funding not to exceed \$300,000 to \$400,000 in total to support additional grants for one (1) to three (3) programs.

The POC determined that it would do the following:

- Establish a process to allocate the additional funds based on the existing work, and uphold the process that was established by the POC through the OFCY 2019-2022 RFP review and selection process.
- Use the "parking lot" established by the Review Sub-committee to review programs that
  have previously been identified, and overlay that work with the direction and priorities of
  City Council as presented at the June 11<sup>th</sup> 2019 LEC meeting
- Consider the input that they have received from their public meetings to come to funding recommendations at their next meeting on July 17, 2019.
- The POC was advised to review the KTOP video of the June 11<sup>th</sup> 2019 LEC meeting to hear first-hand the direction of Council and the public input provided, to inform their decision regarding additional grant awards.

#### City Council Meeting (June 24, 2019)

The City of Oakland FY2019-2021 Adopted Budget provides \$150,000 to the Center for Empowering Refugees and Immigrants in FY2019-2020, and \$200,000 each year to Our Family Coalition in FY2019-2020 and FY2020-2021.

#### <u>"Parking Lot"</u>

During the course of the review process, the subcommittee developed a "parking lot" for programs that were ranked low relative to other applications in the funding strategy and funds available, but would be considered for potential inclusion into the funding recommendation made to the POC. The "parking lot" consisted of 15 programs, the majority of which were in the Youth Development and Leadership funding strategy (See Attachment #1).

Eight of the programs in the "parking lot" ultimately were included in the funding recommendation presented to the POC and approved at their meeting on April 17 2019, while seven program were not included. Three of the five programs identified by City Council at the June 11 LEC meeting are in the 'parking lot'.

Additional programs and agencies not listed above also attended public meetings of the POC to request funding support. Based on the POC direction at the June 19, 2019 meeting, consideration for these additional programs may be discussed for potential funding as part of the review and recommendation for these additional grant awards.

#### **Staff Recommendation for POC Action**

The POC should consider approving additional grant recommendations for approximately \$300,000-\$400,000 in total funding.

**Re:** Appeals Process for Applicants Not Recommended for Funding

#### **Executive Summary**

OFCY issues a Request for Proposal (RFP) to solicit applications to fund programs through an open and fair application process. Any applicant may appeal the POC's funding recommendations to an Appeals subcommittee. For the 2019-2022, OFCY received and reviewed 243 qualified applications, and ultimately made funding recommendations for 149 applications. Out of the 94 applications that did not receive a funding recommendation, nine submitted appeals. The POC determined that none had valid grounds and denied the appeals.

OFCY staff seeks POC guidance and input to improve the funding appeals process for improvements for future open and fair funding solicitations.

#### **Background**

OFCY's RFP for 2019-2022 provided an appeals process for applicants that did not receive a funding recommendation. The RFP stated that any applicant may appeal the POC's funding recommendations to an Appeals subcommittee, and that an appeal must be based on one or more of three criteria:

<b>Unfair process</b> (e.g., the appellant's proposal was treated differently than others)
Material error (e.g., the appellant's proposal was reviewed under the wrong funding
strategy or some other mistake of fact occurred), or
Conflict of interest potentially leading to financial gain by a POC member or reviewer
or members of these individuals' immediate families.

Instructions stated that the appeals should clearly state the issue that negatively affected the review of the proposal as related to the criteria above.

Appeals instructions noted that substantive disagreement with the funding recommendations is not grounds for appeal, and that no appeals would be accepted that challenge the review process as a whole. In addition, the appellants were requested not to submit any new or updated information about their proposal in their appeal. The appeal process was to determine if there was an unfair process, material error, or conflict of interest, and was not established to reconsider the funding decisions or the relative merit of applicants.

An ad-hoc POC Appeals subcommittee was formed to receive the written appeals, hear directly from appellants, and receive a staff response. The committee met on May 15<sup>th</sup>, 2019 at Oakland City Hall. Three appellants attended the meeting to provide an oral summation to the subcommittee in support of their written appeal. After completion of the oral presentation, OFCY staff provided their response to the appeal. Subsequently, after a closed-door session, the Ad-Hoc Appeals Subcommittee made their determination as to the validity of the appeals. The Appeals subcommittee found that none of the appellants had grounds for appeals based on the criteria established and included in the RFP.

Out of the nine appeals, five were based on a perceived **material error** in the calculations for hours of service presented to POC, and were found to be unfounded. The remaining four appeals were based submitted based on an **unfair process** alone or with other and **conflict of interest** and **material error** issues identified. These appeals were determined by the POC Appeals committee to ultimately be based on a **substantive disagreement** with the funding decision.

#### **Staff Recommendation**

In order to improve the appeals process to be more effective in meeting POC and community needs, staff recommends a revision to the criteria that forms the basis for an allowable appeal. POC direction and input will be used to shape and improve the process in advance of the next OFCY funding solicitation of children and youth programming.

### **Appeals Process for Applicants Not Recommended**

The appellant must clearly state the facts that establish one of these bases for appeal and how, as a result, the appellant's proposal was affected negatively. *A substantive disagreement with the funding recommendations is not grounds for appeal.* 

The deadline for filing an appeal is two weeks after the list of recommended programs is approved by the POC at their public meeting. Written appeals shall be hand delivered to the Manager of Children and Youth Services Division at the following address:

Appellants will receive written notice of the outcome of their appeal. In the event of one or more successful appeals, the POC will submit the successful appeal(s) as funding recommendations to the Oakland City Council, which has the authority to accept or reject the entire package.

### **Appeals Instructions**

Please follow the instructions below to submit an appeal regarding the 2019-2022 OFCY funding recommendation for your application. Appeals must be submitted on the two page form below and must be in 12-point font with 1-inch margins. Appeals must be based on one or more of the criteria described below and should clearly state the issue that negatively affected the review of the proposal.

**Unfair process** (e.g., the appellant's proposal was treated differently than others)

**Material error** (e.g., the appellant's proposal was reviewed under the wrong funding category or based on some other objective error occurred), or

**Conflict of interest** potentially leading to financial gain by a POC member or reviewer or members of these individuals' immediate families.

Please note that substantive disagreement with the funding recommendations is not grounds for appeal. No appeals will be accepted that challenge the review process as a whole. Appellants also cannot submit any new or updated information about the proposal.

Appellants will receive written notice of the outcome of their appeal. In the event of one or more successful appeals, the POC may amend the funding recommendations and submit final revised funding recommendations to the Oakland City Council, which has the authority to accept or reject the entire package.

The Planning and Oversight Committee will form an ad-hoc Appeals subcommittee to receive and review appeals. The subcommittee will review and determine the validity of the appeals received and provide an update at the next public POC meeting in May 2019.
