BICYCLIST & PEDESTRIAN ADVISORY COMMISSION

Oakland's Bicyclist & Pedestrian Advisory Commission (BPAC) was established in 2014 to advise the City Council on plans, policies, projects, and programs that affect walking and bicycling. In September 2014, the Commission replaced the Bicycle & Pedestrian Advisory Committee, a body formed by the Public Works Department that had met monthly since 1994.

Oakland residents interested in serving on the Commission are encouraged to apply by mid-September this year. The nine-member commission has staggered terms such that three commissioners' terms end December 31 of each year. The BPAC reviews applications and makes recommendations to the Mayor. The Mayor proposes candidates that must be confirmed by City Council, with new terms and commissioners starting each January.

Commissioners must take the Oath of Office and submit Conflict of Interest Filings (Form 700) at the time of assuming office, annually by April 1, and within 30 days of separation from this body. Commissioners cannot serve more than 6 years.

CANNABIS REGULATORY COMMISSION

On November 2, 2004, the Oakland electorate passed ballot Measure Z, a voter initiative entitled <code>Oakland Cannabis Regulation</code> and Revenue Ordinance. The ordinance requires the City of Oakland (1) Make investigation, citation and arrest for private adult cannabis (marijuana) offenses the City's lowest law enforcement priority; (2) Advocate through its lobbyist and City officers for changes in state and other laws to (a) allow and authorize taxation and regulation of cannabis (marijuana) for adults and eliminate criminal penalties for private, adult cannabis use, (b) grant local control to cities and counties to license and regulate cannabis businesses and collect appropriate fees and taxes, and (c) end the prosecution arrest, investigation and imprisonment for adult private cannabis offenses; (3) Establish a system to license, tax and regulate cannabis (marijuana) sales if California law is amended to allow and authorize such actions; and (4) Create a committee to oversee the ordinance implementation and disbursement of revenue from licensing and taxation of businesses that sell cannabis.

Each Council member shall appoint a community member. The committee shall also include a representative of the City Administrator and City Auditor. Members shall be appointed to a term of two years, and said terms shall commence upon the first day of August 2005, except that an appointment to fill a vacancy shall be for the unexpired term only. Members may be re-appointed to subsequent terms

CHILDREN'S INITIATIVE OVERSIGHT COMMISSION

The Oakland Children's Initiative (Measure AA) is a 2018 Charter Amendment passed by the citizens of Oakland to deepen our early investment in children and support them through college graduation, by dramatically expanding access to high quality preschool and providing college access, mentorship, and scholarship support services for students to obtain 4-year or 2-year college or technical degrees. It will leverage approximately \$30 million in annual revenue to dramatically expand access to and the quality of preschool, as well as significantly increase college enrollment and college graduation rates. Approximately $\frac{2}{3}$ of the funds raised by Measure AA will support early childhood education and approximately $\frac{1}{3}$ of the funds will support college access and persistence support.

The Measure establishes the Childrens' Initiative Oversight Commission to be appointed by the Mayor and confirmed by City Council to provide oversight, accountability, and analysis for the distribution of funds and execution of programming.

Membership Qualifications - the Oversight Commission shall include the following members

- 1. At least 1 member with professional expertise in early childhood education policy
- 2. At least 1 member with professional expertise in, or who is a provider of, early childhood care or education;
- 3. At least 1 member with at least 2 years of experience teaching in early childhood education;
- 4. At least 1 member with at least two 2 years of experience teaching TK-12, or who has professional expertise in TK-12 education or college access;
- 5. At least 1 member with professional expertise in college completion, college or university leadership, or support for traditionally underrepresented college students;
- At least 1 member with experience in budgeting, auditing, finance, or early asset building;
- 7. At least 1 member of a union or labor advocacy group who is employed by the City of Oakland Head Start, the Oakland Unified School District, or a participating early care and education provider;
- 8. At least 1 homeowner who is subject to the parcel tax imposed by Section 5 of the Act;
- 9. At least 1 parent, who presently has, or has had within 5 years from the time of appointment, a child of preschool age who attended a preschool program benefiting from public subsidy, or who was on a waitlist for such a program; and
- 10. At least 1 member who is, or who within 5 years from the time of appointment was, enrolled in an Oakland public school, or who has graduated from an Oakland public school and enrolled in college within 5 years from the time of appointment, or who is the first in their immediate family to graduate from College.

The Children's Initiative Oversight Commissions shall meet at least XX times per year.

CIVIL SERVICE BOARD

2.08.030 - Civil Service Board.

It shall be the function and duty of the Civil Service Board to enforce, through general supervision of the personnel system, the provisions of this chapter and of Article IX of the Charter; to study, investigate and research into such areas and matters as the City Administrator, or the Council through the City Administrator, or the Board of Port Commissioners, may request, or as it may deem advisable; to make reports and recommendations in writing thereon and to formulate policy recommendations or recommended changes to the Personnel Manual for the better realization of the objectives of the personnel system, as set forth in Section 900 of the Charter; to approve the exception of positions under Section 902(f) of the Charter; to perform the appellate duties and functions hereafter described; to review and approve changes to the Personnel Manual, excepting those which are administrative in nature, proposed by the City Administrator, provided that changes in which the Board does not concur may be made with the approval of Council; and to perform such other duties and functions as the City Administrator may for time to time request. The following special provisions shall apply to the Civil Service Board.

A. Composition. The Board shall consist of seven members who will be appointed pursuant to Section 601 of the Charter and who shall serve without compensation. Two members shall be appointed for a term of one year, two for two years, and three for four years, said terms to commence upon the date of appointment. Thereafter, each appointment shall be for a term of four years, except that an appointment to fill a vacancy shall be for the unexpired term only.

Section 901 of the Charter of the City of Oakland establishes the Civil Service Board as the body responsible for enforcement of the City spersonnel system as established by Article IX of the Charter, Personnel Administration. Ordinance 8979, Ordinance 11777 C.M.S., Ordinance 13120 C.M.S., and Section 2.02 of the Civil Service Rules describe the functions and duties of the Civil Service Board. The responsibilities of the Civil Service Board include enforcement of the Civil Service Rules; approval of the exemption of positions from the competitive service; approval of classification specifications and performing appellate duties as delineated in Ordinances 8979, 11777, 13120, the Civil Service Rules and the Personnel Rules and Procedures of the Port of Oakland.

COMMISSION ON HOMELESSNESS

The Commisison on Homelessness provides oversight of the Oakland vacant property tax (2018 Measure W1 and the 2020 Measure Q homelessness funds received by the City of Oakland for Homeless services, and makes recommendations to the City Council for strategies to remedy homelessness. The Commission shall review relevant financial and operational reports related to the expenditure of the homeless services fund. The Commission shall publish an annual report regarding how and to what extent the City Council and Mayor have implemented this Chapter. Additionally, the Commission shall be requested to publish reports regarding the following: 1) Recommendations from the Commission on how to prioritize the allocation of funds in accordance with the requirements of this Chapter, including for: services and programs for homeless people, reduction of homelessness, and supporting the provision of affordable housing to households qualifying as at least lowincome households (those at 55% AMI or belowl: 2) Information, if available, concerning the impacts of programs funded by the Vacant Property Tax (2018 Measure W1 and 2020 Measure O homelessness funds subject to Commission oversight this Ordinance on the occurrence of homelessness and illegal dumping outcomes in the City; 3) Recommendations to the Mayor and the City Council on the Biennial Fiscal Year Budget, in accordance with the City Council's Consolidated Fiscal Policy at the time, that ensures that the Commission Chair communicates homelessness priorities to the Mayor and Council: and 4) Review and respond annually to the City's Homeless Encampment Policy and the Permanent Access to Housing (Pathl Plan which shall be presented to the Commission, as well as hear reports on the housing, programs, and services for persons experiencing homelessness in the City including, but not limited to, street outreach, homeless shelters, transitional housing, housing exits, and permanent supportive housing as needed.

The City Council may assign other duties to the Csommission as provided for by ordinance.

The Homeless Advisory Commission is comprised as follows:

Consists of nine (9) members who are all residents of the City.

No less than half of the members must be residents of heavily impacted neighborhoods. No fewer than two (2) members must be currently homeless, formerly homeless or low-income, as the term "low income" is defined by the United States Department of Housing and Urban Development.

No fewer than three (3) members must have professional expertise in, or be providers of, homeless services or housing, with priority given to individuals with a background in affordable housing, shelter management, or public health.

No fewer than one (1) representative must have financial expertise.

Members may fulfill more than one (1) of these criteria for the purposes of meeting these requirements.

Commission Members, who are unpaid volunteers, should anticipate a significant time commitment for both meeting preparation and attendance.

OAKLAND WORKFORCE DEVELOPMENT BOARD

The Workforce Innovation and Opportunity Act of 2014 ("WIOA) replaced and superseded that Workforce Investment Act of 1998 ("WIA"). The Oakland Workforce Investment Board ("WIB") was created pursuant to WIA in 199. Section 107 of WIOA provides for the establishment of a new local workforce development board in each local workforce development area to replace the WIA workforce investment board in carrying out certain designated workforce development functions. Section 679.310(g) of the proposed WIOA regulations requires the chief local official of a local area to establish bylaws for the workforce development board consistent with state policy for board membership.

As mandated by the Workforce Innovation and Opportunity Act (WIOA), on March 31, 2016, by Executive Order, and as Chief Local Elected Official of the Local Area Designation (the City of Oakland), Mayor Libby Schaaf disbanded the former Workforce Investment Board (WIB) and established the new Workforce Development Board (WDB). The Oakland WDB oversees the federally-funded employment and training programs and services in Oakland. These programs and services help job seekers gain employment and connect businesses with a qualified workforce.

The Mayor appoints the board positions on the Oakland WDB. A majority of these positions are reserved for business-sector leaders. The Oakland WDB can have up to 27 members*. Generally speaking, the Mayor and the WDB share equal authority according to the federal legislation. The Oakland City Council authorizes the City Administrator to appropriate funding and enter into contracts with service providers.


