INFORMATION

The purpose of this memo is to advise the Mayor and City Council of the City's submission of project nominations in the Alameda County Transportation Commission (ACTC) the 2018 Comprehensive Investment Plan (CIP) Call for Projects on October 31, 2016.

The biennial CIP process allocates funding for two years (FY 17-18 and FY 18-19), and programs funding for another three fiscal years. (FY 19-20 to FY 21-22). For the 2018 CIP, ACTC is programming discretionary funding controlled by the agency, including ACTC Measure B, BB and Vehicle Registration Fund (VRF), as well as One Bay Area Grant (OBAG) and Transportation Fund for Clean Air (TFCA) funds.

Oakland submitted twenty-six projects for potential discretionary funding totaling more than \$200 million dollars. All projects were identified in the 2016 Alameda Countywide Transportation Plan as Oakland priorities, and are ready for funding during the period of the CIP. The projects submitted are listed in Attachment A. These projects include investments that would benefit all neighborhoods in Oakland, with a specific emphasis on equity and communities of concern. The projects range from transportation planning studies through design and construction of major infrastructure projects. All modes are represented, including pedestrian, bicycle, complete streets, transit, and goods movement projects.

At ACTC's request, projects were submitted in ranked priority order. Staff prioritized the projects based on an analysis of ACTC's official selection criteria, as well as a consideration of critical funding needs, equity, and readiness. It is important to note that while all phases of a project (through construction) are required to be submitted as a request, ACTC may commit only to the next phase (such as design). Staff expects actual funding commitments to be significantly less than the total submitted.

Transportation staff plans to present this submission in greater detail to Council in early December. Alameda CTC's 2018 CIP review process will proceed through early 2017 and 2018 Subject: 2018 ACTC Comprehensive Investment Plan

CIP programming and allocation recommendations will be considered by the Commission in late spring 2017.
