Emergency Shelter & Supportive Services for Young Adults Experiencing

Homelessness - Covenant House California (CHC) is a non-profit youth homeless shelter that provides sanctuary and support for homes and trafficked youth, ages 18-24. This includes access to additional supportive services, basic needs assistance (food, clothing, showers, referrals), case management, medical and mental health services, educational and employment assistance, and legal assistance.

Family Support Services for the Homeless Winter Relief Voucher Program - The Fremont FRC is a welcoming place where homeless individuals and households with safe and

Fremont FRC is a welcoming place where homeless individuals and households with safe and temporary housing, permanent housing, and wraparound support services. Winter Shelter program is seasonal every year from December to April.

Housing for Oakland's Homeless Veterans - Operation Dignity provides shelter, transitional housing, and supportive services to help veterans and their families escape the crisis of homelessness and regain stability. Veterans receive one-on-one case management to help them create a self-sufficiency plan and secure permanent housing.

Homeless Family Services - *FESCO* provides transitional housing and emergency shelter to low-income homeless families in Alameda County. Participants receive wraparound services including housing assistance, case management, life skills/parenting classes, employment training and job search assistance, mental health assessments, children's activities, and linkages to benefits and mainstream resources.

Senior Homeless Services - St. Mary's Center's Senior Homeless Services provide critical basic needs to low-income Oakland residents age 55+, including transitional shelter, health assessments, psychiatric care, an outpatient addiction recovery program, a daily meal, social stimulation, and permanent supportive housing.

Transitional Housing for Single Women and Moms with Children- Provides high-quality and safe housing services for single Moms with children and single women. A Diamond in the Ruff provides safe and affordable housing for women in need. Residents benefit from a range of services and on-the-job counselling, budgeting advice, and mentorship. It is dedicated to empowering women and helping them overcome their struggles.

Temporary Bridge Housing program - Helps single women and single mothers with transitional housing. The adjunct support services make for a holistic approach to recovery, giving residents the support they need to become free of addiction and/or abuse and become self-sufficient. It has recently received certification as a drug and alcohol treatment center.

Strong Housing Options program - Provide housing support to Oakland low-income and unhoused, extensive case management services, and create a pathway to prosperity for the target BLIPOC population. LFCD's program delivery strategy is founded on providing trauma-informed and intersecting needs services. Thus, the need for comprehensive integrated services design with triage and multi-disciplinary teams, trained internal and external trauma-informed direct services, and meeting clients' cultural challenges and sensitivities.

Love Never Fails was formed in December 2011 after the Founders' teenage dance student experienced human trafficking in the SF Bay Area. All are committed to the well-being of all youth and driven to restore education and protect them from sex trafficking.

Project R3 Return, Restore, and Rise - provides low-income, formerly incarcerated Oaklanders with reentry navigation support, including connection to employment and support to secure housing. It will conduct outreach and receive referrals of reentry clients, both pre- and post-release, from system partners and other community-based partners, and referrals to full case management to secure employment and housing.

Oakland Promise is available to young learners (from newborns to college students) and their families who reside in Oakland. OP offers every child the financial resources, educational programming, mentorship, and a supportive community to help them and their families to seek out and thrive in higher education and the career of their choosing.

Urban University is a 501c3 nonprofit working to improve the socioeconomic status of impoverished individuals by providing employability training, coaching and employment opportunities. Over the past 20 years, we've successfully delivered workforce development training and coaching services to prepare more than 1,600 low-income individuals for successful entry into the workforce.
