**CITY OF OAKLAND
RELEASE AND WAIVER OF LIABILITY
AND INDEMNITY AGREEMENT**

IN CONSIDERATION of being permitted to participate in *the above referenced activity/event* or to utilize the facilities, services and programs of the **CITY OF OAKLAND**, for any purpose, including, but not limited to, observation or use of facilities or equipment, or participation in any on-site or off-site program affiliated with the **CITY OF OAKLAND**, the undersigned participant and any parent or guardian of a minor participant, for himself/herself/themselves and such personal representatives, assigns, heirs, spouse or partner, and next of kin (hereinafter referred to as "PARTICIPANT"), hereby acknowledges, agrees and represents that he, she or they accepts any and all risks associated with the use of any **CITY OF OAKLAND** facility or equipment, or participation in any program affiliated with the **CITY OF OAKLAND**, including but not limited to travel risks and/or risks inherent in the intended activity.

IN FURTHER CONSIDERATION OF BEING PERMITTED TO PARTICIPATE OR ENTER THE PREMISES FOR ANY PURPOSE INCLUDING, BUT NOT LIMITED TO OBSERVATION OR USE OF FACILITIES OR EQUIPMENT, OR PARTICIPATION IN ANY ON-SITE OR OFF-SITE PROGRAM AFFILIATED WITH THE **CITY OF OAKLAND**, PARTICIPANT HEREBY AGREES TO THE FOLLOWING:

1. PARTICIPANT HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the **CITY OF OAKLAND**, its Councilmembers, directors, officers, agents, and employees (hereinafter referred to as "RELEASEES") from all liability to PARTICIPANT for any loss or damage, including all claims or liabilities arising from bodily injury, death, or damage to property of PARTICIPANT, whether caused by the negligence of the RELEASEES or otherwise while PARTICIPANT is/are in, upon, or about the premises or any facility of the **CITY OF OAKLAND**, or while using any equipment therein or participating in any program affiliated with the **CITY OF OAKLAND**.
2. PARTICIPANT HEREBY ELECTS TO VOLUNTARILY PARTICIPATE in said activity with full knowledge that said activity may be hazardous to PARTICIPANT and his/her/their person or property. PARTICIPANT voluntarily assumes full responsibility for all risks of loss, property or personal/bodily injury, including death, that may be sustained due to being engaged in such activity, whether caused by the negligence of RELEASEES or otherwise.
3. PARTICIPANT HEREBY AGREES TO INDEMNIFY, SAVE AND HOLD HARMLESS the RELEASEES, and each of them, from any loss, liability, damages or costs they may incur due to the presence of PARTICIPANT in, upon or about the **CITY OF OAKLAND** premises or in any way observing or using any facilities or equipment of the **CITY OF OAKLAND** or participating in any program affiliated with the **CITY OF OAKLAND** whether caused by the negligence of the RELEASEES or otherwise.
4. PARTICIPANT HEREBY ASSUMES FULL RESPONSIBILITY FOR, AND RISK OF, BODILY INJURY, DEATH OR PROPERTY DAMAGE to PARTICIPANT due to negligence of RELEASEES or otherwise while in, about or upon the premises of the **CITY OF OAKLAND** and/or while using the premises or any facilities or equipment thereon or participating in any program affiliated with **CITY OF OAKLAND**.
5. PARTICIPANT HEREBY WARRANTS, ACKNOWLEDGES AND AGREES that this **Release and Waiver of Liability and Indemnity Agreement** shall bind PARTICIPANT, including all parents and guardians of any minor participant, and, if PARTICIPANT is deceased, shall bind PARTICIPANT's heirs, assigns and personal representatives and shall be deemed a release, waiver, discharge and covenant not to sue the above named RELEASEES.
