### A. Call to Order/Recite AC-OCAP Promise

M. Rivera called the May 9, 2022, Administering Board Teleconference to order at 5:30 p.m. The AC-OCAP Promise was recited.

### B. Roll Call/Determination of Quorum/Approval of Agenda

Roll call was performed by staff M. Francisco. A quorum was established at 5:35 p.m.

### F. Presentation: Emile Durette, Alameda County Wealth Building Initiative

Emile Durette, Management Analyst with the Alameda County Social Services Agency, was introduced by A. Ford and welcomed by the Board. A PowerPoint Presentation titled *Alameda County Community Wealth Building Initiative* was displayed on the teleconference screen. The presentation began with the findings of the 2021 Alameda County System Modeling/Racial Equity Report, which established institutional and structural racism as the cause of low-income communities of color disproportionately affected by homelessness, poverty, academic underachievement, incarceration, and poor health outcomes. The Wealth Building Initiative is Alameda County's response to the report's findings and is a new approach to

economic development that will assist families in acquiring skills, social networks, a home, savings, and ownership stake in a business, so that they can endure unforeseen economic stressors, send their children to college, and plan for the future. Partners of the Initiative and the Community Wealth Building Model were discussed in detail. Next steps are to secure a \$265,000 planning grant, followed by implementing a five-year plan with the resulting deliverables: 535 households obtaining affordable housing, 4,000 transitional employment slots, 400 new worker-owners, and 350 apprenticeship trainees. The presentation concluded with a question-and-answer session.

## **G. CAP Updates (E. Clemons)**

E. Clemons announced her appointment to Interim Director of the City of Oakland's Human Services Department. E. Clemons introduced DesrayInn Cole, Program Manager, who will assist with the transition.

### **1. Board Updates**

#### **A. AC-OCAP Chairperson – Monique Rivera to succeed to the Office of Chairperson**

E. Clemons announced M. Rivera's succession to the Office of Chairperson, citing the following from the AC-OCAP Bylaws, "in the event the Office of Chairperson is vacated in mid-term, the Vice-Chairperson shall succeed to the Office of Chairperson" (AC-OCAP Bylaws, 2011).

#### **B. Interim Vice-Chairperson Election – Attachment G1B**

E. Clemons stated that proceeding with an election is at the discretion of the Chairperson, citing the following from AC-OCAP Bylaws, "unexpired terms of one year or less may be filled by appointment of the Board Chairperson" (AC-OCAP Bylaws, 2011). After a brief discussion among Board Members, it was determined that an election would not be held, and Chair M. Rivera appointed S. Johnson to Vice-Chairperson and B. Cook to Secretary.

#### **C. CDBG Oakland District 4, 7, and Alameda County Board Vacancies – Attachment G1C**

Njeri McGee-Tyner, Alameda County community representative resigned on April 15, 2022. Request letters for Oakland District 7 and Alameda County Community Representative were sent to their respective elected officials and included in the Agenda Packet. Guest Patricia Schader, known to staff and the Board, expressed interest in serving on the AC-OCAP as a representative of CDBG Oakland District 7.

#### **D. Private Sector Selection Process and Recommendations – Attachment G1D**

The bylaws require a new private sector selection to be made since Oakland Rotary did not respond to communications requesting a new representative. E. Clemons requested Agenda Item G1D be moved to the Executive Committee Agenda.

#### **E. Board Acknowledgements – AC-OCAP Scholarship Fund Discussion**

E. Clemons discussed a proposal to establish a scholarship fund in Mrs. Gladys Green's honor, which would be administered by Oakland Promise. E. Clemons requested Agenda Item G1E be moved to the Executive Committee Agenda.

### **2. AC-OCAP Programming**

#### **A. Community Service Block Grant (CSBG)/Community Aid, Relief, and Economic Security (CARES) and Program Update**

More Head Start families in need of housing and food assistance have received up to \$500 in gift cards, provided by 2021 CSBG funds. CARES funds continue to assist families directly and/or indirectly impacted by COVID-19. Staff J. Ellis reported that just \$100,000 of the \$1.8 million CARES funding remains to be distributed through UpTogether (previously Financial Independence Initiative (FII)). CARES funding is set to expire on May 31st, however AC-OCAP is in the process of securing an extension through August 31st. E. Clemons reported on the salary savings resulting from not hiring a planner, and the

Board will need to consider how to leverage and allocate the savings to other programs at a later date.

### **B. 2022 Earned Income Tax Credit (EITC) Outcomes**

EITC Outcomes will be shared at the next AC-OCAP Administering Board Teleconference.

### **C. California Department of Community Services & Development (CSD) Monitoring Site Visit (City of Oakland): Thursday, May 19, 2022**

As E. Clemons transitions into her new role, Staff D. Williams is the point person for the monitoring visit. The visit will include an examination of expenditure and programmatic transactions, as well as client questions from AC-OCAP grantee's Civicorps and St. Mary's Center.

### **D. 2023-2025 Request for Partnership (RFP) Process and Timeline – Attachment G2D**

Cindy King, Health & Human Services Program Planner, will oversee the RFP work moving forward. E. Clemons requested that the RFP timeline be reviewed by Board Members.

### **E. Update on HR 5129 – CSBG Modernization Act of 2021 (CSBG has not been reauthorized since 1998)**

On Friday, May 13, 2022 at 9:00 a.m. Eastern Standard Time, the U.S. House of Representatives will vote on the CSBG Modernization Act (HR 5129). The bill reauthorizes the CSBG Act for 10 years, adopts 200% of poverty as the income eligibility level for CSBG, establishes a federally administered Community Action Innovations Program, and strengthens tripartite boards through specified operations, duties and required expertise.

**ACTION ITEM:** CAP Staff to share NCAP email regarding CSBG Modernization Act.

**ADOPT A RESOLUTION DETERMINING THAT CONDUCTING IN-PERSON MEETINGS OF THE ALAMEDA COUNTY-OAKLAND COMMUNITY ACTION PARTNERSHIP (AC-OCAP) ADMINISTERING BOARD AND ITS COMMITTEES WOULD PRESENT IMMINENT RISKS TO ATTENDEES' HEALTH, AND ELECTING TO CONTINUE CONDUCTING MEETINGS USING TELECONFERENCING IN ACCORDANCE WITH CALIFORNIA GOVERNMENT CODE SECTION 54953(e), A PROVISION OF AB-361.**

**WHEREAS**, on March 4, 2020, Governor Gavin Newsom declared a state of emergency related to COVID-19, pursuant to Government Code Section 8625, and such declaration has not been lifted or rescinded. See <https://www.gov.ca.gov/wp-content/uploads/2020/03/3.4.20-Coronavirus-SOE-Proclamation.pdf>

**WHEREAS**, on March 9, 2020, the City Administrator in their capacity as the Director of the Emergency Operations Center (EOC), issued a proclamation of local emergency due to the spread of COVID-19 in Oakland, and on March 12, 2020, the City Council passed Resolution No. 88075 C.M.S. ratifying the proclamation of local emergency pursuant to Oakland Municipal Code (O.M.C.) section 8.50.050(C); and

**WHEREAS**, City Council Resolution No. 88075 remains in full force and effect to date; and

**WHEREAS**, the Centers for Disease Control (CDC) recommends physical distancing of at least six (6) feet whenever possible, avoiding crowds, and avoiding spaces that do not offer fresh air from the outdoors, particularly for people who are not fully vaccinated or who are at higher risk of getting very sick from COVID-19. See <https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/prevention.html>;

**WHEREAS**, the CDC recommends that people who live with unvaccinated people avoid activities that make physical distancing hard. See <https://www.cdc.gov/coronavirus/2019-ncov/your-health/about-covid-19/caring-for-children/families.html>;

**WHEREAS**, the CDC recommends that older adults limit in-person interactions as much as possible, particularly when indoors. See <https://www.cdc.gov/aging/covid19/covid19-older-adults.html>;

**WHEREAS**, the CDC, the California Department of Public Health, and the Alameda County Public Health Department all recommend that people experiencing COVID-19 symptoms stay home. See <https://www.cdc.gov/coronavirus/2019-ncov/if-you-are-sick/steps-when-sick.html>;

**WHEREAS**, persons without symptoms may be able to spread the COVID-19 virus. *See* <https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/prevention.html>;

**WHEREAS**, fully vaccinated persons who become infected with the COVID-19 Delta variant can spread the virus to others. *See* <https://www.cdc.gov/coronavirus/2019-ncov/vaccines/fully-vaccinated.html>;

**WHEREAS**, the City's public-meeting facilities are indoor facilities that do not designed to ensure circulation of fresh / outdoor air, particularly during periods of cold and/or rainy weather, and were not designed to ensure that attendees can remain six (6) feet apart; now therefore be it:

**WHEREAS**, holding in-person meetings would encourage community members to come to City facilities to participate in local government, and some of them would be at high risk of getting very sick from COVID-19 and/or would live with someone who is at high risk; and

**WHEREAS**, in-person meetings would tempt community members who are experiencing COVID-19 symptoms to leave their homes in order to come to City facilities and participate in local government; and

**WHEREAS**, attendees would use ride-share services and/or public transit to travel to in-person meetings, thereby putting them in close and prolonged contact with additional people outside of their households; and

**WHEREAS**, on \_\_\_\_\_, 202\_\_\_\_ the AC-OCAP Administering Board adopted a resolution determining that conducting in-person meetings would present imminent risks to attendees' health, and electing to continue conducting meetings using teleconferencing in accordance with California Government Code Section 54953(e), a provision of AB-361; now therefore be it:

**RESOLVED:** that the AC-OCAP Administering Board finds and determines that the foregoing recitals are true and correct and hereby adopts and incorporates them into this Resolution; and be it

**FURTHER RESOLVED:** that, based on these determinations and consistent with federal, state and local health guidance, the AC-OCAP Administering Board determines that conducting in-person meetings would pose imminent risks to the health of attendees; and be it

**FURTHER RESOLVED:** that the AC-OCAP Administering Board firmly believes that the community's health and safety seriously and the community's right to participate in local government, are both critically important, and is committed to balancing the two by continuing to use teleconferencing to conduct public meetings, in accordance with California Government Code Section 54953(e), a provision of AB-361; and be it

**FURTHER RESOLVED:** that the AC-OCAP Administering Board will renew these (or similar) findings at least every thirty (30) days in accordance with California Government Code section 54953(e) until the state of emergency related to COVID-19 has been lifted, or the AC-OCAP Administering Board finds that in-person meetings no longer pose imminent risks to the health of attendees, whichever is occurs first.

Dear Executive Director:

The purpose of this letter is to notify you that the Department of Community Services and Development (CSD) has received California's final Community Services Block Grant (CSBG) Notice of Grant Award from the U.S. Department of Health and Human Services Office of Grants Management. The final CSBG grant award for the 2022 program year is \$63,067,352 – an increase of \$205,423.00 from the 2021 program year allocation. The attached amendment releases the final CSBG allocation and makes the CSBG discretionary portion of the CSBG allocation available to agencies.

Due to the CSBG allocation increase, agencies must submit a revised CSD 425 Budget Series reflecting the increased amount identified on the 2022 CSBG Allocation Spreadsheet under the column labeled "Project Budgets – CAA" and a revised CSD 641 Workplan.

As required by state statute, upon execution of the amendment, CSD will issue an advance not to exceed 25 percent of the total allocation. Upon approval of your contract deliverables, your agency's remaining advance payment will be automatically authorized. If your agency opts not to receive an advance, you must submit a letter on your organization's letterhead with the contract declining the advance. Please refer to the allocation spreadsheets, which detail the amount of the advance.

CSD is also amending the 2022 CSBG contract to include CSBG discretionary funds. The expenditure timeframe for discretionary funds is June 15, 2022, through May 31, 2023. Each agency will receive \$31,000 that may be used to expand or enhance program services and/or to increase agency capacity.

The expenditures for CSBG discretionary funds must be tracked separately, which requires a separate budget and work plan. To complete the required contract budget and work plan, Agencies must use the CSD 627 Discretionary Budget Series and the CSD 626 Discretionary Workplan contract forms.

Agencies that opt to receive an advance payment for the discretionary funds must notify CSD in writing on agency letterhead submitted with the contract. Upon approval of contract deliverables, your agency's advance payment will be automatically authorized. Please refer to the allocation spreadsheets which detail the amount of the advance.

All budget and work plan forms for the regular and discretionary grant awards may be accessed through CSD's [Local Agencies Portal](#), located under the "Forms" tab after selecting "CSBG."

Contract amendments will be executed electronically via DocuSign. For your reference, DocuSign information is provided with instructions to add applicable agency staff that are authorized to execute contracts.

If you have any questions, please contact your assigned field representative. CSD looks forward to a continued productive partnership so that, together, we can effectively administer our critical programs and services designed to strengthen the economic security of vulnerable Californians.
