- **5.** Discussion Item #1: Review Strategy for Advocacy Committee (Attachment 5) T. Love worked on condensing the strategy based on the committee's current capacity.
 - Q. Norwood proposed three strategic areas for the committee to focus on:
 - Communications (letter writing, media platforms)
 - Outreach (building relationships, contacting meetings)
 - Organizing (putting together advocacy events)

Strategic Considerations: The goal was to create a manageable strategy that matches the committee's current capacity. Emphasis on clear responsibilities and accountability. Ability to effectively pursue advocacy goals with limited resources.

- **6. Discussion Item #2: Review Policy Priorities of Cal-CAPA Bill Watch (Attachment 6)** T. Love reviewed CAPA's existing policy priorities, which included:
 - Strengthening community diversity and inclusion
 - Maintaining service infrastructure
 - Addressing social circumstances related to energy, water, and climate change.
 - Supporting network and legislative efforts.
- 7. Discussion Item #3: Identify specific legislation to advocate for The committee discussed and evaluated each bill's relevance to their mission. They considered Santiago's bill about tax credits for young children (AB 1128) but noted it had previously failed in committee. T. Love suggested looking at Senator Arreguin's transportation bill, which proposed \$2 billion for public transportation. Q. Norwood initially shared several potential bills, including:

- AB 936 (CalFresh fruit and vegetable pilot project)
- AB 648 (student housing development at community colleges)
- AB 2465 (equity for socially disadvantaged groups in state grant programs)
