End-of-Year Update | June 2025

The Oakland Children's Initiative (OCI) remains diligent and intentional in advancing implementation and strengthening the infrastructure necessary to support our collective work. This includes expanding the capacity and technical support for our Implementation and community partners. As the final meeting of the fiscal year, this update provides a summary of key developments and outlines the forward-looking priorities for the next two years. These priorities include: deepened facilitation, strategic communications, program planning and budgeting, evaluation, administration, and sustained community engagement. Below is a formal update since the last report in May 2025.


