#### **October Resource Committee Report (Update)**

To date, we have received twenty-two (22) Neighborhood Council (NC) forms representing twenty-seven (27) community policing beats.

Eleven NC have everything ready to proceed with coming before the CPAB. These NCs represent beats 8x, 12x, 12y/13z, 20x, 25x, 27x, 27y, 32x, 33/34x, 35x, and 35y. We have invited these eleven Neighborhood Councils to the November 2025 CPAB meeting.

For eleven NCs, we are nearly ready to proceed but we are awaiting answers to questions as well as supporting documentation showing compliance.

**RE: Sub-Committee Report Memorandum:** 

The recently formed ad hoc sub-committee for the update of resolution 79235 is pleased to submit a summary of our discussed goals and outreach intentions for the next year (see attachment A). We are asking for the Board's consideration and approval to utilize the attached "one-pager" document as appropriate collateral and talking points guidance as we undertake communitywide outreach on the resolution update over the next few months.

#### **Background**

The ad hoc sub-committee has met three times this summer to discuss and develop a summary of goals and the outreach materials. With our discussions, there have been several points of consensus that the ad hoc sub-committee has agreed upon as an approach to start the resolution update.

#### Consensus points include:

- The existing 20-year-old resolution is outdated and should be reviewed for its current relevance to community policing.
- We endeavor to work from the existing resolution and its integrated structure of block level, neighborhood level, and citywide level. We seek to strengthen the explicit intent of neighborhood empowerment and the overall role of neighborhoods in achieving community safety and health.<sup>1</sup>
- As the City has objectively not been upholding its stated commitment to the
  resolution instead of backsliding on the function, voice, involvement, and
  empowerment of NCs, the resolution needs to be updated and reaffirmed with the
  leadership of community that can hold the City accountable placed at the forefront.

<sup>&</sup>lt;sup>1</sup> Other positive aspects of the existing resolution we recognize include its intents to enhance public safety and quality of life; emphasize empowerment and engagement, establish peer-to-peer partnerships between community and city agencies; use proactive problem-solving methods; be geographically based; provide City and inter-departmental support to NCs with dedicated staff and resources.

- We support the continued role of having the CPAB do regular review of the City community policing policy before implementation and report out to City Council/public safety committee.
- We wish to expand from primarily community policing focused on OPD by also bringing in other departments within the City involved in community safety such as DVP, NLC, Public Works, Planning, OakDOT, Workforce Dev. etc.
- The resolution should ensure that the City, working with the CPAB, commit to holding an annual summit ("congress of neighborhoods") including block orgs.

There were also some key points that we consider still open questions for which we would like to get specific input over the next few months both from the board and as we engage our community partners:

#### Open Questions include:

- How to encourage greater activation and participation in NCs. We propose to
  incorporate a proactive "neighborhood by neighborhood" planning and
  implementation role for NCs that would, with technical assistance from City,
  support on-going quality of life and community health improvement actions at the
  neighborhood level. This approach would also stipulate that the City utilize certified
  NC plans to inform biennial capital improvement project budgets and
  implementation.
- How should we best ensure or manage that NCs correspond to organic geographic neighborhoods? Police beats were used to maximize efficient service calls in respects to policing but the focus on public elementary school boundaries might be more contiguous with actual neighborhoods.
- Should block level groups like Neighborhood Watch that predated community
  policing efforts be recognized for their own autonomy (without a need to certify by
  CPAB). Instead, we can seek to provide incentives, training resources, or other
  encouragement for these groups to be part of the NC structure and defining
  community policing policy.
- Should there be a reconfiguration of the structure and name of our oversight board, e.g., should this be a Neighborhood Empowerment Commission? Does the number of seats and appointments need to be updated?
- How should we stipulate that the City provides a dedicated budget funding amount
  to appropriately and adequately support NCs along with a department of
  neighborhood empowerment to formally acknowledge how the City intends to
  govern and engage as part of its commitment to community safety and health?

#### **Recommendation:**

We ask the CPAB to review, consider, and if aggregable, affirm the goals and next steps for the resolution update outreach process.

### 2025 Proposed Update to Resolution 79235 Summary

#### **Overall Objective**

Update and strengthen Oakland's 2005 Community Policing and Public Safety Resolution (79235) to reaffirm its structural importance, ensure sustained City, Neighborhood Council, and community member engagement, and enhance its effectiveness as a formally adopted policy. The revised resolution will:

- Prioritize and advance neighborhood empowerment
- Strengthen opportunities for community capacity building
- Promote connections between enhanced quality of life, health, and safety
- Ensure and activate collaborative, citywide engagement

### Why an Update Is Needed

- 1. **20 years old** Framework from 2005 no longer adequately reflects current needs; functionally it is not supporting the community part of policing and safety.
- 2. **Accountability gaps** Dissolution of Neighborhood Services Division (NSD) and missed summits weaken community trust.
- 3. **Shift in focus** Broaden beyond problem-solving by policing to emphasize empowerment, community health, and proactive grassroots involvement in neighborhood improvements.
- 4. **Neighborhood Councils (NCs)** Reaffirmed as essential, requiring structured support, liaison staff, and resources for more sustained community involvement.
- 5. **Strategic alignment** Opportunity to integrate with Oakland's General Plan update, capital improvements, community planning, and resiliency initiatives.

### **Key Goals of the Update**

- 1. Reassert Policy Mandate
  - ➤ Make Resolution 79235 central to public safety through inter-active community engagement.
- 2. Empower Communities
  - ➤ Prioritize the means to improve health, grassroots leadership, and proactive involvement in addressing quality of life concerns
- 3. Reinforce Neighborhood Councils
  - ➤ Provide dedicated resources, staffing, and technical support so neighborhoods have a stronger role in City government and the investments of public services.
- 4. Integrate with Citywide Initiatives
  - ➤ Align NC priority-setting with the City's General Plan, capital projects, and resilience strategies.

### **CPAB Ad Hoc Committee's Next Steps**

- **Research best practices** Study other U.S. city models of municipal-supported neighborhood empowerment.
- **Community outreach** Conduct inclusive citywide engagement strategy (including with City Council members, NCs, community organizations, block groups) to gather input on proposed updates.
- Draft update Present proposed revision of Resolution 79235 for CPAB review (goal: initial direction draft with community input in Q1 2026 and final draft for adoption by June 30, 2026).
- **Ongoing alignment** Coordinate with Measure NN Commission to ensure consistency with safety and policing goals.

#### **Bottom Line**

Updating Resolution 79235 will **reestablish Oakland's commitment** to community-driven safety, strengthen neighborhood structures, and embed **equity**, **health**, **and resilience** into the City's long-term public safety strategy.
