Meeting Minutes

Approval of Minutes:

1. Approval of MINUTES of April 2021 Minutes

Motion moved to approve by Tyese Wortham. Seconded by Sriba Kwadjovie. The motion
passed unanimously.

MANAGER'S REPORT

Roberto Bedoya, Cultural Affairs Manager

Roberto Bedoya began his report by sharing that the Cultural Affairs Division (CAD) recently received a \$900,000 grant from the Mellon Foundation for the Cultural Strategists in Government Program, which embeds artists in different government departments to help them develop new ways of working. The pilot for this program began 2 years ago, and this new funding will support 12 strategists for 30 months' total. As discussed previously, it is difficult for government agencies to receive private foundation funding, however the Mellon Foundation found the Oakland landscape fitting for this grant opportunity, and we will partner with the Oakland Fund for Public Innovation to serve as the funding intermediary. The program will be launched this fall.

Bedoya continued by providing an update on the newly approved City budget. He thanked the Funding Advisory Committee for their advocacy and presence during this process. CAD now has an extra \$500,000 for this year and \$1M for the next year to support cultural funding. Furthermore, a part-time position has been unfrozen to create a permanent full-time position. Bedoya is working with Denise Pate and Raquel Iglesias to develop next steps in disbursing the \$500,000 for this fiscal year, with funding being granted by June 30, 2022. The City Council has also created a preference for cultural funding to prioritize flatland neighborhoods (East Oakland, below 580, etc), to support geographic and racial equity. Another priority communicated was to support neighborhood festival

culture throughout the city. Festival support could come in the form of funding permitting fees, artist fees, fire and police, etc.

Lastly, the Just City Fund, of which CAD is a partner in, continues to move along nicely. The fund recently received over 120 applications to which only 10 grantees will be selected. The Just City Fund is a partnership with the East Bay Community Foundation and the Akonadi Foundation.

Discussion Points:

- Jim Santi Owen asked what is the process for the \$900k Mellon grant and the program it supports. Are these paid positions? Roberto Bedoya clarified that a project manager will need to be hired to support the process and where the funding intermediary, Oakland Fund for Public Innovation, will play a key role. Strategists will be paid \$40k per year to work with a City government department.
- Jim also asked about staff capacity for grants and Roberto shared that more staff will be added to support grants. A part-time position has been unfrozen to create a permanent full-time position who will support grants, and another part-time position will be hired to support various projects within the department.
- Tyese Wortham applauded CAD on all the great news, and honored the many artists who advocated for more support for the division. Tyese also asked what opportunities will the new cultural strategists have to learn from the previous. Roberto shared that peer learning will be key, and a priority for the incoming project manager.
- Indi McCasey asked what happened with the Goldman public policy fellow, and if their work will help inform the work of the cultural strategists. Roberto stated that he will share the report the fellow generated with FAC.
- Adriana Grino shared her congratulations on the Mellon grant and asked for clarification on
 when the second round of Neighborhood Voices would be happening. Roberto shared that
 we're hoping to release the guidelines by the end of the summer and start deliberations by
 the end of the calendar year. Roberto also shared that developing proper language and data
 points will demonstrate how we are currently supporting equity and serving every district in
 Oakland.

Coordinator's Report Denise Pate, Cultural Funding Program Coordinator

Denise Pate began her report by sharing that cultural funding is currently finishing up the contracts for 2020-21 Round Two Neighborhood Voice grantees. Pate shared that staff is currently working through a tricky contract which has been delayed because of a new requirement which came up with insurance, but staff continues moving forward. 2021-22 Round One Neighborhood Voices deadline is on July 15th. This grant deadline also applies to Organizational Assistance (general operating). Grantee workshops were decently attended, however many early applications had significant issues, which showed a great need for grantee technical assistance. 157 applications are currently in the queue and we expect the majority to be submitted.

Pate also shared that we are in need for Organizational Assistance panelists, happening on September 3rd. This panel requires a high level of knowledge to review these established applicants; Pate welcomed any recommendations FAC may have. She also shared that Zoom has helped recruit panelists across the US, as well as create more accessibility for all.

Raquel Iglesias will be writing the next Neighborhood Voices guidelines, with a goal of releasing them mid-august. Pate also shared that the expectation for cultural funding to serve every corner of the city with little funds is challenging, however the team will continue working on language and gathering data to support the work being done.

Discussion Points:

- Indi McCasey shared their appreciation for the cultural funding team, and the importance of supporting artists through the insurance and contracting process. They also suggested that panelists payment be increased to match our peers. Roberto stated that we would consider this and try to implement this suggestion.
- Jim Santi Owen asked what the likelihood is to reestablish the Arts in the Schools program. Roberto said we would consider this, and mentioned the need to critically review the number of small awards people are receiving considering the amount of paper work required for each grant.

DISCUSSION ITEMS

1. DISCUSSION ITEM #1 - Re-establish hiatus requirements for CFP grant categories
This hiatus would apply for Organizational Projects and Individual Artist Projects.

Discussion Points:

- Denise Pate clarified that in the past we have had grantee hiatus periods. A hiatus period allows other applicants to enter the grantee pool, for example: after 2 or 3 consecutive years, the grantee would have an "off" year of receiving a grant to allow others a chance to receive funding. "Off Year" grantees should be notified a year prior of this requirement.
- Jim Santi Owen asked if we should rethink timing of when to implement to give grantees more of a heads-up. Denise stated that if we make the announcement now, grantees would have a year of notice, applying to the 2022-23 granting period. This would also support City Councils call for us to focus on underserved communities.
- Adriana Grino asked if the program has collected data on the application success rate of first time applicants for more context. Denise agreed this would be a good idea and knows off-hand that there is a low likelihood that new applicants get funded.
- Indi McCasey named constraints put upon by the city as creating barriers for new applicants, and suggested the additional use of partnerships to expand reach.
- Sriba Kwadjovie asked how long the hiatus would be in effect for, and if there is the possibility of creating a new funding opportunity for new applicants. Denise clarified that we don't have enough resources for technical assistance, but sees this as a great

- need. At this time CAD does not have the capacity for another grant round. Sriba shared her support of this hiatus and making more space for new grantees.
- Tyese Wortham expressed her gratitude for staff and being honest about the challenges moving forward.
- Adriana Grino expressed her desire to learn about the impact the hiatus period has on the applicant pool moving forward.

ACTION ITEM #1 Hiatus requirement for Neighborhood Voices for Organizations Organizations that received grants through the Neighborhood Voices for Organizations category for the past two consecutive grant cycles (Fiscal Years 20-21, 21-22,) are ineligible to apply in FY22-23. After a one-year hiatus, the organization may apply for the FY23-24 cycle.

• 5 in favor. Action item passes unanimously.

ACTION ITEM #2: Hiatus requirement for Neighborhood Voices for Individual Artists

Individual Artists who have received funds in the Neighborhood Voices for INDIVIDUAL ARTISTS category for the past, two consecutive years are ineligible to apply for one year (i.e. if you were awarded funds in FY20-21 and FY21-22, you may not apply in FY22-23). After a one-year hiatus, the Individual artist applicant may apply for the FY23-24 funding cycle.

• 5 in favor. Action item passes unanimously.

2. DISCUSSION ITEM #2 - FY21-22 Round Two Categories and new guidelines

Discussion points:

- Adriana Grino asked if the need to support festivals could be folded into this Round
 One of funding to decrease the amount of work for staff. Roberto stated this may be
 a possibility, and is discussing festival needs with the Cultural Affairs Commission
 next week.
- Indi McCasey asked when the next commission meeting is, Neha Balram clarified it's on July 26th. Indi also emphasized the importance of staff self-care and highlighted the idea of not adding another round of panels to support staff capacity. Tyese seconded this point.
