Oakland's Four-Year Community Violence Reduction Plan Development Process

Process Overview

The members of the Oakland Public Safety Planning and Oversight Commission (OPSPOC) request to meet with leadership from OPD, OFD, and DVP, as well as other City departments, to build the framework for Oakland's Four-Year Community Violence Reduction Plan (CVRP), as set forth in Measure NN

OPSPOC endeavors to build a collaborative and productive partnership with each department, and respectfully requests expeditious scheduling of meetings with OPSPOC to ensure completion of the Plan by March 2026.

1. Vision & Goals Development Sessions with OPD, OFD, and DVP (2 hours)

- a. *Timeline*: Early October
- b. *Objective*: Commissioners will meet with leadership from DVP, OPD, and OFD to draft a vision statement and define both short- and long-term goals for Oakland's Four-Year Community Violence Reduction Plan. Additionally, commissioners will discuss potential policies and programs that may align with department goals.

2. Strategies & Metrics Development Sessions with OPD, OFD, and DVP (3 hours)

- a. Timeline: November
- b. *Objective*: Commissioners and department leadership will define strategies and metrics of success for the departments' short- and long-term goals. Commissioners will provide an overview of how community input can be incorporated into the CVRP goals.

3. Focus Groups with OPD, OFD and DVP Staff (1-2 hours)

- a. Timeline: November
- b. *Objective*: Commissioners will hold focus groups with OFD, OPD and DVP department staff who are currently providing services in the community in order to refine the implementation strategies for the CVRP. Commissioners will also continue to seek community input at regular meetings, community engagement events, focus groups, and key informant interviews.

4. Asynchronous Review of Strategies Sections & Integration of Feedback

a. Timeline: November through December

b. Objective: Commissioners will draft the strategic plan sections of the CVRP and provide a draft to department leadership. Department leadership will provide feedback, and commissioners will be available for troubleshooting and thought partnership. The CVRP draft may also be available to the public for feedback during the December OPSPOC public meeting.

5. CVRP Full Plan Drafting

- a. Timeline: December through January
- b. Objective: Commissioners will complete a public-facing CVRP draft for a public comment period. Commissioners will request additional meetings and feedback with department leadership if necessary.

6. Collaboration with Other Relevant City Departments (1-2 hours)

- a. Timeline: January
- b. Objective: OPSPOC will attend an Agency Directors meeting and facilitate collaborative discussions in breakout groups with the Directors of City Departments. OPSPOC will share the draft CVRP in advance and seek input not just from OPD, OFD and DVP but also from other departments whose work touches on public safety, such as OakDOT, Public Works, Workforce Development, Parks & Recreation, and Human Services, including the Oakland Fund for Youth and Families.

7. Beginning of Public Comment Period

- a. Timeline: February and March
- b. Objective: OPSPOC will hold community engagement events in each City district to receive feedback on the CVRP. OPSPOC will publish a community-wide survey seeking feedback on the CVRP, and integrate or respond to public comment.

8. Submission to Public Safety Committee

- a. Timeline: Late March
- b. Objective: OPSPOC will submit the CVRP to the City Council's Public Safety Committee prior to submission to the full City Council. This will give the OPSPOC an opportunity to address any concerns or questions they may have about the drafted CVRP before final submission.

9. Submission to City Council for Approval

- a. Timeline: April
- b. Objective: OPSPOC will formally submit the CVRP to City Council. If City Council does not approve the CVRP after the first submission, commissioners will address their feedback and schedule additional meetings with department leadership if needed.

To fulfill the ambitious deadline set in Measure NN and ensure that the City is able to continue collecting funds under Measure NN, the OPSPOC relies on your support, collaboration and prompt communication. We look forward to working together to ensure a safer, stronger Oakland for everyone!

BACKGROUND / LEGISLATIVE HISTORY

The Oakland Community Violence and Emergency Response Act of 2024 generates support to services that are critical to maintaining public safety in Oakland. The chief purpose and intent of this measure is to raise revenue solely to pay for the development, implementation, and evaluation of a holistic, results-driven approach to the prevention and reduction of violent crime in Oakland. The tax proceeds raised by the special taxes created by the ordinance may be used only to pay for costs or expenses relating to or arising from efforts to achieve the following desired goals:

- 1) Reduce homicides, robberies, car jackings and break-ins, domestic violence, and other qun-related violence;
- 2) Reduce response time for 911 emergency calls for service, and improve the quality of response; and
- 3) Reduce the incidence of human trafficking, including the sexual exploitation of minors.

The Act requires that each City department receiving or distributing funds generated by this Act propose a priority spending plan at least every three (3) years, the first presentation of which shall occur within 120 days of the effective date of the Act. The priority spending plan shall include proposed expenditures, strategic rationales for those expenditures, and intended measurable outcomes and metrics expected from those expenditures.

ANALYSIS AND POLICY ALTERNATIVES
