- VI. Item 1: Guest Presentation from Ruth Meza and Celina Chan, Department of Transportation

Feedback gathering: voting activity in the community to gauge people's preference on lighting, wayfighting, and other decorations for the undercrossing

Top themes:

- lighting improvements: must be functional, easy to maintain, avoid overstimulation/distraction, complement community, and enhance safety. The lighting also must be paired with safety measures. Survey revealed that most people preferred colorful lighting.
- strong positive feedback for art that represents Oakland's culture/history.
- Maintenance was a big concern \rightarrow trash should be picked up regularly, new modifications should be easy to maintain
- Big concern about personal safety and traffic when traveling through undercrossing
- Big support for adding bright and bold colors. Suggestions to add color on ceilings, columns, and walkways to brighten up the undercrossing
- interest in adding greenery (plants, trees) → conflicts with concerns about maintenance
- Navigation: Most preferred text-based, colorful navigation
- wayfinding: Most preferred straightforward signage
- Fencing: People preferred the idea of see-through fencing rather than fencing that is completely closed off
- Community engagement feedback: People felt strongly about community engagement in this project and suggested that the project team collaborate with community ambassadors. OakDOT website: www.oaklandca.gov/undercrossings
