The Oakland Parks and Recreation Advisory Commission reviewed the staff report for Item 7A prepared by Sarah Herbelin, Boating.

The Jack London Aquatic Center (JLAC) contains a public non-motorized boat launching and landing site on the Oakland Estuary. The California State Coastal Conservancy San Francisco Bay Area Water Trail ("Water Trail") program asked the City to consider designating the JLAC as a Water Trail site in order to provide enhanced public access to the Oakland Estuary and San Francisco Bay waters.

Designation results in the location being added to the Water Trail website, installation of Water Trail signage, and opportunities to apply for funding to improve the site. Three are no costs associated with the Bay Area Water Trail site designation. The Water Trail organization currently partners with Oakland Public Works with regard to illegal dumping.

Funds raised will be used to cover the costs of the festival, (i.e stage rental, clean-up, tables/chairs, etc.). Approval from the Parks and Recreation Advisory Commission is required per O.M.C. section 12.64.080.

FISCAL IMPACT

Eastside Arts Alliance is paying all fees associated with the event estimated at \$3780.00.

PROJECT / PROGRAM DESCRIPTION

The Malcolm X Jazz Arts Festival is dedicated to bringing the community together and building unity. The event also allows the Eastside Arts Alliance the exposure of support and services to the residents in the San Antonio district. Eastside Arts Alliance is expecting to have 10 to 15 arts and crafts vendors and 5 to 7 food vendors at this year's event.

Vendor fees are \$75 for arts and craft/merchandise vendors and \$125 for food vendors.

The estimated attendance is 1000.

BACKGROUND / LEGISLATIVE HISTORY

This is the 18th year that Eastside Arts Alliance (ESAA), has held the Malcolm X Jazz Festival at San Antonio Park. The last event was successful as previous year's events. Many of the participating vendors were community-based organizations and local community artists who offered arts and crafts items for sale.

I am writing on behalf of EastSide Arts Alliance. We would like permission to have arts and crafts and food vendors for our 18th annual Malcolm X Jazz Arts Festival. This annual festival has taken place in San Antonio Park, and has been consistently a successful free community event.

The festival is scheduled to take place on Saturday, May 19, 2018.

We would like to be able to have community vendors selling cultural products at the festival. This has been an ongoing tradition where community residents are able to sell handcrafted arts and food that represent their respective cultures. We are expecting to have 20-25 arts vendors and 5-7 food vendors. We charge a very reasonable fee for tables (\$75 crafts and \$125 food). The funds cover the costs of presenting the festival (stage rental, clean-up, tables/chairs, etc). SUMMARY

This is Burger Boogaloo's 6th annual 2-day music festival held at Mosswood Park on June 30th and July 1, 2018. Last year's Burger Boogaloo event at Mosswood Park had over 5,000 attendees per day and provided entertainment for music fans of all ages. Burger Boogaloo is requesting once again the approval of the solicitation of an onsite entrance fee in which proceeds will go to help cover cost of musicians, equipment, marketing, staffing, and facility usage and donation fees. In addition, Burger Boogaloo is requesting the approval of sales of merchandise, food concessions and alcoholic beverages. Best Beverage Catering Company will be contracted to facilitate all management and security of alcohol sales. Best Beverage Catering is a reputable company that has managed such events as Outside Lands Music Festival in Golden Gate Park and Treasure Island Music Festival. Burger Boogaloo has also secured National Construction Rentals to provide full fencing around perimeter of event, as well as, a secured designated alcohol zone. Local food concessions will be provided by Oakland merchants.

FISCAL IMPACT

Mosswood will provide 3 staff to help monitor this event for a total impact of approximately \$930. Funding for staff time will come from Mosswood self-sustaining fund 1820. Burger Boogaloo will provide lighting, sound, equipment, advertising, staffing, medical care, temporary fencing, and security. Mosswood will charge approximately \$20,000 for usage of the park for this event. The revenues will be deposited to the Fund 1820 – OPR Self-Sustaining fund, which supports on-going programs, events and activities.

PROJECT DESCRIPTION

The mission of Burger Boogaloo is and has been to showcase local musicians and bring together the arts community in Oakland, CA and the surrounding areas. This festival will be held at Mosswood Park from 12pm-10pm on June 30th and July 1, 2018 and is supported by Eastbay Express, SF Guardian and many local merchants. The event will be hosted by John Waters, an American film

director, screenwriter, author, and actor, for the third year in a row. With the success of last year's event Burger Boogaloo organizers strive to make this an annual event with Oakland Parks, Recreation and Youth Development and continue to attract local and legendary performers. Set-up for this event will occur on June 28-29th. Burger Boogaloo obtains security and maintenance crew, medical staff, fencing, and portable restrooms. Mosswood Recreation Center staff will be available during set-up time to monitor and provide assistance if necessary.

BACKGROUND / LEGISLATIVE HISTORY

Burger Boogaloo, now in its sixth year at Mosswood Park, was organized by Marc Ribak and Amy Caver, with the help of Sean Borhman of Burger Records. Burger Records features a lineup of over 100 fantastic Rock/Pop music acts. Of these acts, about 20-25 will perform on two stages at the 2018 summer event. More details, including a list of performers, can be found on their website at www.burgerboogaloo.com.

Burger Boogaloo provides an opportunity to showcase local talent not only in the music industry, but in the food industry as well. Last year featured 10 vendors serving a variety of food and drink, from burgers and beers to vegan treats and gourmet coffee.

RECOMMENDATION

Oakland Parks, Recreation and Youth Development staff recommends that the Parks and Recreation Advisory Commission approve the request for solicitation of entrance fees and sales of food concession, merchandise and alcoholic beverages for the 6th Annual Burger Boogaloo at Mosswood Park on June 30th – July 1st, 2018.

MILLER PARK AND DESIGNATE THE LOCATION FOR BICYCLE USE

EXECUTIVE SUMMARY / OUTCOME

A Pump Track is a human-built, looping trail system that you can ride continuously without pedaling. Pump Tracks can be built in areas as small as 50' by 50' and provide hours of exercise, entertainment, and skill building for cyclists of all ages. Pump Tracks are built using only dirt and shovels and can be changed or removed with little inconvenience. The proposed site, currently an attraction for illegal dumping and other unsavory activities, was flattened by a bulldozer decades ago creating a barren, uninviting space and hence has been unused by park users.

The Joaquin Miller Park Pump Track Organizing Group (PTOG) includes professional cyclists. professional trail builders, and a partnership with the Bicycle Trails Council, the Oakland Composite Mountain Bike Team, and Oakland Trails. The project has been reviewed and endorsed by Oakland Parks, Recreation and Youth Development (OPRYD) Director J. Nicholas Williams, District 4 Councilmember Annie Campbell Washington, Oakland Public Works (OPW) Creeks, Watershed, & Stormwater Division, and the Friends of Joaquin Miller Park.

A recommendation to approve the Minor Conditional Use Permit for the installation of a Pump Track by the Parks and Recreation Advisory Commission (PPRAC) with further approval by the Planning Commission, and PRAC's designation of the space to allow bicycles would result in the enhancement of an unused area of Joaquin Miller Park, deter negative activity, and provide increased recreational services.

FISCAL IMPACT

There is no negative fiscal impact to the City of Oakland. The Bicycle Trails Council is funding the permit fees for the Minor Conditional Use Permit, and together with the Oakland Composite Mountain Bike Team and PTOG, will build and maintain the site in perpetuity.

PROJECT / PROGRAM DESCRIPTION

Pump Tracks are low-speed skills courses benefitting riders of all ages and abilities. The installation process would proceed as follows:

Task 1: Project Planning

Once the project location and work plan has been approved by the City, the project team will begin the planning process which will include the design of the pump track and a finalized estimate on the dirt required for construction. With these estimates the team will request bids for soil and finalize the project cost.

Task 2: Deliver Dirt and Begin Rough Shaping

Once the soil provider has been identified and approved by OPW, a one-time delivery of dirt will be made via dump truck to the site which is easily accessible to trucks. Once the soil is delivered, volunteers will use hand tools to shape the dirt into the rough outline of the track. This step will likely take 3 to 4 days.

Task 3: Final Shaping and Packing

Using hand tools and volunteer hours, the project team will then sculpt and compact the track into its final form.

Task 4: Project Maintenance

While the pump track is relatively low maintenance, it will require some routine upkeep. This will include sweeping the dust and gravel from turns and filling and compacting holes with soil as ruts or bumps appear. These maintenance tasks will be completed by volunteers from the local riding community as well as from the project team. The Bicycle Trails Council and Oakland Composite High School MTB Racing Team will both enter into Adopt-a-Spot agreements with Oakland Public Works Department to maintain the Pump Track, remove litter, graffiti, and invasive plants at the site.

PTOG is made up of five qualified individuals with extensive knowledge and experience in trail and pump track construction, design, project management, and/or community outreach.

Ryan Gardner, LEED AP, MESM, Environmental Scientist

Role: Project Manager

Ryan has been a professional mountain bike racer for 10 years and is a resident of Oakland, CA. The pump track has been a dream of his since he moved to Oakland several years ago. Ryan sees the pump track as a way to foster the outdoor community in Oakland and to provide a safe place for kids to gain confidence on two wheels. Ryan works as a sustainability consultant and environmental scientist for Rincon Consultants, also in Oakland.

Kevin Smallman, School Teacher, Trail Builder

Role: Design and Construction Lead

Kevin is a professional mountain bike racer, school teacher, and trail builder who lives in San Leandro, CA. Kevin has built pump tracks and trails throughout California on both a volunteer and professional basis and has volunteered his time to this project. Kevin's experience with building and maintenance will be key to the project's overall success.

Morgan Fletcher, Oakland Composite Head Coach

Role: Community Outreach, Adopt-a-Spot designee

Morgan is the pioneer of high school cycling in Oakland. He is the head coach of the Oakland High School Composite Team and will be paramount in bringing the local cycling community together. Morgan will also use the pump track for teaching skills to his teams.

Mike Udkow, President, Bicycle Trails Council of the East Bay

Role: Financial sponsor, Adopt-a-Spot designee

The Bicycle Trails Council of the East Bay is the oldest mountain biking organization in the county, is well funded, and has a long history of working with the City of Oakland for maintenance in Joaquin Miller Park.

Stan Dodson, Executive Director, Oakland Trails

Role: Community outreach

Oakland Trails is involved to ensure that all stakeholders have been engaged in the process as required by the City of Oakland, and to present the project to PRAC.

BACKGROUND / LEGISLATIVE HISTORY

This project has been extensively vetted in the community:

Spring, 2016: Morgan Fletcher introduced the project in a joint meeting with OPRYD Director J. Nicholas Williams and District 4 Councilmember Annie Campbell Washington.

Summer, 2016: Ryan Gardner and Kevin Smallman introduced the project to the Friends of Joaquin Miller Park (FOJMP).

November, 2017: Ryan Gardner and Stan Dodson asked FOJMP to endorse the project. Because many members were not familiar with the proposed site, PTOG agreed to install stakes so members could visit and visualize the project. The site visits took place over the next few weeks by several members.

December, 2017: The Bicycle Trails Council of the East Bay Board of Directors voted to approve 1) funding the Minor CUP fees (\$1500), and 2) enter into an Adopt-a-Spot agreement to maintain the site in perpetuity.

December, 2017: FOJMP Board of Directors voted to endorse the project.

December, 2017: Mike Udkow and Stan Dodson met with OPRYD Director Williams and Assistant Director Riley to discuss final steps needed for City approval of the project.

February, 2018: OPW Creeks, Watershed, & Stormwater Division staff Ben Livsey conducted a site visit and endorsed the project with one stipulation, as stated: "The Watershed and Stormwater Management Division at City of Oakland finds the Pump Track Proposal for Joaquin Miller Park acceptable with one condition: The pump track must be setback a minimum of 15 feet from the bluff top."

RECOMMENDATION

Oakland Parks, Recreation and Youth Development recommends that the Park and Recreation Advisory Commission recommend approval of a Minor Conditional Use Permit for installation of a Pump Track feature in Joaquin Miller Park and designate the location for bicycle use.







OAKLAND MUNICIPAL CODE VIOLATIONS AS INFRACTIONS

SUMMARY

Staff recommends that the Parks and Recreation Advisory Commission (PRAC) make a recommendation to the City Council to amend Chapter 12.64 Park and Recreation Area Use Regulations of the Oakland Municipal Code (OMC), Section 12.60.020 of the OMC, Bicycle Operation Rules-Violations-Penalty, and Section 1.28.020 of the OMC, Violations as Infractions to modernize park and recreation rules to better meet the needs of park users.

FISCAL IMPACT

The fiscal impact of the proposed ordinance changes will be the cost to produce and install new signs with the updated O.M.C. regulations. Improved regulations and new signs clarifying responsible park usage may result in reduced maintenance costs. The estimated cost to replace signs citywide is \$25,000 (250 signs at \$100 each). The cost of signs will be funded from the adopted budget within the Oakland Public Works Department (OPW) Fund 4400 – City Facilities Fund.

OPW confirmed funding for 28 new park rule signs and is beginning the installation process. Oakland Parks Recreation & Youth Development (OPRYD) provided OPW with a list of the parks and locations for installation of the first 28 signs.

BACKGROUND / LEGISLATIVE HISTORY

Since October, 2015, staff has been working to amend the code language of the Oakland Municipal Code related to park use rules and regulation and park signage. OPRYD provided several forums for the community to offer suggestions, recommendations, and feedback on appropriate language and user-friendly rules to create a more positive experience for park users.

On April 13, 2016, the PRAC approved staff's recommendation to amend OMC Chapter 12.64 – Parks and Recreation Area Use Regulations, OMC Section 12.60.020 – Bicycle Operation Rules-Violations and Chapter 1.28.020 – Violations as Infractions with an amendment of seven additional minor modifications to the OMC as recommended by PRAC.

At the May 11, 2016 PRAC meeting, OPRYD presented six of the seven modifications and requested direction for the remaining code, OMC Section 12.64.120. The PRAC came to a consensus that OMC Section 12.64.120 be returned to the Task Force to address the following issues raised by the PRAC:

- Incorporate language relevant to noise regulations that is mindful of cultural practices
- Construct ordinance language in a way that allows the public to self-measure or monitor behavior

Public Hearings and the Task Force Meetings were held in 2016 and 2017 and the Task Force continued to meet on a regular basis. In January 2018, the Task Force reviewed the recommended changes with various City Departments.

At the March 14, 2018 PRAC meeting, OPRYD presented updated amendments to the OMC. The PRAC moved to postpose voting in order for the Task Force to convene and finalize the language. On March 28, 2018, the PRAC Task Force met to discuss additional changes to the Ordinance grid. OPRYD received the amendments and after thorough review and receipt of community input, the OPRYD is recommending approval of the changes as indicated on *Exhibit B*.

RECOMMENDATION

Staff recommends that the Parks and Recreation Advisory Commission make a recommendation to the City Council to amend Chapter 12.64 of the OMC, Park and Recreation Area Use Regulations; Section 12.60.020 of the OMC, Bicycle Operation Rules-Violations-Penalty as related to use in parks; and Section 1.28.020 of the OMC, Violations as Infractions.

PARKS AND RECREATION ADVISORY COMMISSION PARK RULE ORDINANCE TASK FORCE FINDINGS

Dear Oakland Parks and Recreation Advisory Commission and Oakland Public At Large,

We submit to you for your consideration the following proposed amendments to the Oakland Municipal Code Chapter 12.64 Park and Recreation Area Use Regulations, Section 12.60.020 Bicycle Operation Rules-Violations-Penalty, and Section 1.28.020 - Violations and Infractions. While we are not exactly sure when the last time this section of the City's code was amended, once we began reading through it, it became apparent that it had not been changed in many decades.

As we embarked on the process to update these ordinances, the members of the Parks and Recreation Advisory Commission (PRAC) Ordinance Task Force grounded in the tenets of diversity, equity, and inclusion, while remaining committed to supporting appropriate stewardship of our public green spaces. We sought to create ordinances that enhance and encourage Oakland's vibrant cultural history, as well as put in common sense rules so that everyone can access and live harmoniously with the City's parks.

The PRAC Ordinance Task Force first met in November 2015. PRAC and City Staff then hosted two meetings to solicit feedback and input from the community regarding the municipal code. The first meeting was at a PRAC meeting on September 14, 2016 where the item was agendized. 50 community members were in attendance and 37 spoke. The second was a town hall at Mosswood Recreation Center on November 16, 2016 where 60 community members were in attendance. Staff has received input from emails. We heard from lifelong Oakland residents to individuals who just recently moved to the City. We heard from tenants, renters, homeowners, artists, community event organizers, leaders, and neighbors. In addition we researched best practices from cities all over the county. We are thankful to the community members who took their time to offer their feedback, and we are humbled by the interest in this topic.

Sound in Parks

By far, the biggest topic of conversation both at the meetings and in written comments was about sound levels, almost exclusively focused on Lake Merritt. With the improvements being implemented through Measure DD, Oakland's increasing population and popularity as a destination, and larger pressures of gentrification, activity on Lake Merritt, particularly on sunny weekends, has been steadily on the rise; although many of the activities have been around for decades and continue to this day. These activities range from permitted to unpermitted activities.

With permitted activities, individuals apply to the City for a permit, usually for an event. During the permitting process, staff informs the organizers of the rules for sound levels in parks and informs them on ways to reduce sound in the adjoining neighborhood, such as by not aiming speakers at residential areas. Organizers are told of the decibel limits for amplified sound. This system is not perfect, particularly around Lake Merritt where sound can travel across the water and the various buildings and structures can cause sound to bounce and reflect. However,

through the permitting process, there is at least a point person, the applicant, who can address issues and whom staff can contact if needed. If an individual or group has continually caused too much sound in the past, they can be refused future permits.

Unpermitted activities, described in 12.64.120 - Park sound regulation, are trickier to enforce, and many of the comments we received were about unpermitted activities, usually people playing music too loudly and percussion instruments. In all, we attempted to craft language that encourages positive, polite, and respectful use of the parks, and gives those who feel that other are being too loud a way to ameliorate the situation. The City has other ordinances in other sections of the municipal code, particularly the Health & Safety section 8.18.010–Excessive and annoying noises prohibited and section 8.18.020–Persistent noise a nuisance. These codes apply to city park and recreations spaces, just as they apply to all places in Oakland. Ultimately, while rules on sound levels in parks do exists, they may not be able to always be enforced due to the City's lack of resources, and that authority rests with the Oakland Police Department.

Other Items

Under **12.64.050** - **Animals**, we felt that it was appropriate for Oakland Police Department to turn cats that are loose in parks over to Oakland Animal Services, rather than destroy them.

Under 12.64.070 – Weapons-Disturbing Birds, we added language about remote controlled devices after hearing concern about drones and other flying objects disturbing birds, particularly at the wildlife sanctuary in Lake Merritt.

We removed "sleeping on benches" from section 12.64.100. We felt there was nothing inherently wrong with taking a nap on a bench in a park and thought that it would most commonly be enforced on homeless individuals. There are other sections and regulations regarding park hours, which can be used to ensure people are not staying in parks overnight.

At the request of Oakland Parks, Recreation, and Youth Development Director, we included 12.64.101 – Playgrounds/Play areas to further define these areas within parks, as the staff had been receiving reports of older individuals loitering around play areas for young children, making them not useful for their intended purpose.

Section 12.64.160 – Fires and barbecues was updated to be in line with the locations and policies PRAC voted on in July 2015.

In section 12.64.250 - Statement of principles we added sexual orientation, gender identity and expression to expressly include LGBTQ individuals and communities, and also to be more in line with California's State anti-discrimination laws.

We updated and revised a lot of the permitting process. Most of this language was developed by City Staff, as they administer these processes on a daily basis.

Under 12.64.320 - Criteria for issuance of permit, we added the following condition to reasons why someone could be refused a permit: "The applicant has a prior history of events in

parks which include verified, unresolved complaints of excessive noise, inciting violence, or poor security and crowd control and/or poor parking control." If someone's event was poorly run and impacted the surrounding neighborhood in the past, we would want to be able to consider not issuing them another permit, unless these issues can be resolved. The phrase "inciting violence" was added because of the fascist and white supremacist groups that held rallies in Berkeley over the summer of 2017, dressed in riot gear, who preceded to riot throughout the city. While these groups did not receive a permit from the city ahead of time, we still wanted to make sure that these, and any other violent groups could not legally operate their rallies in Oakland city parks.

12.64.410 – **Administrative Regulations** was added to give City Staff appropriate authority to implement the policies and regulations set forth in this document.

12.60.020 - Bicycle operation rules—Violation—Penalty was updated slightly to discourage bicycle use in parks that would be dangerous or damaging to the parkland.

Other ideas/Bike Rack

Not every issue in the City's parks can be address through changes in municipal ordinances, and the PRAC Ordinance Task Force kept a list of other and off topic (bike rack) ideas for future consideration to work on improving many of issues we heard about that. To that, the PRAC ordinance subcommittee also presents the following recommendations for improving our parks, based on the feedback we heard from the public:

- 1. Lake Merritt is a unique park site in Oakland which has been an epicenter of park user and residential contentions. Because of its diverse cultural practices and uses as well as its growing popularity and park user population Lake Merritt is in need of some type of park ambassadors who can respectfully guide park user activities. Suggestions have included non-armed police cadets, park rangers, or community park patrols, especially during high park use periods Friday-Sunday April 1 October 31st.
- 2. Foster the formation of a "Friends of" group for Lake Merritt, which can address issues and develop solutions in the future.
- 3. Investigate establishing community designated music zones for non-amplified/acoustic performance art. Develop working relationship with Cultural Affairs Manager for continuity of cultural expression protected activities and zones.
- 4. Investigate allowing more music and art vending permits for those that meet artist vending guidelines as outlined by Cultural Affairs Manager in alignment with cultural expression protected activities.
- 5. Fund a Lake Merritt acoustic/sound study to understand the dynamics of the parks sound transfers. This could help determine which areas of the lake needs to be retrofitted with sound dampening system, sound technologies, and/or vegetation to reduce park noise/sound from bleeding into residential areas. Moreover The City of Oakland should look into park designs solutions to accommodate these culturally relevant and long term park user practices and engagements.
- 6. Implement "Open Day" in which Oakland residents can enjoy their local parks unencumbered by outside/paid/schedule events.

- 7. Increase of restrooms and garbage receptacles are needed. Staff to tend to them.
- 8. Investigate allowing more food vending permits for vendors that meet healthy food guidelines
- 9. Encourage accessible calendar print and online for residents to be informed of permitted events, games and closures. Link with council member newsletters.

Next Steps

After the ordinance is approved, with or without further modifications, by PRAC, it will be reviewed by the City's lawyers. The PRAC Ordinance task force will review these changes and if there is anything that we feel is substantially changed from the intent of the PRAC-approved language, we will request bringing the ordinances back to PRAC. If the lawyer's edits look to be in line with the spirit of our suggested changes, the final version of the Oakland Municipal Code Chapter 12.64 Park and Recreation Area Use Regulations, Section 12.60.020 Bicycle Operation Rules-Violations-Penalty, and Section 1.28.020 - Violations and Infractions will go to Oakland City Council for official adoption.

Again, thank you to everyone who has helped make these recommended updates possible. Many people have spent a lot of time and effort putting these ordinances together. Hopefully, they can be implemented to help further support this City that we all love.

No person shall be permitted to use the shores of Lake Merritt as a landing place for boats, or keep thereat boats for hire or floating boat houses with pleasure boats for hire, or keep boats of any kind in Lake Merritt, except under a permit from the Recreation Commission for such purpose, and only at places designated by and under restrictions and regulations promulgated by the Board of Park Directors or the Recreation Commission; and no regattas, boat races, or other special events involving the use of Lake Merritt shall take place thereon without permission granted by the Recreation Commission.

12.64.210 - Fishing in Lake Merritt.

No person shall fish in Lake Merritt without written permission from the Board of Park Directors so to do, and no person shall in any event be allowed to catch more than two bass in one day in Lake Merritt.

12.64.220 - The zoo.

It is unlawful for any person to tease, injure or frighten any of the birds animals, reptiles or fish belonging to, or confined in the municipal zoo.

12.64.230 - Municipal swimming pools—Not to be used in absence of attendant.

It is unlawful for any person to enter upon any municipal swimming pool or the dressing rooms connected therewith at any time when no employee of the Recreation Department, or other attendant authorized by said Department, is on duty at said pool.

12.64.240 - Golf courses.

A. Trespass on. It is unlawful for any person to trespass upon the Oakland Municipal Golf Course, or upon any private or public golf course in the city, except pursuant to the express consent of the person in charge of the management thereof.

This subsection shall not apply to the employees of the city properly engaged in work for said city in or upon the above described area and authorized by the <u>City</u> Board of Playground Directors or the Board of Park Directors to be thereon.

D. Boats and Boat Races. No person shall be permitted to use the shores of Lake Merritt as a landing place for boats, or keep thereat-boats for hire or floating boat houses with pleasure boats for hire, or keep boats of any kind in Lake Merritt, except under a permit from the OPR Recreation Commission for such purpose, and only at places designated by and under restrictions and regulations promulgated authorized by the Director Board of Park Directors or the Recreation Commission; and no regattas, boat races, or other special events involving the use of Lake Merritt shall take place thereon without permission granted by a permit from OPR. "Non-amplified community musical performance" and "non-amplified community entertainment performance" means any public performance conducted in any city park that is open to the public consisting of an individual or a group of twenty-four (24) or less performers that use non-amplified sounds in which no funds are collected on site.

12.64.270 - Compliance required.

No person shall enter, be or remain in any park of the city unless he or she complies with this article and other provisions of this code.

12.64.280 - Permit required.

No use of any park for a private or special event may be made without issuance of a permit therefor. All applications for use of any park must be accompanied by the fee prescribed in the master fee schedule, signed or co-signed by an adult, which adult shall agree to be responsible for said exclusive use. No use permit will be granted, if, prior to the time the application was filed, the city has scheduled a city-sponsored event at the same time and place as the activity proposed in the application.

12.64.290 - Private event park use application.

Any person applying for a private event permit hereunder shall file an application for such permit with the PRCS Central Reservations Unit not less than fifteen (15) working days nor more than eleven (11) months prior to the proposed use of said park. The Director may waive the fifteen (15) working day period if applicant waives all appeal rights.

12.64.291 - Park use permit for special events.

Any person applying for a park use permit for a special event shall file an application for such permit with the PRCS Central Reservations Unit not less than ninety (90) days nor more than eleven (11) months prior to the proposed use of said park. The Director may waive the ninety (90) day period if the applicant waives all appeal rights.

In addition to applying for a park use permit, the applicant must apply for a special event permit with the Oakland Police Department for approval by the Chief of Police or his designee pursuant to the requirements enumerated in <u>Chapter 9.52</u> of <u>Title 9</u> of the Oakland Municipal Code. However, the Chief of Police, in consultation with the Director of Parks, Recreation and Cultural Services or his or her authorized representative, shall retain the authority to delegate the

In addition to applying for a park use permit, the applicant must apply for a special event permit with the Oakland Police Department (OPD) for approval by the Chief of Police or her or his designee pursuant to the requirements enumerated in Chapter 9.52 of Title 9 of the Oakland Municipal Code. However, the Chief of Police, in consultation with the Director of Parks, Recreation and Cultural Services or his or her authorized representative, shall retain the authority to delegate the issuance of special event permits for certain routine events in city

No loudspeaker shall be permitted to be placed in a public park within three hundred (300) feet of any residential structure. L. The applicant has a prior history of events in parks which include verified, unresolved complaints of excessive noise, inciting violence, or poor security and crowd control and/or poor parking control.

12.60.020 - Bicycle operation rules—Violation—Penalty.

It is unlawful to operate a bicycle on any trail within the city in an unsafe, reckless, dangerous or negligent manner. No person shall operate a bicycle in excess of fifteen (15) miles per hour, nor in excess of five miles per hour when passing pedestrians or equestrians or when approaching and negotiating a blind turn, nor at a greater speed then is reasonable or prudent. Within city parks, bicyclists can ride on named trails only and are prohibited from operating bicycles off-trail. Bicyclists must obey all posted signs and rules. Bicyclists must call out when passing pedestrians, or other bicyclists and then must pass to the left. Bicyclists must yield to equestrians by calling out and requesting instructions to pass. The City Manager, or his or her designees, shall determine trail accessibility for bicyclists. SUMMARY

This is a request for the Parks and Recreation Advisory Commission 'PRAC', to allow the Friends of the Oakland Municipal Band, also known as FOMB, to sell and collect monies on site at the five concerts of the 107th season of the Oakland Municipal Band. The Oakland Municipal Band performs a variety of musical selections from classical to Broadway and Hollywood at the Edoff Memorial Bandstand. The musicians are union professionals who are members of orchestras and symphonies throughout the Bay Area. The concerts are free and open to all. Last year, our audiences of families, seniors, couples and individuals exceeded 250 every concert. Many more enjoyed the music as they engaged in other activities at Lakeside Park. This year, FOMB is requesting permission to accept donations and to sell snacks during intermission.

FISCAL IMPACT

There is no fiscal impact on OPRYD. FOMB is responsible for paying the musicians, the conductors and all other direct expenses of the Oakland Municipal Band's performances at the Edoff Memorial Bandstand. The members of FOBM are volunteers. FOMB continues its partners with OPRYD and is proud to be one of Oakland's longest running cultural arts programs.

PROJECT DESCRIPTION

The purpose of the 107th season of the Oakland Municipal Band is in line with the mission of OPRYD. The concerts are part of the national culture of live summer music performances. They foster a better understanding of American diversity by presenting selections from the nation's rich musical traditions. As free, open air concerts, the band performances are accessible and fun entertainment for all generations. Many families have attended for many years, and for children, these concerts can be their first exposure to live classical and pops music.

BACKGROUND

The Friends of the Oakland Municipal Band is a 501 C (3) organization, was founded in November, 2010 and incorporated on January 26, 2012 in the city of Oakland, California. FOMB is registered as a Californian non-profit corporation and has a valid city business license. The Oakland Municipal Band was established in 1912.

On behalf of the Friends of the Oakland Municipal Band (FOMB), I ask that you and your fellow commissioners on the Parks and Recreation Advisory Commission (PRAC) allow FOMB to collect monies on site during the five concerts of the 107th season of the Oakland Municipal Band. The concert dates are July 4, 15,22, 29 and August 5. Presented at the historic Edoff Municipal Bandstand in Lakeside Park, the concerts begin at 1:00 pm and end at 3:00 pm. FOMB accepts donations from audience members and sells refreshments during intermission. Accepting donations is critical to our mission as we are responsible for paying the musicians, the conductors and other direct expenses of the Oakland Municipal Band's performances. FOMB sells refreshments during intermission in order to retain our audience. We make only a modest amount of money from the sale of snacks, but people attending cultural arts events expect to find refreshments during intermission.

The members of FOBM are volunteers. The group began in 1988 as a supporting organization of the Oakland Municipal Band under the fiscal management of the Oakland Parks and Recreation Foundation. At the time, the City of Oakland provided most of the funding for the band's performances. By 2010, however, FOMB was raising almost half of the expenses, and by 2012, the City of Oakland ending all funding. Today, the concerts are presented in partnership with the Department of Parks, Recreation and Youth Development, with FOMB responsible for paying the band's expenses. FOMB was founded as a independent non-profit in November 2010 and incorporated as a 501c(3) organization on January 26, 2012. FOMB is duly registered as a non-profit corporation in the State of California and has a valid City of Oakland business license.

The 35-piece band Oakland Municipal Band performs a variety of musical selections from classical to Broadway and Hollywood for the enjoyment and enrichment of the

diverse population of Oakland and the surrounding communities. Musicians are members of orchestras and symphonies throughout the Bay Area. We hire through the Musicians Union Local 6, and these concerts provide a welcome income during the off-season to musicians in our community.

The Oakland Municipal Band is one of oldest musical organizations in the United States. Since 1912, the Oakland Municipal Band has performed live music in the heart of the city. These free outdoor concerts make live music available to many who may otherwise not be able to experience the excitement of live performance. Lakeside Park is the cultural heart of the city, and these concerts bring residents of all ages and backgrounds together for quality live music, picnicking and socializing. Some audience members have been enjoying concerts for more than 50 years. For children, these concerts are often their first exposure to live performance of the American songbook. Many people enjoy the music as they engage in other activities at Lakeside Park. The volunteer members of FOMB are committing to keeping the Band playing on.
