The Oakland Parks and Recreation Advisory Commission reviewed the staff report for Item 7A prepared by Sarah Herbelin, Boating.

The Jack London Aquatic Center (JLAC) contains a public non-motorized boat launching and landing site on the Oakland Estuary. The California State Coastal Conservancy San Francisco Bay Area Water Trail ("Water Trail") program asked the City to consider designating the JLAC as a Water Trail site in order to provide enhanced public access to the Oakland Estuary and San Francisco Bay waters.

Designation results in the location being added to the Water Trail website, installation of Water Trail signage, and opportunities to apply for funding to improve the site. Three are no costs associated with the Bay Area Water Trail site designation. The Water Trail organization currently partners with Oakland Public Works with regard to illegal dumping.

Vegan Outreach is requesting permission to allow mobile food truck vendors, non-profits and local vendors to collect funds and donations in exchange for goods services at the 4th Annual Oakland VegFest at the Lake Merritt Boulevard Amphitheatre on Saturday, May 19, 2018. Approval from the Parks and Recreation Advisory Commission is required per O.M.C. section 12.64.080.

FISCAL IMPACT

Vegan Outreach is paying all rental fees associated with the event estimated at \$3,230.00.

PROJECT / PROGRAM DESCRIPTION

The 2017 Oakland VegFest at Lake Merritt was hugely successful. It drew approximately 3,000 people, and received local media coverage in the East Bay Express, KPFA, and KRON. The event featured local chefs and dozens of local businesses and restaurants.

Booths will be set up for participating restaurants, businesses, food vendors, and non-profits. The Oakland VegFest will also feature speakers, music, and cooking demonstrations.

The following is a list of fees to be collected onsite:

- \$5-\$15 food vendors
- \$5-\$30 merchants selling wares
- \$10 non-profits receiving approximately \$100 in donations per tables

The revenue from the tabling fees will go to Oakland Veg to cover the various costs for hosting the event (such as park rental and permits, supplies and rental costs). Vendors and non-profits will keep all respective monies collected during the event in exchange for goods and services provided.

The estimated attendance is 3000.

Oakland Veg Week is an annual event celebrating the many vegetarian venue options in Oakland.

BACKGROUND HISTORY

Carol Ann was born, raised, married, had her family, and lived in San Francisco all her life. She attended Lowell High School and the University of California, Berkeley.

Mr. Bachman shared the following history.

"Until we both went to college we lived as two very close families in the same household for our mothers were identical twins that also dressed identically. They were the *first* San Francisco Twins and you might say that we lived in the first San Francisco commune that predated the Haight-Ashbury times. We were officially first cousins, but genetically we were half sibs, although closer since we did not have to share our parents. The genetics are complicated but happened because each of our mothers had identical DNA."

Mr. Bachman and his wife have lived and worked in Oakland for over 50 years. Ron is an avid runner competing in three Oakland marathons resulting in injuries which now cause him to walk slowly. He spends a great deal of time walking around the Lake with his wife. They would love to pass "Carol Ann's Bench" whenever they circumnavigate Oakland's beautiful lake allowing them a place to remember Carol Ann.

SUMMARY

Parks and Recreation Advisory Council approval is required in order for CarebelinQ Omnimedia LLC to solicit fees for vendors to sell merchandise at a City of Oakland Park, in accordance with Oakland Municipal Code Section 12.64.080. This proposal is for Oakland Carnival, an annual free community festival held at Mosswood Park. Oakland Carnival is a free, family friendly event for the public featuring Oakland artisans celebrating African communities. Oakland Carnival attracts many Oakland residents for this one day event held at Mosswood Park. Organizers are requesting permission to collect registration fees from onsite vendors to create an African Marketplace and for approval of vendors to sell goods and food items. The merchandise sold will include clothing, soaps, beauty products and art. Food sales will also highlight culturally diverse cuisines. Individual vendors only, will benefit from sale of items.

FISCAL IMPACT

Mosswood will provide 2 staff to help monitor and supervise this event for a total fiscal impact of \$470. Mosswood will charge approximately \$2400 for usage of the park for this event. The revenues will be deposited to the Fund 1820 – OPR Self-Sustaining fund, which supports on-going programs, events and activities.

PROJECT DESCRIPTION

Oakland Carnival promotes art, culture, wellness, and fitness through festival activities such as music, drumming, movement, and dance. This event brings Oakland residents together at park spaces, creating an atmosphere of comradery, celebration, and community wellness. The event is to be held on June 2, 2018, one week after Memorial Day weekend. Organizers are working with the community and its institutions to increase support and engagement.

BACKGROUND

Oakland Carnival Festival is presented by Theo Williams, produced by CaribelinQ OmniMedia LLC in partnership with Dimensions Dance Theater serving as fiscal sponsor. In its fourth official year, the festival has brought enthusiastic audiences to enjoy some of Oakland's top performing companies in a beautiful public space. Oakland based performers showcase their talents at

Mosswood Park and feature music and dance from African, Caribbean, and Latin American Cultures. Over the past four years, Oakland Carnival has come to be known as a cultural destination and a "way of shifting openly accessible public spaces into spaces filled with activities that contribute to the holistic development & collective healing of our communities."

RECOMMENDATION

Staff recommends that the Park and Recreation Advisory Commission approve 'Oakland Carnival Festival' to solicit fees for vendor registration, and food, concessions and sales of goods and wares by vendors for the 2018 event. Providing that this event meets the requirements of OPD and outstanding documents and payments have been submitted to OPRYD.

Staff recommends that Oakland Carnival producers provide at least 3 portable restrooms, one of which is ADA accessible, and 2 handwashing stations, one of which is ADA accessible.

Below is a list of outstanding requirements needed to complete OPRYD paperwork. Information to OPR should be submitted no later than May 2, 2018, by 5pm in order to complete facility permit.

- Merged into one co-ed club in the 1980's.








- At the OLBC we have an elected board of directors and appointed committees.

Revival of OLBC


- Since 2013 their has been a revival of the OLBC.


Group Lessons
