#### **SUMMARY**

This informational report requests support from PRAC for a minor Conditional Use Permit (CUP) to install fitness equipment and a water fountain along Courtland Creek Park. Courtland Creek Park is a linear park in East Oakland parallel to High Street, Brookdale Avenue, Thompson Street, and Courtland Avenue.

The installation of these items is the result of coordination with City of Oakland staff from the Oakland Public Works (OPW) Watershed and Stormwater Management Division (WSMD) and the Oakland Parks, Recreation, and Youth Development (OPRYD) department. An application for a minor conditional use permit, as required by Sections 17.11.060 and 17.11.090, will be considered by the Parks and Recreation Advisory Commission before a final decision by the Director of City Planning.

#### BACKGROUND / LEGISLATIVE HISTORY

On January 8, 2025, OPRYD presented a report to PRAC to support a minor conditional use permit. That report included a total of \$250,000. After consulting with Oakland Public Works Projects and the Grant Management team, the \$250,000 was the total cost for all projects at the site, including the installation of fitness equipment, a water fountain, and repaving a basketball court. The presentation and follow-up on April 9, 2025, did not clearly explain the budget for the fitness equipment and water fill station project. This report provides a more detailed description of the fitness equipment and water fill station budget.

### PROJECT / PROGRAM DESCRIPTION

The fitness equipment and water fill station project aims to connect the community with nature-based recreational amenities in the park. Installing fitness equipment and a water fountain is part of the park's broader Courtland Creek Restoration Project. The project elements will enhance the park for users in the following ways.

- 1) Enhance park usage.
- 2) Provide access for people of all ages and abilities.
- 3) Enhance the park by adding recreational activities.

### **FISCAL IMPACT**

This Capital Improvement Project is fully funded through the City of Oakland's Measure Q parcel tax. The budget for the Courtland Creek project as a whole is \$250,000 (the basketball repaving project is \$75,000 of the \$250K). The budget for purchasing and installing fitness equipment and a water-fill station is \$175,000. The cost estimate/quote breakdown is as follows:

- Gametime fitness equipment is only \$30,328.
- The water Fill Station quote is \$11,926.00.
- Fitness Equipment + Water Fill Station = \$42,254.
- Installation of Fitness Equipment and Water Fill Station = \$48,669.
- Totals of Subtotal (\$90,923) Discount (4,852.48) + Material Surcharge (\$909.84) +Freight (\$2,678.77) + Tax (\$3,138.06) = \$92,797.19.
- Construction management is estimated to account for 20% of the project (\$92,797.19), \$18,559.43.
- Project management is estimated at 25% of the project cost (\$92,797.19), totaling \$23,199.
- The total estimated cost for the project (\$92,797.19 + \$18,559.43 + \$23,199) = \$134,252.62.



### **SUMMARY**

Oakland Parks, Recreation & Youth Development (OPRYD), in partnership with the Fam 1st Family Foundation (F1FF), proposes a significant enhancement of recreational assets at DeFremery Park, located at 1651 Adeline Street in Oakland, California. This proposal includes the acceptance of a gift-in-place donation of forty-nine thousand, seven hundred and fifty dollars (\$49,750) from the Jordan Brand to resurface the basketball court, as well as authorization to enter into a Right of Entry contract with Project Backboard (construction vendor).

Founded in 2011, F1FF is a non-profit organization committed to expanding opportunities for underserved youth in Oakland and beyond through sports and family support services. F1FF leverages sports as a platform to teach critical life skills, including adaptability, resilience, and determination. Since early 2025, OPRYD staff have been in active collaboration with F1FF representatives—Oakland natives Joshua Johnson and Marshawn Lynch—to identify impactful recreation projects and recreation site improvements. These discussions have centered on how philanthropic investments can enhance public park facilities and community experiences.

### BACKGROUND / LEGISLATIVE HISTORY

On March 18, 2025, OPRYD, Josh, and Marshawn met to explore upgrades to Oakland Parks and Recreation facilities, including repaying outdoor basketball courts. On March 21, 2025, OPRYD held an internal meeting to identify which sites would benefit from donations from F1FF.

Recently, Josh mentioned that the Jordan Brand was interested in funding the repaving of the DeFremery Park basketball court. Jordan Brand supports community organizations like F1FF to enhance outdoor spaces in urban areas. Thanks to F1FF's efforts, Jordan Brand agreed to donate funds for the repaying project at DeFremery Park. OPRYD and F1FF believe this contribution will enhance an essential asset in West Oakland.

This project involves collaboration between Fam 1st Foundation, Project Backboard, OPRYD, Panther Skate, and the Jordan Brand. Project Backboard is the vendor responsible for resurfacing the court. Panther Skate is an organization that uses the court weekly for roller skating activities. The group's purpose is to create a safe, inclusive, and accessible space for roller skaters of all identities, ages, and abilities, organized by the community for youth, while contributing to the rich history of

West Oakland and DeFremery Park. All the organizations quickly came together to improve an OPRYD facility. Following the project's completion, a ribbon-cutting ceremony will be held.

### PROJECT / PROGRAM DESCRIPTION

OPRYD usually funds improvements to recreation centers and fields through infrastructure bonds and state or federal grants. These funds go through the Oakland Public Works Projects and Grant Management (PGM) team. While this approach is standard and necessary, OPRYD constantly seeks additional funding sources. The improvement at DeFremery Park will allow OPRYD to better serve the City of Oakland by providing a facility that meets the needs of the West Oakland community. Earlier this year, a park assessment confirmed that the DeFremery basketball court needed resurfacing. This project will address this deficiency.

On May 21, 2025, OPRYD met with the Jordan Foundation, Project Backboard, Panther Skate, and F1FF at DeFremery Park to evaluate the site and discuss the project. During this meeting, the Jordan Brand representatives presented the plan to resurface the court by filling cracks, patching low areas, applying asphalt, and adding a color coat. The project will also include new basketball backboards and rims. After installation, Oakland Public Works (OPW) will maintain the site. The project timeline is as follows:

- PRAC meeting with anticipated support/approval June 11, 2025
- Start of resurfacing June 20, 2025
- Installation of striping July 7, 2025
- Ribbon cutting/rededication/Fam 1st Celebration July 11, 2025

#### FISCAL IMPACT

The City of Oakland has managed a process for identifying infrastructure improvements for several years. Various groups submitted proposals for upgrades to the City of Oakland Capital Improvements Projects (CIP) team. OPRYD focused on improving recreation centers and sports fields. Recently, the CIP team stopped accepting new proposals. Due to this change, OPRYD is exploring alternative funding options for capital projects. The partnership with F1FF and its resources provides another funding option for these essential improvements. This project will not have a negative fiscal impact on the City of Oakland.

### PUBLIC OUTREACH / INTEREST

OPRYD has communicated with Panther Skate Plaza, the roller-skating group that utilizes the courts for its activities. They attended the onsite meeting on May 21, 2025, and provided valuable insights into how participants use the courts. DeFremery Center Director Greg McClain supports this project. This project aims to enhance the safety of a park asset, which is expected to increase its usage following the upgrade.

### **COORDINATION**

This project is a collaborative effort involving the Jordan Brand, F1FF, Project Backboard, Panther Skate, OPRYD, and the OPW Facilities Services Division.

### **RECOMMENDATION**

Oakland Parks, Recreation & Youth Development (OPRYD) recommends that the Parks and Recreation Advisory Council support a gift-in-place donation not to exceed forty-nine thousand

seven hundred fifty dollars (\$49,750) from the Jordan Brand and a Right of Entry agreement between OPRYD and the Jordan Brand for the resurfacing of the basketball court at DeFremery Park.







- Court Resurfacing & Base Coating
  - Scrape and coat entire surface with two (2) coats of acrylic resurfacer (Sport Master or equivalent).
  - Let surface cure.
  - Apply at least two (2) coats of acrylic sports specific color coating (Sport Master or equivalent) to the basketball courts only in accordance with the base coat requirements of final approved design.
- Court Game Line Installation
  - Stripe courts with textured acrylic with line paint
  - Let cure 2 days(can be less or more depending on weather).
- Remove four old basketball rims and backboards and install four new rims and backboards.
- Prime and paint backboard posts.

Re: Recommendations on the Proposed FY 2025-27 Proposed Policy Budget

As members of the Parks and Recreation Advisory Commission (PRAC), we are writing to convey our thoughts about the proposed FY 2025-2027 budget. Given our reading of the preliminary budget, we have questions and concerns about how Measure Q money will be allocated for the upcoming fiscal years and how various OPRYD functions will be funded.

PRAC consists of Oakland residents appointed by the Mayor's Office and approved by the City Council. We are responsible for advising the Mayor, City Council, OPRYD and City Administrator on policy and operations of the City's parks and recreation system. Another one of our key responsibilities is oversight of Measure Q, as assigned to us by the City Council in 2020 (Ordinance 13622 CMS). We volunteer our time and expertise out of a deep recognition of the role that parks and recreation play in the wellbeing and health of our communities.

As the Budget Advisory Committee recommends in their letter for the May 28, 2025 budget meeting ("Recommendations on FY2025-7 Proposed Policy Budget,"), PRAC strongly endorses the view that City Council should prioritize the use of general purpose funds to comply with mandatory voter-approved items such as Measure Q. These ballot measures reflect core community priorities and legal mandates and should be prioritized over other initiatives to the extent possible.

### **Measure Q Related Funding Priorities:**

1) Unrelated Expenses continue to be allocated to Measure Q: In the last budget cycle, we noted that the City's administrative, analyst and managerial positions unrelated to maintaining parks and recreation services were allocated to Measure Q as detailed in our June 14, 2024 letter. In the current budget cycle none of these expenses have been transferred to their proper department nor deleted and instead have become part of the baseline Measure Q budget. These expenses should not be allocated to Measure Q and much-needed positions such as gardners and equipment operators that are currently frozen should be funded instead (see item 6, below).

**2) Maintenance of Effort** (MOE): The MOE is a mechanism to ensure that the revenues raised are used for the purposes that voters approved. This serves, in effect, to safeguard the City's promise to voters.

Measure Q allows up to 55% of revenues for parks to be used for existing park maintenance. The remainder must be used for new parks and recreation services. Measure Q revenues have grown from \$25,814,627 in FY 2020-21 to \$34,141,547 in FY 2025-26 and \$35,097,510 in FY 2026-27, yet despite this revenue growth the City is not meeting the MOE for Parks, Landscape Maintenance, and Recreational Services.

Under the Extreme FIscal Necessity resolution the City did not meet MOE levels in the FY 2023-2024 budget, and this proposed budget looks to set MOE spending at 65%. The effect of this is that about \$2.2 million in Measure Q funds will be diverted from being spent on new park initiatives and will be spent instead on maintenance, which contravenes the dictates of the Measure. We are aware that a financial stabilization plan is underway which is expected to be completed by year end. As we understand it, this plan would restore proper MOE levels to Measure Q and other affected ballot measures. We hope that this stabilization plan will go into effect in time for the FY 2026-27 budget and ask that PRAC be kept apprised of its progress through periodic informational reports.

- **3) Extreme Fiscal Necessity definition:** For the past year, a group of ballot measure stakeholders have been advocating for the creation of a definition of "extreme fiscal necessity" in order to set some parameters around its invocation and duration. We have been working with DCA Monica Davis and Budget Administrator Bradley Johnson on this and understand that they will be placing an item on the June 3 agenda addressing this topic.
- **4)** The required City Auditor's Audit: Measure Q Section 5-B states: "The City Auditor shall perform a biennial audit to assure accountability and proper disbursement of all proceeds collected by the City from the special tax." The Auditor did complete the FY 2020-2022 Audit, but does not have the staff capacity to do the FY 2022-24 Audit that is critical to assuring the Ballot Measure requirements are met. This effort requires funding to move forward.
- **5) Annual Financial Audit:** The City Auditor recommended that an Annual Financial Audit be conducted in the FY 2020-2022 audit, and the City Administration agreed it would commence in 2025. An outside firm was contracted to provide those services for a number of Measures; however, the contract did not include Measure Q. Though this omission was addressed in a supplemental report, it has not been formally added to the contract. We request that the Measure Q audit be officially added to the vendor contract; otherwise, it may have the propensity to fall through the cracks and will require ongoing monitoring by PRAC to ensure that it does not.
- **6) Staffing:** A number of positions frozen in OPW Parks, Trees, and facilities are impacting the Department's ability to meet the Measure Q mandated levels of field mowing, trash pickup, and bathroom cleaning. If the following Measure Q-funded positions were to be filled, these

requirements would largely meet the minimum performance levels that have been established for these maintenance activities.

- a) Mowing: One Park Equipment Operator (currently a frozen position from the mid-cycle budget)
- b) Trash: Three additional gardeners needed (there are currently six frozen positions from the mid-cycle budget).
- c) Bathroom cleaning: Two custodians needed (positions are currently awaiting Finance Committee approval).

### **OPRYD Funding Priorities:**

PRAC believes providing proper funding levels for after-school programs and Town Camp is an absolute necessity. The proposed FY 2025-27 budget deletes 6.54 FTE and freezes 17.71 FTE from recreation and service programs. The explanatory note states that there is no service impact as the positions were vacant. We find that that statement takes too narrow a view. OPRYD determined that these positions were necessary to properly meet the community's needs. The impact is, in fact, that the lower level of services will continue, and the community will continue to be underserved. This translates to some combination of fewer programs, reduced hours, fewer locations, and/or a reduction in enrollees.

This is particularly important because both these programs are essential to the well-being of Oakland families, and any diminishment or cancellation of them will create undue hardships and cascading adverse effects for Oakland families. Public safety is a major driving force for many Oakland residents and elected officials, and reducing these programs may ultimately reduce public safety in Oakland. As the National League of Cities' Public Safety Brief states, after-school programs can provide a return of \$3-\$13 for every dollar invested by generating higher incomes and lowering crime rates. Comprehensive after-school/mentoring programs can decrease violent crime arrests by 44% and vandalism and weapons crimes by 36% for youth. Therefore, preserving funding and expanding the above programs can significantly increase public safety for residents and certaining how they feel about this important issue. It is money well spent.

We acknowledge the challenges that City leadership faces in this difficult budget cycle and all that you are doing to right the ship. Given the financial constraints, we understand that trade-offs must be made to produce a balanced budget, a difficult task given the many critical needs in Oakland. We appreciate your hard work and thoughtfulness to that end and look forward to hearing your thoughts on the topics raised in this letter.
