SUMMARY

This report provides updates on delivery of Measure Q-funded park services through the second quarter of Fiscal Year 2025/2026 (October 1-December 31).

BACKGROUND / LEGISLATIVE HISTORY

Measure Q, approved by Oakland voters in March 2020, provides funding for parks maintenance, homelessness services, and water quality. The City Council assigned PRAC the oversight role regarding the Measure Q expenditures related to parks maintenance and water quality services. As a component of this oversight function, OPW routinely submits updates to PRAC.

STATEMENT OF THE ISSUE

This report covers Quarters 1 and 2 of Fiscal Year 2025/2026 from July 1, 2025, to December 31, 2025. The Q2 reporting format continues the use of color coding within the tables to indicate where OPW is meeting or falling short of targets. Per PRAC’s suggestion, the narrative analysis has been simplified to *target*, *results/variances*, and *addressing variances*. Similarly, this Q2 report includes equity analysis where the disparities between parks’ maintenance in equity priority neighborhoods (versus others) are identified. Parks with an asterisk (*) in the tables at Attachment A, B, C, and D are in high priority equity neighborhoods based on [OakDOT’s Geographic Equity Toolbox](https://www.oaklandca.gov/resources/oakdot-geographic-equity-toolbox) (available at <https://www.oaklandca.gov/resources/oakdot-geographic-equity-toolbox>) and parks with ** are in highest priority equity neighborhoods.

Staff seek PRAC’s input on this report and its analysis.

1. **Dedicated Staffing Per Park:** Measure Q Section 3(B)(1)(m): “Providing dedicated staff at major parks. ‘Major Parks’ means City operated Community Parks, Region-serving parks, and Resource Conservation Areas, as those terms are used in the Open Space Conservation & Recreation (OSCAR) Element of the Oakland General Plan.”

Target: Staff define Measure Q’s dedicated staffing goal as at least one full-time equivalent (FTE) devoted per month at each major park. Staff also developed a preliminary industry standard for number of parks maintenance FTEs per acre of park maintained. In 2008, the International City/County Management Association recommended a best practice of one park maintenance staff member per 12 acres of parkland and indicated a higher ratio if population density is higher. Oakland has a high population density and its parks face frequent illegal dumping, so staff adjusted the industry standard to one park maintenance staff per 10 acres. The park assessments will re-evaluate whether this is the right standard and, if not, recommend a new one.

To approximate FTEs per major park, staff track total labor hours worked by staff at each major park. Then these total labor hours per park are converted into a FTE count per park by dividing the total work hours per park by the number of hours a FTE works per month. This results in an approximate number of FTEs per park per month.

Results/Variations: Attachment A shows the results. Q2 averages show that eight of the 11 major parks are meeting both the Measure Q-derived target of one FTE per major park and the industry standard target. Three of the parks are meeting the Measure Q-derived target but not the industry standard target.

Addressing variations: The City’s two largest parks are meeting the Measure Q target but not meeting the industry standard target. This is consistent with Q1. The development of parks assessments will address the maintenance needs of these region-serving parks and, if gaps exist, consider approaches to addressing these gaps.

2. **Ballfield Mowing:** Measure Q Section 3(B)(1)(a): “Mowing City operated sports fields frequently, every other week, or as may be required by the time of year.”

The Parks and Trees Division in Public Works’ Bureau of the Environment is responsible for ballfield mowing. Measure Q sets a priority to mow “frequently” and defines frequently as every other week (or roughly two times per month), or “as [frequently as] it may be required by the time of year.”

Target: Public Works sets a mowing target based on time of the year. During the off peak (or rainy) season from November to March, rain is likely, turf growth is slowed, and ballfields are used less, thus mowing is less frequent. Staff’s goal in the off-peak season is one mow per month at each field.

Peak (or dry) season is April to October. Rain is unlikely, turf growth is higher, ballfield use increases, and mowing is, and should be, occurring regularly. Measure Q says mowing should be occurring “every other week.” In peak season, staff’s target is mowing ballfields twice per month.

Results/Variations: Attachment B shows the results. Q2 includes October, which is peak season, and November and December, which are off-peak. For Q2, the average of citywide mows exceeded monthly targets. For individual parks, 77-93% are meeting the monthly mow target.

Addressing variations: The data suggest that another 10 mows per month would enable every individual park to meet the Measure Q goal. Staff estimate that the one additional Park Equipment Operator is sufficient to ensure these 10 mows per month. As of June 2024, Measure Q funded seven Park Equipment Operators, six of which were filled and one vacant. The midcycle budget froze the vacant Equipment Operator position. Filling this frozen position would achieve the Measure Q-derived mowing goal for every ballfield at every park. (Note the seventh Park Operator is slated to

be unfrozen this spring pending mid-cycle budget decisions. If the unfreezing is approved, Parks will begin to onboard an additional staffer July 2026 at the very earliest).

3. Trash and Litter: Measure Q Section 3(B)(1)(b): “Collecting trash and litter several times per week, including Saturdays and Sundays, from the City’s most used parks, assuring equitable distribution of resources...”

Staff define the City’s most used parks as the community parks and regional-serving parks in the General Plan’s OSCAR element. Trash cans are emptied and litter removed at these parks every Monday and Friday by the Bureau of Environment’s Parks and Trees Division.

Target: Staff set two goals for trash and litter pickup. The baseline goal is emptying of cans and picking up litter two times per week (or eight times per month). To derive a Measure Q goal, staff took the baseline goal of two pickups per week, added a pickup on Saturday and Sunday to reflect Measure Q’s language “including Saturdays and Sundays...”, and then included an overall completion rate of 75% of the time. This Measure Q-derived goal translates into three or more weekly pickups (four pickups multiplied by 75%) at the most used parks.

Results/Variations: Attachment C shows the results. In Q2, staff emptied an average of 1,620 trash cans monthly, a couple hundred short of the baseline goal of 1,888 per month and well below the Measure Q-derived goal of 2,832 per month.

Addressing variations: Staff estimate an additional Gardener can empty an average of 560 cans per month. Based on this estimate, hiring at least three Gardeners should enable staff to meet the Measure Q-derived goal for trash can emptying. There are currently fourteen existing Gardener vacancies, however the recruitment for those positions is progressing slowly given limited resources in the city’s Department of Human Resources Management (DHRM). While awaiting the full recruitment, DHRM is supporting the hiring of nine limited duration Gardeners that have an approximate start date of the third week in March. The limited duration Gardeners will fill positions until an analyst is available to process the recruitment and those staff may compete for the permanent positions.

4. Restroom Cleaning: Measure Q Section 3(B)(1)(e): “Cleaning Park Restrooms more than once per day, especially on weekends.”

The Facilities Services Division of Public Works’ Bureau of Maintenance and Internal Services is responsible for outdoor restroom cleaning. A custodial unit is dedicated to outside restrooms and pools. Five Custodians are currently funded by Measure Q.

Target: Staff set a baseline goal of cleaning every parks’ outdoor restroom once per day. To derive a Measure Q goal, staff considered the ballot text’s language to clean park restrooms “more than once per day, especially on weekends.” Staff set a target of twice per day cleanings including weekends and then included the goal of meeting this twice-per-day standard 80% of the time.

Each cleaning count represents the restroom or restrooms being cleaned at the listed location. Where only one bathroom exists at a location, one count equals one restroom cleaning. In locations with

multiple restrooms, one count represents multiple restrooms being cleaned. No reporting is provided for the cleanings of parks restrooms that are closed or operate only seasonally or by event. These include Arroyo Viejo** (McConnell Field), Caldecott, Carter Gilmore**, DeFremery**, Joaquin Miller-Sequoia Arena, Lafayette Park**, Oakport Field*, Otis Spunkmeyer Field*, Raimondi, Officer Willie Wilkins*, Willow Park*, and Woodminster.

Results/Variations: Attachment D shows the results. In Q2, average citywide restroom cleaning counts exceeded the baseline goal. However, those citywide restroom cleaning counts continue to fall short of the Measure Q-derived goal. The citywide shortfall averaged 614 cleaning per month.

Addressing variations: Staff estimate that one custodian can clean 14 restrooms per day, which equates to ~280 cleanings per month. By hiring 3 more custodians, staff would regularly meet the Measure Q-derived goal. There is currently one vacant frozen Measure Q-funded custodian positions for outdoor restrooms. OPW will work to unfreeze this position in the spring and continue to request additional Measure Q-funded custodian positions be budgeted.

RECOMMENDATION

OPW recommends that PRAC receive this informational report.

SUMMARY

Oakland Parks, Recreation & Youth Development received a request from the American Brain Tumor Association, a non-profit organization whose mission is to advance the understanding and treatment of brain tumors with the goals of improving, extending and, ultimately, saving the lives of those impacted by a brain tumor diagnosis. The American Brain Tumor Association is requesting approval to collect on-site registration fees at the BT5K Run/Walk. The applicant is aware of the additional permits required. Approval from the Parks and Recreation Advisory Commission is required per O.M.C. section 12.64.080.

BACKGROUND / LEGISLATIVE HISTORY RECOMMENDATION

SUBJECT: REQUEST FOR THE PARKS AND RECREATION ADVISORY COMMISSION TO APPROVE A GIFT-IN-PLACE DONATION FOR FORTY-SEVEN THOUSAND DOLLARS (\$47,000.00) FROM FRIENDS OF JOAQUIN MILLER PARK (FOJMP) FOR THE INSTALLATION OF RUSTIC FENCING TO PROTECT THE REDWOODS AT JOAQUIN MILLER PARK AND THE REPLACEMENT OF SIGNAGE THROUGHOUT THE PARK

SUMMARY

Coast redwoods (*Sequoia sempervirens*) are iconic to California, and those still standing in Oakland are symbols of resilience. Our redwood forest was first harvested in the mid-1840s and perhaps again after the 1906 earthquake when resources were scarce. Then, in the 1920s, the City of Oakland began acquiring the redwood forest that is now Joaquin Miller Park (JMP). We enjoy access to their beauty and solitude today because of the seedbank and sprouts that sprang from the original ancient trees. But in many areas of the redwood forest, it is being overused. Especially in the expansive, flatter grove areas along Skyline Blvd, where public access is easy, the forest floor is trampled and compacted to bare mineral soil, with no build-up of duff or an organic soil layer (see Exhibit A).

Oakland Trails, in partnership with Friends of Sausal Creek (FOSC) and Friends of Joaquin Miller Park (FOJMP), is seeking PRAC approval to protect selected stands of redwood trees and important understory populations of huckleberry and sword ferns by installing ~120-foot sections of rustic, split-rail cedar fencing. The fencing would allow forest litter and the organic soil layer to naturalize over time, greatly improving the health of the trees and understory, while still providing park visitors with close access to the majestic trees.

In addition to the fencing, trail signs at Joaquin Miller Park have disappeared. FOJMP, in association with Oakland Trails and the primary stakeholders of JMP, is requesting PRAC permission to replace missing trail markers, to establish new primary trailhead signs with city ordinances/rules documented, and to place environmentally protective signs in sensitive redwood groves, as preventive measures against further forest destruction. In addition, FOJMP is requesting permission to replace any vandalized and deliberately removed park signs in the foreseeable future or until the city of Oakland re-establishes a formal ranger or park restoration and rehabilitation plan.

The following provides an overview of trails and trail usage at JMP:

- Unprecedented and unchecked bootleg trail-use in the Big Trees Area of JMP has been increasing since the 2009 decision to remove park rangers. Moreover, a sprawling web of rogue trails has been cut through the sensitive redwood forest, leading to catastrophic deforestation and destruction of redwoods in the Oakland hills.

- Current maps are obsolete and no longer published or available for park users
- Due to vandalism and sign removal, limited signage exists in the park directing park users, which further promotes off-trail wandering and unsanctioned trail use/construction.
- Additionally, in the absence of Ranger presence to participate in trail use and removal or defacement of signs, current and future replacement is required and urgently needed for the protection of the redwood forest.
- The primary concern is that the native plant communities of the forest floor of JMP are being obliterated by off-trail mountain biking, hikers, and day campers. At the same time, the topsoil is being pulverized and compacted.

BACKGROUND / LEGISLATIVE HISTORY

Since at least 2008, PRAC has approved the installation of split-rail cedar fencing in Joaquin Miller Park. Past uses have included delineating trails and trailheads. This is the first known request for approval of rustic fencing for purely ecological protection and/or restoration.

In 2009, the City of Oakland adopted a budget that discontinued the Park Ranger Unit, whose mission was to improve the quality and safety of Oakland's parks for community enjoyment and to serve as a resource for park patrons. The Rangers accomplished this mission in part by educating park users and enforcing park rules and City ordinances. In the absence of the Rangers, the need for community engagement and volunteerism was more critical than ever. In an attempt to mitigate some of the negative impacts associated with the loss of the Rangers, the City encouraged engagement through volunteer groups and organizations identified by OPRYD as stakeholders whose missions and focus are aligned with OPRYD and are to support positive activity in the park and support the City's efforts to maintain the 500-plus acres of Joaquin Miller Park. **Unlawful sign removal, sign defacing, new trail building, and Redwood tree and branch cutting for trail clearing are ongoing in Joaquin Miller Park. For the purpose of delineating the definition of stakeholders now responsible for JMP, these groups include, but are not limited to, FOJMP, Oakland Trails, FOOSC, Bicycle Trails Council of the East Bay (BTCEB), Metropolitan Horsemen Association (MHA), and others, such as "Sogorea te' Land Trust".

****12.64.090 - Injuring trees and other properties.**

It is unlawful for any person to trespass upon the grass of any public park in the city or to pick flowers from the same, or to cut, break or in anywise injure, damage or deface the trees, shrubs, turf, buildings, fences, benches, fountains, statuary or any fixtures connected therewith, or to foul any fountains or springs within said park.

PROJECT / PROGRAM DESCRIPTION

Selected stands of redwood trees would be identified for protection by Oakland Trails and/or Friends and Sausal Creek specialists. The amount of fencing needed depends on the size of the selected stand, but the stand in Exhibit A, which would require 120 feet of fencing, is representative of the typical size and scope of each project site.

The projects would be funded by non-profit organizations and installed by volunteers under Oakland Public Works Adopt-a-Spot agreements. Oakland Trails will advise all involved volunteer groups on fence installation protocols and standards (fence types, post depths, attachments, etc.).

The finished project would appear as Exhibit B, with rustic fencing following the contours of the stand (as in a recent treatment in nearby Roberts Park).

The sign replacement project would be in four parts and would be installed by volunteers under Oakland Public Works Adopt-A-Spot agreements. Friends of Joaquin Miller will advise all involved volunteer groups on sign replacement and installation protocols and standards. The locations of the new sanctioned trailhead signs are shown on the JMP map below (Exhibit C).

- **Replacements for Big Trees posts. Type: see example #1 below on Page 10.**
- **Replace all trail directional posts. Type: see example #2 below on Page 11.**
- **New sensitive nature-protection signs will be placed in various locations where maximum deforestation is present. Type: see example # 3 below on Page 13.**
- **Installation of trail head signs with city ordinances posted throughout JMP Type: see example #4 on Page 15.**
- **Refer to Exhibit A, JMP Trail map below (Page 9) and the list of current sanctioned trails JMP, where new city ordinance signs will be placed at each trail head.**

Campground Signs is the vendor creating the signs seen on pages 13 and 14. The company website is at: [Campground Signs - 100s of Camping Signs and Campsite Signs!](#). The vendor for all park trail directional signs will be local lumber, such as Ashby lumber, and Oakland Trails will design the signs as per the existing trail posts. The vendor for the new city ordinance trail signs is to be determined (example #4 on page 15), but will be paid for by FOJMP. Since similar trailhead signs for Montclair RR were produced and installed by OPRYD, stakeholders would request similar support.

FISCAL IMPACT

There would be no fiscal impact on the City. The proposed protective fencing would cost roughly \$17,500 and would be funded, installed, and maintained by volunteers as an ongoing project, with resources provided as they become available.

FOJMP would pay for signage. Sign installation and maintenance would be handled by volunteers as an ongoing project, as resources are provided. The total value of the sign replacement project funded by volunteers is estimated to be \$29,500. Volunteers will provide maintenance for the signs at no cost to the city throughout the year.

PUBLIC OUTREACH / INTEREST

This project was proposed by Stan Dodson (Oakland Trails) at the February 2, 2026, Friends of Joaquin Miller Park board meeting. The additional project for sign replacement was proposed by Megan Palsa to the City of Oakland and Quincy Williams and endorsed by Dale Riden at the Friends of Joaquin Miller Park board meeting.

Stan Dodson and Gary McCormick (Oakland Trails) met with Dr. Rob Leidy (Friends of Sausal Creek) on site to plan the project scope, including installing approximately 120-foot sections of split-rail cedar fencing to protect redwood stands and patches of sword ferns and huckleberry.

Dale Riden FOJMP, Gary McCormick (Oakland Trails), and Oakland citizen Megan Palsa identified the current trails in JMP that need signs (either new or replacement) and identified sensitive Redwood sections that will need protective environmental educational signs.

On March 2, 2026, FOJMP voted to approve the PRAC-approved project (Big Tree Fence Installation and Park Signage Replacement).

COORDINATION

This project is a collaborative effort between the City of Oakland Parks, Recreation, and Youth Development (OPRYD), Friends of Joaquin Miller Park (FOJMP), Oakland Trails, Oakland Public Works (OPW) – Environmental Services Division, and Park Services. OPW staff will provide technical guidance on fence and sign installation, while FOJMP will manage implementation, contractor engagement, and maintenance for both the fencing and signs.

OPRYD has contacted the City of Oakland Planning Division to review this project. The following is their review of this project. “This falls under the category of benches and street furniture, the sum of which is less than 100 square feet. It's not a perfect fit, but it's under Accessory, and this is clearly an accessory use. In any event, those are permitted and do not require a zoning permit.” Neither of these projects will trigger a minor conditional use permit.

RECOMMENDATION

Staff recommends that the Park and Recreation Advisory Commission support a gift-in-place donation of forty-seven thousand dollars (\$47,000.00) from the Friends of Joaquin Miller Park (FOJMP) project for the installation of rustic fencing to protect the Redwoods at Joaquin Miller Park and replace trailhead signs.



Map of Redwoods SD Project Fencing







We are happy to support this opportunity to work with the City of Oakland to keep Joaquin Miller Park in good condition.


