- 1. Welcome/ Roll Call / Meeting called to order at 5:40 p.m. PAAC Chair Eric Murphy called the meeting to order and read the Cultural Affairs Commission/Public Art Advisory Committee Land Acknowledgment.
- 2. Public Comment: No comment was provided.

PAAC 6-3-24 Item III

- 3. Action Item: Adopt the Minutes from the May 6, 2024 Public Art Advisory Committee Meeting. K. Kushner motioned to approve the minutes. M. Guillard seconded; M. Navasero Aye; K. Leventi Aye. Motion passed unanimously.
- 4. Informational Item: Public Art Program Plan Update Public Art Coordinator Kristen Zaremba briefly discussed the City of Oakland's budget deficit, including the status of existing and uncommitted public art funds. Zaremba shared details from a report Cultural Affairs Division staff presented to the City Council Life Enrichment Committee meeting on May 14th. Zaremba subsequently provided an overview of the Public Art Program Activities Report and Projects Plan draft. She articulated the historical foundation for the projects plan, the program goals and recommendations identified in the City Council-adopted Cultural Plan in 2018, the program's staffing needs, and the proposed designation of public art funds for future projects, collections' management, and program administration. Zaremba discussed the importance of further analysis and mapping of the Civic art collection for equitable investment across all the sectors of the city. Additionally, the report provides an overview of recently completed, new and continuing projects, the proposed public art project account fund balance allocation, and a public art financial budget summary for fiscal year 2024-2025. Committee members offered comments and questions regarding collections management databases, collection assessments, program website management, project documentation, the importance of preservation and the securing of program staff, and collaboration with city officials for public art commissions in their districts. The plan will be finalized with the PAAC in July, then presented to City Council for approval. Zaremba shared publication materials and information about the previous Open Proposals initiative through the City of Oakland's Public Art Program, which offered funding for artists to propose projects on City property, and the Public Art Program's intention to use this model for new commissions not associated with capital projects. Committee members showed support for this structure and suggested localized panels and collaboration with Council members where appropriate.
- 5. Informational Item: Public Art Coordinator Updates on Current Projects / Program Activity a. Public Art Program Administration:
 - Staff shared consolidation revisions to the Public Art Program website.
 Committee members suggested adding supplemental photos to enhance the visual experience of the website.
 - ii. Staff shared the Public Art Program ordinance's location on the website.
 - b. City of Oakland Budget Update: Zaremba shared information on future budget discussions and resources on how to learn more about understanding the budget. Staff shared that there will be a special Cultural Affairs Commission Meeting on 6/13 to discuss the budget updates and how it impacts the work of the Division. PAAC members are welcome to attend the meeting.
 - c. **PAAC Recruitment:** Zaremba encouraged members to review the expertise matrix and to think about possible future PAAC members. Staff will focus on PAAC recruitment after the artist recruitment initiative has been launched.
 - d. **Public Art in Private Development**: Staff shared an update on the Affordable Housing Month workshop and progress on the 24th and Waverly housing development, which includes a public art project by Marc Fornes, currently being installed.
 - e. Cultural Strategist in Government Update: Staff shared that recommendation letters

- have been sent to artists who completed the CSIG workshop series. The CSIG program report is now available on the CAD website.
- f. **Artist Recruitment Update:** Staff updated the committee that the RFQ schedule will be postponed by a few weeks to the end of the month, shared the current outreach plan and asked committee members to share additional outlets for distribution and to think about review panel recommendations.
- **6. Open Forum:** No speakers
- **7. Announcements:** K. Kushner shared that *Calli: The Art of Xicanx Peoples* exhibition will open at the Oakland Museum of California on June 14th. E. Murphy and K. Kushner shared that they have new artist studios at Studio 11 in Jack London Square. E. Murphy will be exhibiting at Studio One 11:00-3:30 on June 9th. M. Navasero will have a solo exhibit at the Doherty Community Arts Center on Saturday June 8th, 1:00-3:00 pm.

Zaremba encouraged Committee members to ask detailed questions about the plan and endorse the plan during City Council presentations. Zaremba answered questions from Committee members regarding project description pages, Mosswood Park public art planning, and the cultural civic commons open proposals initiative. Committee members suggested adding more details about upcoming projects. Staff confirmed more detail will be added to

- CIP project descriptions prior to presenting to Council. **Motion:** K. Leventi moved to approve the 2024-25 Public Art Project Plan Final Draft for Presentation to City Council, K. Kushner seconded, S. Miller Aye, M. Navasero Aye.
- 5. Informational/Discussion Item: 2024 Public Art Prequalified Artist Roster Staff shared with the Committee that the Public Art Prequalified Artist Roster RFQ opened for applications on July 1st, 2024. Staff shared updates to the program web pages where content from the public art workshops and the Cultural Strategist in Government for public art materials are now available, including a worksheet and video. Staff shared their approach for fostering accessibility and how applicants will submit their credentials for review by a dedicated selection panel. Staff and committee members discussed the selection panel candidate list for the application review. Panelists will be selected based on availability for the panel to be conducted in early September.
- 6. Informational Item: Public Art Coordinator Updates on Current Projects / Program Activity
 - a. **Public Art Program Updates:** Zaremba gave an update on private development projects including Cherry Hill Apartments (District 7 / 95th & International) and Ancora Place (District 5 / 2255 International Blvd.).
 - b. **City of Oakland Budget Update:** Zaremba shared updates on the budget discussions and how the work of the Cultural Affairs Division could be impacted.
 - c. Coordination with Cultural Affairs Commission Meeting: Zaremba shared that the film initiative, City budget, and cultural facilities bond was discussed at the Special Cultural Affairs Commission meeting on June 13th. The final recommendation for a film initiative will be adopted by the City Council as part of the mid-cycle budget.
 - d. Artist-Community Initiated Projects Paint the Town Utility Box Program: Zaremba briefed the Committee on Oakland Department of Transportation's (OakDOT) program for the utility boxes and potential changes to the PAAC design review process, to streamline the requirements for community designed projects without a specific artist's design.
- 7. Open Forum: Gary Knecht, co-founder of the Jack London Improvement District, President of the South of the Nimitz Improvement Council raised awareness about OakDOT's Embarcadero West Rail Safety and Access Project. He asked the Committee to seek more about the project and advocate for public art to be incorporated into the project. Knecht invited the public and the Committee members to attend the upcoming community meeting on July 17th to advocate for public art. Zaremba noted that she was aware of the project and planned to attend the upcoming meeting. Staff will report back on potential public art funding and opportunities at a future meeting.
- **8. Announcements:** Committee member K. Levanti shared information about the Los Angeles Arts and Culture Department's Public Artist's in Development Program, which led to a further discussion about funding from private entities. K. Kushner shared that Eric Murphy will be having a show at his studio in Jack London Square.

SUMMARY

Staff requests the Public Art Advisory Committee (PAAC) receive a report on the Public Art for Private Development proposed artwork for the Native American Health Center (NAHC) located at 3050 International Boulevard, and to provide comments on the public artwork designed for placement on a City owned parcel and in the Public Right of Way, in accordance with Oakland Municipal Code Chapter 15.78 Public Art for Private Development.

BACKGROUND

The project applicant, the Native American Health Center, is commissioning new permanent public artwork to comply with the municipal code requirement for nonresidential development to contribute 1.0 percent and residential development to contribute 0.5 percent of building development costs for public art on their development site. The development is located at 3050 International Boulevard, on a City-owned parcel and within the public right of way, in Council District 5. The public art proposal includes murals and mosaics designed by artists Francisco "Amend" Sanchez and Thomas Wong from Civic Design Studio. See the art plan submittal attached (Item V.b) The artist team was selected through an RFQ and competitive selection process conducted by NAHC, and has worked with SAHA, Lisjan Ohlone leadership and other community stakeholders on developing designs which reflect and honor the NAHC and Fruitvale communities.

The City requires that public art projects intended for placement on City property or within the public right of way be reviewed and approved by the Public Art Program and Public Art Advisory Committee prior to proceeding with all other City permitting requirements. The applicant previously submitted complete public art plans prior to building permit issuance, and subsequent conceptual designs on schedule and as required, and will be responsible for securing relevant permits as part of the larger project.

These artworks to be placed on City property will be documented in accordance with the OMC through permits for improvements in the public right of way and are anticipated to remain the property of and be maintained by the applicant, the Native American Health Center, unless approved otherwise by the City. Agreements for ongoing maintenance for artwork placed in the Public Right of Way will be developed after design approval, prior to installation.

If any project cannot be realized to comply with the all the Oakland Public Art Ordinance and Oakland building codes, the applicants have the option to propose an alternate artwork and/or location, or to make an in-lieu contribution to the Public Art Project Account, prior to issuance of a Certificate of Occupancy from the City for each project.

About Thomas Wong

Thomas Wong is an Oakland-based mixed-media artist and award-winning graphic designer whose large-scale work was recently featured at the entrance of both the Alameda County Government and Oakland Museum buildings. He has been a featured exhibit artist at the Oakland Museum, and has had his work showcased at Yerba Buena Center SF and Yoshi's Jazz Heritage Center. Most recently Thomas orchestrated over 100+ pieces of large scale permanent artwork in Oakland's Brooklyn Basin affordable housing developments. The works include kinetic wind installations, concrete artisanal floor designs, as well as the work of over 100 youth artists across 8 schools. It garnered honors from the 2022 San Francisco International Design Week, as well as the prestigious International Gold Nugget Design Awards.

Thomas' graphic and interactive design work was inducted into the permanent historical archives of the Smithsonian Institute in Washington DC. As a graphic designer he has supported dozens of Bay-Area social justice and community organizations over 15 years.

This and other efforts resulted in a "Best of the East Bay" award for the district in 2012. Artist Statement Civic Design Studio featuring Francisco Sanchez

The public art for Native American Health Center is a creative collaboration between longtime local art and design group Civic Design Studio, led by Thomas Wong, and lead artist and community cultural leader Francisco Sanchez, also widely known as Bay Area mural legend Amend TDK. Francisco grew up in the Fruitvale, has decades of mural, education and community development experience. Civic Design Studio is an internationally award-winning design firm that bridges high-level art production with deep levels of community engagement.

Together Francisco and Civic Design Studio met with NAHC and tribal leaders, staff and community to envision 2 tower designs, as well as concrete floor designs for their new building at 3050 International Boulevard. NAHC has a longstanding and very reputable history in Fruitvale, and see this building as an opportunity to expand their services, impact and importance to their communities, both in the neighborhood and across the region.

For the designs, we pay tribute to our local indigenous tribe, the Lisjan Ohlone, both in the past and future. We spoke with Lisjan leadership as a focus of the thematic design. We also recognize in our work regional tribes across the Bay Area that partner with and come to Native American Health Center.

The location of the building is above Sausal creek, and tributaries run underground throughout the neighborhood. So we all felt that reconnecting to waterways and lifting up indigenous ways of being was a big hope for the future. Leaders and community lifted up these concepts:

- Reconnecting to waterways, canoes
- Tule weaving communities together
- Acorns, strawberries, food and life sustenance
- Abundance, health for the future

Francisco created the visuals with the support of Thomas and Civic Design Studio, which we translated into glass bead tile mosaics. The glass tiles bring a future-forward looking vibrancy, shine and permanency to the artwork, and complement the beautiful architectural designs of Indigenous Architecture firm 7 Directions led by Daniel Glenn. The mosaic incorporates the leadership and community feedback we received through a number of meetings and discussions. We also worked closely with HKIT Architects and Satellite Affordable Housing leaders to make the design cohesive with the building and sidewalks.

We hope our designs bring greater attention and respect to the incredible work and vision of Native American Health Center. It has been an honor and privilege for us to be a part of this groundbreaking project.







Materials and Methods

We will be using glass bead tiles to make our mosaics for the upper tower areas of the building. Samples of glass bead tiles can be found here. Our partner for the tile is Sourcetiles and Trendgroup. Sourcetiles is a local company, works in international tile export, and is based in East Oakland near Fruitvale. Their principal owner also grew up in Fruitvale, and has a commitment to the community he is a part of.

The tile panels come in 24x24 inch squares on which the ¼ in tiles are attached to. Installation will be the same as normal thinset tile on buildings, and we are working with HKIT Architects and NAHC subcontractors to plan the installation on their end. We are not doing the installation ourselves, leaving it up to the professional building contractors, coordinated by NAHC and HKIT.

Maintenance

Glass tile mosaics need little to no maintenance, and can be cleaned as NAHC would the building exterior itself, by power washing. This is per NAHC's operational schedule for building maintenance. There is no color fade or deterioration of the glass tiles itself.

However, the appeal will be limited to issues and/or evidence presented to the Zoning Manager prior to the close of the previously noticed public comment period on the matter.

19. Dust Controls - Construction Related

Requirement: The project applicant shall implement all of the following applicable dust control measures during construction of the project:

- a) Water all exposed surfaces of active construction areas at least twice daily. Watering should be sufficient to prevent airborne dust from leaving the site. Increased watering frequency may be necessary whenever wind speeds exceed 15 miles per hour. Reclaimed water should be used whenever feasible.
- b) Cover all trucks hauling soil, sand, and other loose materials or require all trucks to maintain at least two feet of freeboard (i.e., the minimum required space between the top of the load and the top of the trailer).
- c) All visible mud or dirt track-out onto adjacent public roads shall be removed using wet power vacuum street sweepers at least once per day. The use of dry power sweeping is prohibited.
- d) Limit vehicle speeds on unpaved roads to 15 miles per hour.
- e) All demolition activities (if any) shall be suspended when average wind speeds exceed 20 mph.
- f) All trucks and equipment, including tires, shall be washed off prior to leaving the site.
- g) Site accesses to a distance of 100 feet from the paved road shall be treated with a 6 to 12 inch compacted layer of wood chips, mulch, or gravel.





SUMMARY

Staff recommends that the Public Art Advisory Committee (PAAC) accept the 2024 Public Art Pre-Qualified Artist Roster selection panel's recommendations for upcoming Capital Improvement and City funded public art commissions.

BACKGROUND

The Oakland Public Art Program is developing an artist roster to identify artists to create new public artwork for various projects in parks, plazas, streetscapes and community centers throughout the city, in conjunction with city-funded improvements. Depending on the project opportunity, qualified applicants and artist teams should have demonstrated experience and/or expressed interest working in public art, with an approach to artwork design that translate to public spaces and permanent materials fabricated by the artists or specialty fabricators. Some projects require experience working with community and youth. Budgets for these projects are expected to range from \$40,000 to \$500,000.

Upcoming projects include, but are not limited to the Mosswood Community Center, DeFremery Park, Estuary Park, Lincoln Recreation Center, 14th St. Streetscape Project, City Council funded murals.

SELECTION PROCESS

In July 2024, the Public Art Program issued a Request for Qualifications for a pre-qualified artist roster. Practicing, professional artists or artist teams living or working in the state of California were eligible to submit their qualifications for consideration and possible commission for upcoming public art projects. Staff focused on recruitment to the local artist community, through on-line, social media-based engagement and distribution through local arts organizations. In addition to the public art workshop resources already posted on the City's program website, an on-line application workshop was offered on July 17th, 2024 and posted on the program website for potential applicants who could not attend the workshop to review prior to applying for the roster.

The City received a total of 417 applications to the artist roster. The applicant pool included 63 artists who were guaranteed inclusion in the roster after successfully completing the Cultural Strategist in Government (CSIG) Public Art workshops offered in 2023. Staff reviewed all applications for eligibility and forwarded 298 applications (from a total of 361 eligible applications less the 63 pre-approved CSIG workshops artists) to the selection panel for review. The selection panel reviewed and scored the 298 artist applications in advance and met virtually on Monday, September 16, 2024 to discuss and make final recommendations for the pre-qualified roster.

Voting members of the pre-qualified artist pool selection panel (Attachment B) were local arts representatives Kevin Chen, Independent Curator, Educator and Artist; Mario Navasero, Artist and Public Art Advisory Committee member; and Jennifer Easton, BART Art Manager and Cultural Affairs Commission representative (Attachment B.) Eric Murphy, Joyce Gordon Gallery Director, Artist and Public Art Advisory Committee co-chair, was not able to participate in the panel but provided input on the artist selection. The panel was facilitated by Public Art Program Coordinator Kristen Zaremba and Assistant Public Art Program Coordinator Josie de Mira.

After review and deliberations, the panel recommended 260 artists (Attachment C), based on the selection criteria, to be included in the roster.

Of the 260 artists recommended for the roster, 60% live in Oakland and 40% both live and work in Oakland. Within the field of public art specifically, approximately one half of the 260 artists are considered emerging artists, while the other half are experienced. The list of recommended artists represents a variety of artistic mediums, including murals, sculpture, metal, glass, mosaic and photography.

For projects to be initiated in 2024-2025, a shortlist of eligible artists will be developed and reviewed for each commission by dedicated project-specific panels of artists, City, community, and project stakeholders. Artist finalists will be selected by the project selection panel and be invited to attend a project orientation with City representatives and project stakeholder prior to interviews and proposal development. Final project panel recommendations will be forwarded to the Public Art Advisory Committee for review and final approval before each project commences.

FISCAL IMPACT

There is no fiscal impact at this stage of the recruitment process. Upcoming projects will be funded through the Oakland Percent for Art Ordinance (13562 C.M.S.). Once approved by the PAAC, recommended artists will be considered for individual projects as described above before they may be contracted for design development, fabrication and/or installation of final artwork. Funding for the 2024 Pre-Qualified Public Art Roster projects will come from a variety of sources, including Measure WW, Measure KK, Measure DD and contributions to the Public Art Program Fund.

RECOMMENDATIONS

Staff recommends that the Public Art Advisory Committee (PAAC) accept the selection panel's recommendation of 260 selected artists (Attachment C). to be included in the pre-qualified artist roster of eligible candidates for upcoming Capital Improvement and City funded public art commissions to be initiated in 2024-2025.

BACKGROUND

The City of Oakland's Public Art Program, established in 1989, commissions original works of art for public spaces throughout Oakland. The program enriches the city's visual environment, integrates the creativity of artists into public construction projects, and provides a means for residents and visitors to enjoy and experience the richness and diversity of Oakland culture. Our program is guided by the principles uplifted in <u>Belonging in Oakland</u>, the City's Cultural Development Plan that aims to promote cultural equity, belonging, and well-being for all communities of Oakland.

OPPORTUNITY

Artists selected for the prequalified artist roster will be used by Public Art Program staff to recommend appropriate applicants for a range of city-funded improvement projects. Improvement projects include but are not limited to various streetscape projects and city facilities including parks, libraries, fire stations, and recreation facilities. Emerging and established artists working and living in Oakland who reflect Oakland's diverse artistic community in regard to race, age, class, and gender are strongly encouraged to apply.

Artists working and living in Oakland and in the Bay Area are strongly encouraged to apply.

Artists who apply as part of a team may also apply as an individual artist, in a separate application.

A selection panel of artists/arts professionals, City staff, and representatives from the Oakland Public Art Advisory Committee will review the applications and recommend applicants for the Public Art Prequalified Artist Roster. PUBLIC ART PROGRAM POLICIES

Acceptance of Proposals

The City of Oakland Cultural Affairs Division reserves the right to reject all applications and/or subsequent design proposals or to augment the roster of applicants by direct invitation as needed.

Proposal Policy

If an artist or artist team is paid to develop a digital or physical proposal maquette, or other conceptual design materials for a proposal, the following policy shall apply. The Cultural Affairs Division shall:

- At its sole discretion, have unconditional rights to own digital or physical proposal boards or maquettes, or other design materials produced as a part of this selection and/or commission process.
- Have the right to display and/or reproduce any maquettes or proposal commissioned, whether selected for implementation or not.
- Require that all concepts, proposals and/or maquettes submitted are original and unique.

Americans with Disabilities Act

The selected artist(s) will be required to comply with the Americans with Disabilities Act in addition to related federal, state and local codes and will be encouraged to develop artwork(s) sensitive to programmatic as well as physical accessibility issues.

Other Requirements

Any selected artists or artist teams, once recommended for a project and approved by the City, shall be asked to enter a contract with the City of Oakland for the duration of the project. All proposed locations and concepts for artworks are subject to approval by the City and/or other representatives. Depending on the specific scope of the project, prior to the issuance and throughout the duration of the contract, the artist may be required to secure and maintain various types of insurance, including Automobile Liability, General Liability, Fine Arts and other insurance as required by the City.

All information contained herein does not constitute either an expressed or implied contract and these provisions are subject to change.
