- City Adopted Protocol for Process Integrity

 - Establishes transparent system for communication
 - Sets a code of conduct for participants
- Staff and Consultants have completed:
 - Confidentiality Agreement
 - Conflict of Interest Form

 - Appointed Process Coordinator



Service Group 1 Mixed Materials & Organics

- Exclusive Mixed Materials & Organics Collection Services - Contract Term: a 10 year contract with options to extend the contract for up to 2 additional five year periods
- Weekly Mixed Materials collection and processing or transfer for SFD, MFD, City and Commercial customers
- Annual Bulky Goods collection for SFD and MFD
- Temporary Roll-off Box Collection & Processing

Service Group 1 Mixed Materials & Organics

- Community Outreach Services public information
- On-call Sharps and HHW Collection
- Billing Services
- Customer Service Office and Call Center
- Transfer to Designated Disposal Site
- Waste Diversion Requirements



Service Group 2 Residential Recycling

- Exclusive Residential Recyclables Collection
 Services Contract Term: a 10 year contract with options to extend the contract for up to 2 additional five year periods
- Weekly single stream recyclables collection and processing for SFD, MFD, and City
 - Includes used oil and oil filter, and household battery collection
- Tons collected and tons diverted requirements
- Customer Service Office



Commercial Non- Exclusive Single Stream Recyclable Materials Collection And Processing

- Proposers for both Service Groups must propose for this service
- City will require either the Service Group 1
 Contractor or the Service Group 2 Contractor to provide this service
