BACKGROUND


Project Scope

The goal of this project is to improve undercrossings for people walking, biking, and rolling.

Undercrossing Improvements will include:

- **Lighting** will help make people feel safer and could be colorful or fun to look at.
- **Wayfinding** will help people know where they are and see where they want to go.
- **Placemaking** makes the space feel safe, welcoming, and reflective of the surrounding community.




Project Locations

Engagement Methods



Previous engagement from Fall-Winter 2024 indicated community concerns around lighting, wayfinding, traffic safety, personal safety, cleanliness, community identity, and support for unhoused people. For more info on past engagement activities, visit OaklandCA.gov/Undercrossings.

From **May 1 through June 30, 2025**, the Undercrossing Improvements team engaged with community members in two ways:

Online survey: Over 700 people responded to a survey questions distributed online, in person, and through word-of-mouth in the project area.

In-person and virtual meetings: The project team presented project updates and survey questions at meetings with 13 organizations or commissions that were previously engaged.








For option A, tiles can be arranged to create images of people from Oakland. **Would you like to see mosaic tile portraits at this location?**

The top 3 choices were **Jack London Square**, **West Oakland BART station**, and **12th Street BART station**.
















Which kind of wayfinding design do you prefer?

QUALITATIVE FEEDBACK

This section summarizes open-ended comments from the survey as well as comments received from attendees of meetings and presentations. Because the project lies within Caltrans right-of-way, some suggestions may not be permitted. The UXI project team will work to confirm improvements that meet Caltrans guidelines.

All or multiple locations (54 comments)

- Add brighter, more vividly colorful lighting (pedestrian-scale and/or additional lighting)
- Design lighting fixtures to prevent vandalism or theft of copper wires

Broadway under I-880 (33 comments)

- Strong support for more lighting to improve pedestrian safety
- Design for durability, ease of maintenance, and resistance to (or compatibility with) graffiti.
- Include designs or patterns, such as an Asian motif (e.g. lanterns), or filters that can be changed in the future.
- Light the underside of the freeway in addition to the columns and walkways.

Martin Luther King Jr. Way under I-880 (15 comments)

- Add interesting fixtures or light sculptures on the undercrossing columns and ceiling

Broadway under I-880 (29 comments)

- Use both icons and names in wayfinding signage
- Include names of destinations in multiple languages, especially Spanish, Chinese, Vietnamese
- Ensure that icons are recognizable

Martin Luther King Jr. Way under I-880 (9 comments)

- Include other destinations such as the Ferry Terminal and Water Shuttle
- Include community services such as health clinics or soup kitchens

7th Street under I-980 (12 comments)

- Include wayfinding, such as “West Oakland” and other neighborhood names, on the columns or ceiling
- Include distances on wayfinding
- Make wayfinding legible to people moving quickly (in vehicles or on bicycles)

All or multiple locations (7 comments)

- Add more decorations and colors
- Include noise reduction or abatement

Broadway under I-880 (92 comments)

- Use a different shape of bollard, such as large spheres, railings, circular bike racks, etc.
- Use fewer bollards to be less distracting and less costly
- Remove existing guardrail art installation
- Light or paint the underside of the freeway in addition to columns and walkways
- Include Chinatown or Asian American history as themes
- Use a plain or less messy design for the pattern on the fence
- Make sure that there's consistency between the designs for fencing, lighting, and bollards

Washington Street under I-880 (31 comments)

- Include more patterned lighting, designs, or art
- Use art patterns that reflect the history and culture of Jack London and Old Oakland

Martin Luther King Jr. Way under I-880 (32 comments)


- Put column designs in brighter colors or at a more visible height
- Include artwork of notable figures, such as Huey Newton and members of the Black Panther Party, in tiled portraits on the columns

7th Street under I-980 (52 comments)

- For the black jazz theme – the music notes should reflect actual music
- The designs should acknowledge history, such as freeway impacts, blues and jazz history, local figures, and local organizations (such as The Crucible and Mandela Co-op)
- Consider plants, a “green wall”, or other landscaping

All or multiple locations (14 comments)

- Include regular cleaning as a part of the scope of improvements
- Ensure that lighting, artwork, and designs are cleaned and maintained
- Design for durability, ease of maintenance, and resistance to graffiti
- Work with groups such as the City of Oakland's Adopt-a-Spot program, Jack London Improvement District, Oakland Chinatown Improvement Council, to maintain the undercrossings after construction is complete



Broadway under I-880 (35 comments)

- Clear trash and clean sidewalks more often
- Add trash receptacles at every corner

Washington Street under I-880 (13 comments)


- Consider more durable options for the posts in the painted curb extensions
- Regularly refresh the painted patterns in the curb extensions since they will fade over time

Martin Luther Jr. Way under I-880 (22 comments)

- Ensure that the designs on the columns are cleaned and maintained. Consider graffiti-resistant coatings

7th Street under I-980 (12 comments)

- Perform regular cleaning and maintenance
- Design for durability and easy cleaning

Traffic safety, pedestrian safety, and bike lanes (164 comments)

Comments were centered around desires for improved pedestrian and bicycle infrastructure at the 4 undercrossings, particularly infrastructure to facilitate safe crossings at intersections.

New bike and pedestrian safety improvements will be delivered at the Martin Luther King Jr. Way, 7th Street, and Broadway undercrossings through these projects:

Encampments (56 comments)

- Presence of encampments at undercrossings, particularly Broadway under I-880
- Preference for or against hostile infrastructure to deter encampments.

INCORPORATING FEEDBACK INTO PROJECT DESIGNS

Design Direction for All Four Undercrossings

The project team incorporated community feedback into the designs of the four undercrossings. The project designs follow the principles outlined in the slides in this section.

Lighting

- Add brighter, more colorful lighting

Wayfinding

- Make sure wayfinding is legible

Placemaking

- Incorporate ways to add more color at the undercrossings

Maintenance

- Design for durability, ease of maintenance, cleaning, and resistance to (or compatibility with) graffiti.

Not all community-preferred design elements may be approved by Caltrans and final designs may be substantially different or reduced compared to images and descriptions in this presentation.

7th Street under I-980

- Explore adding a painted design on the sidewalk near the freeway columns
- Explore using paint or stain on the columns that is resistant to weathering
- The design team is adding street trees and ground plantings on 7th Street outside of Caltrans right-of-way

MLK Jr. Way under I-880

- The project team is not pursuing tile portraits on the columns. There was no clear consensus from community engagement feedback on who to represent in the portraits.
- Use brighter colors for column designs (i.e. explore using a different color)
- Explore whether there are other treatments that can be added to the fence to obscure the vehicles and trucks parked in the lot behind the fence
- Add the ferry terminal to wayfinding signage

Design Direction for Broadway and Washington St Undercrossings


- Project lighting will be designed to be as colorful and expansive as possible without being distracting.
- The project team will work with Oakland Cultural Affairs and the Public Art Advisory Committee (PAAC) to explore the removal of the existing public art (the guardrail art installation).
- Wayfinding should include both recognizable icons and names in multiple languages.
- Explore ways other than bollards to include visual cues for separation and safety from moving vehicles. Bollards invite challenges for maintenance and cleaning, as well as some pedestrian navigation, and they do not provide a crash rated barrier.

Washington Street under I-880

- Pursue inclusion of patterns that better represent Jack London and Old Oakland that aren't prone to fading over time.
- Bring curb ramps into Americans with Disabilities Act guideline (ADA) compliance

NEXT STEPS



The project team is working with the consultant teams to incorporate feedback from community engagement and will further develop the designs for the four undercrossings.

The next set of designs will be more detailed and will be available by the end of 2025. These designs will be submitted to Caltrans for their review and approval of encroachment permits.

Not all community-preferred design elements may be approved by Caltrans and final designs may be substantially different or reduced compared to images and descriptions in this presentation.
